WHEREAS, the Town government of Vienna is interested in cooperating with the government of Fairfax County in regional planning and in any other way that is beneficial to the citizens of Vienna, and

WHEREAS, although Virginia law does not provide for a referendum before a town becomes a city, the Vienna Town Council believes that the desires of the citizens of Vienna should be obtained before Vienna's form of government is changed.

NOW, THEREFORE, BE IT RESOLVED. that the Vienna Town Council here-

by agrees as follows:

(1) Action to change the governmental status of Vienna or Fairfax County before adjournment of the 1964 General Assembly of Virginia would not be in the best interests of the citizens of Vienna, and

(2) The citizens of Vienna should be given an opportunity to determine which form of government Vienna should have before any

governmental status, and

(3) If because of some event not now known to the Council, Vienna should be forced to become a city in order to save its charter and sufficient time is not available to properly determine the desires of the citizens of Vienna before having to take such action, the matter will be submitted to the citizens as soon as practicable after taking such action to determine whether they agree or disagree with the action taken by the

The initial cost of water to Vienna under the contract is 25¢ per thousand gallons compared to 32¢ per thousand for the limited amount now purchased from Falls Church. The price will go down as the amount of water used increases until, at two million less than 15¢ a thousand gallons.

> The water contract was signed after many months of negotiation by the Town Council and the Town staff and follows the recommendations of Engineers, who made an extensive study of the Town's water and sewer systems. A l million gallon water tank is to be constructed on Wall Street beyond the northeast Town limits. The site selection followed recommendations of Michael Baker Jr.

Negotiations are underway for connection of the Town's sewer system to the proposed Difficult Run Spur of the Dulles Airport Potomac River Interceptor which will carry sewage to the District of Columbia plant south of Washington, and the proposed upper Accotink Sewer System of Fairfax County. Under the plan the south half of Vienna will The Town has signed an agreement drain into the Accotink system and

Interceptor. In time, these sewer connections will replace our present sewage treatment plants. It is estimated, however, that it will be between 18 months to three years before either line is completed.

#### WIDENING OF MAPLE AVENUE AND NUTLEY ROAD

The Town has now received the necessary additional right of way on Maple Avenue and Park Street to carry out the widening of Maple Avenue from Park to Glyndon Street. This widening is now underway.

The State Highway Department has a proposed project which will widen Route 123 from Tyson's Corner to a point just northeast of St. Andrew's TOWN CODE Street. Mayor Wilson recently met with State Highway officials in Richmond and subsequently the Town received a communication stating they now looked very favorably towards making permanent widening improvements on Maple Avenue from Park Street to the Town limits when the Tyson's Corner improvements nance alone is \$10. Other individare made.

Nutley Road will be 4-laned with a divided center-strip and sidewalks on both sides and will be the Town's access to Route 66. The Town will acquire the land needed for the right of way and will be reimbursed 25 percent by the State and 50 percent by the Federal Government. These improvements are scheduled for completion in the Fall of 1963.

#### NEW PUBLIC LIBRARY

The new Patrick Henry branch of the Public Library is now open to the citizens of Vienna. It is located at 325 Maple Avenue East in the new shopping center. Hours of operation are: Monday, Wednesday, and Friday 10:00 a.m. to 9:00 p.m., Tuesday and Thursday, 10:00 a.m. to 6:00 p.m., and Saturday 9:00 a.m. to 5:00 p.m.

In approving the Use Permit for the library, the Town Council directed that the permit fee be donated to the County Library Fund. The Library in Vienna was made possible by the Friends of the Library, who raised \$7500 toward the cost of the facility.

#### SCHOOL SIDEWALKS

Sidewalks leading to Marshall Road and Louise Archer Elementary Schools were recently completed.

#### NEW TOWN ATTORNEY
