# This Month in History

from the Vienna Newsletter archives

JULY 1999 - The Town Council has adopted an ordinance, which becomes effective July 1, in response to citizen complaints about aggressive driving in Vienna's residential neighborhoods. It allows for a civil penalty of \$100 to any motorist convicted of exceeding the speed limit by 20 mph or more on residential streets.

JULY 1989 – At its July 3 meeting, the Town Council will hold a joint public hearing with the Planning Commission on proposed ordinances concerning planting and replacement of trees during property development. They would require developers to submit a plan that within 10 years would provide a tree canopy exceeding five feet in height over at least 20% of the property in residential zones and 10% in non-residential zones.

JULY 1979 – An arrangement is being worked out between the Vienna Planning Office and Showcase Theatres of Bethesda, MD, to make the Vienna Theatre parking lot available for Metrobus riders and carpoolers. Permits would be issued for a monthly fee of \$25, with all revenues going to the operation and maintenance of the parking lot. WMATA has confirmed that the bus will stop in front of the lot to pick up riders in the morning.

JULY 1969 - The Town Council passed a resolution to purchase a large portable pool for use at the Community Center this summer. However, the County Health Department ruled that this did not fulfill County regulations for commercial pools. The Town Council regretfully had to abandon consideration of the portable pool.

# **Beware of Phone & Internet Scams**

- \$ Lower Your Interest Rate on Credit Cards Scam A person calls and offers to lower the interest rates on your credit cards. You provide personal information, including credit card numbers. That information is then used to make fraudulent purchases or steal your identity. DO NOT give out personal information unless YOU initiate the contact with the financial institution.
- **\$ Vehicle Warranty Scam** A call comes in from an individual stating that your vehicle warranty is running out or has run out. He asks you to send information and money to extend your warranty. When you do, the individual becomes unreachable, or if you make installment payments and try to file a claim, you find out the company no longer exists or never did exist.
- \$ Internet Scams Phishing and fictitious e-mails are a huge problem. In one of the most common scams, you are informed that you have an invalid account or your account is in need of updating. So you enter your information and now the criminal has it. NEVER, EVER give out your log-in ID, password, credit card number, PIN, or bank information to anyone unless YOU initiated the contact. If in doubt, don't do anything and call or visit your bank or financial institution.
- **\$ Wireless/Internet Fraud –** If you have an unsecured wireless router or network set up in your home, anyone with a laptop computer can gain access from the street, driveway, sidewalk, or anywhere else in the vicinity where there is a signal. Always password protect your network.
- **\$ Lottery Winner Scam** An e-mail arrives notifying you that you have won a large sum of money. All you have to do is pay the taxes on the winnings. You are asked to mail a check for that amount. Once you do, your money is gone as there are no winnings to retrieve.

# Go Green, Vienna!

In these difficult economic times, wouldn't it be nice to save money and help the environment? To have experiences instead of stuff? To focus on renewing, reusing, recycling and sustainability?

Vienna's Green Expo, held at the Community Center in April, was a start. Nearly three dozen exhibitors and hundreds of attendees enjoyed a very educational evening. Attendees learned about ways to save on heating and cooling in their homes, how to judge the energy use of new appliances, and how to use rain barrels, composting and rain gardens to save money on water and fertilizer. They got free compact fluorescent light bulbs from the Sierra Club, fluorescent night lights from Dominion Power, and bike trail maps from Fairfax Advocates for Better Bicycling. They munched on snacks donated by Whole Foods. And much, much more.

Vienna resident and Sierra Club member Susan Stillman demonstrated how "vampire power" increases your electric bill. "Anything that stays warm or has a light or a display is still using electricity even though you think it's turned off," Stillman said. She suggested unplugging or placing on power strips re-chargers and appliances that draw power when not in use, such as computers. The Sierra Club also presented a talk on "The Lazy Cheapskate's Guide to Going Green" and showed how a "Kill-A-Watt" device can display your electricity usage.

The James Madison High School Environmental Club, along with an organization called Tapwater Now, conducted blind taste tests of tap water vs. bottled water. As in the old Pepsi challenge, participants sipped from unlabeled cups and tried to determine which water was which. They were unable to tell the difference at least 90% of the time.

The Vienna Optimists touted the Farmers' Market, held every Saturday morning near the caboose. Local farmers using old-style farming methods do not contribute to the environmental waste created by industrialized food production. And the food tastes better, too.

Several exhibits showcased green building. These included Commonwealth Home Remodelers, Sagatov Associates, Custom Floors by Mohawk, Capital Sun Group Solar Energy Systems and Encompass Green Remodeling. The US Green Building Council for Leadership in Energy and Environmental Design (LEED) told attendees about LEED designation for homes and sustainable remodeling practices. Susan Pierce of Commonwealth spoke about "Harvesting the Dollar Advantages of Green Remodeling."

Bicycling was prominent at the Expo; both bikes@vienna and Spokes, Inc. had booths. John Brunow of bikes@vienna feels the Green Expo helped him reinforce his company's marketing message. He said the Green Expo is, "the perfect event giving information to residents and giving businesses the opportunity to tell their story."

What if you missed the Green Expo? There will be another in spring 2010, but there is much you can do in the meantime, such as using the Town's new single-stream recycling program, which allows many more items to be recycled. Details are online – go to the Department of Public Works area of www.viennava.gov and click on "Recycling" on the left.

# **MESSAGE FROM THE TOWN MANAGER**

This is the Town of Vienna's eleventh annual report to inform you about your drinking water quality. As a part of the Safe Drinking Water Act of 1996, the U.S. Environmental Protection Agency (EPA) requires all water utilities across the nation to mail their customers a Water Quality Report by July 1, 2009. Our goal is to provide you with a safe and dependable supply of drinking water, and we want you to understand our efforts to protect your water supply.

The quality of your drinking water must meet state and federal requirements administered by the Virginia Department of Health. We constantly monitor for various contaminants in the water supply to meet all regulatory requirements. The tables in this report list only those contaminants that had some level of detection. Many other contaminants have been analyzed but were either not present or were below the detection limits of the laboratory equipment. All of our water quality data are from testing done in 2008. However, the Commonwealth allows us to monitor for some contaminants less than once a year because the concentration of these contaminants does not change frequently. Even though some of our data may be more than one year old, they are accurate.

Is your water safe to drink? Absolutely! The Town of Vienna water system had only one minor violation during the year. We're proud to share our water quality test results with you. Also, a "source water assessment" of our system has been conducted by the Virginia Department of Health. Wells #1 & #9 were determined to be of high susceptibility to contamination using the criteria developed by the state in its approved Source Water Assessment Program. This report consists of maps showing the assessment area, land use activities, and records of any contamination within the last five years. Decisions concerning Vienna's water are made by the Town Council. Regular meetings are normally held the first and third Mondays of the month (except July and August) at 8 p.m. in the Council Chamber at Town Hall.

# **GENERAL INFORMATION**

As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and can pick up substances resulting from the presence of animals or from human activity. Substances (referred to as contaminants) in source water may come from septic systems, discharges from domestic or industrial wastewater treatment facilities, agricultural and farming activities, urban storm water runoff, residential uses, and many other types of activities. Water from surface sources is treated to make it drinkable while groundwater may or may not have any treatment.

All drinking water, including bottled drinking water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information can be obtained by calling the Environmental Protection Agency's (EPA) Safe Drinking Water Hotline at 1-800-426-4791.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. Environmental Protection Agency/Center for Disease Control guidelines on appropriate means to lessen the risk of infection by cryptosporidium and other microbiological contaminants are available from the Safe Drinking Water Hotline.

# WATER SOURCES

For the calendar year 2008, the Town of Vienna was supplied with treated surface water from the Potomac River by the Fairfax County Water Authority (FCWA) and the City of Falls Church. The Town purchases treated water from the Washington Aqueduct supplied by Falls Church. The final source is groundwater from two wells in the Town of Vienna. Well water is blended in the Town's delivery system and comprises approximately 1% of our total usage.

# HOW DO I READ THIS CHART?

Our water is tested to assure that it is safe and healthy. Contaminants in the drinking water are routinely monitored according to Federal and State regulations. The table contained in this report shows the most recent results of our monitoring. Typical sources of contamination show where this substance usually originates. The following definitions are provided to help you better understand terms and abbreviations.

- The FCWA sampling program includes cryptosporidium. Their results and information are included.
- Non-detects (ND) laboratory analysis indicates that the contaminant is not present.
- Parts per million (ppm) one part per million corresponds to one minute in two years or a single penny in \$10,000.
- Parts per billion (ppb) one part per billion corresponds to one minute in 2,000 years or a single penny in \$10,000,000.
- Parts per trillion (ppt) one part per trillion corresponds to one minute in 2,000,000 years or a single penny in \$10,000,000,000.
- Picocuries per liter (pCi/L) picocuries per liter is a measure of the radioactivity in water.
- Nephelometric Turbidity Unit (NTU) nephelometric turbidity unit is a measure of the clarity, or cloudiness, of water.
   Turbidity in excess of 5 NTU is just noticeable to the average person. Turbidity is monitored because it is a good indicator of the effectiveness of the filtration system.
- Action Level (AL) the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a
  water system must follow.
- Treatment Technique (TT) a required process intended to reduce the level of a contaminant in drinking water.
- Maximum Contaminant Level (MCL) the highest level of a contaminant that is allowed in drinking water. MCLs are set at
  very stringent levels by the U.S. Environmental Protection Agency. In developing the standards EPA assumes that the average
  adult drinks two liters of water each day throughout a 70-year life span. EPA generally sets MCLs at levels that will result in
  no adverse health effects for some contaminants or a one-in-ten-thousand to one-in-one million chance of having the
  described health effect for other contaminants.
- Maximum Contaminant Level Goal (MCLG) the level of a contaminant in drinking water below which there is no known or
  expected risk to health. MCLGs allow for a margin of safety. MCLs are set as close to the MCLGs as feasible using the best
  available treatment technology.
- Maximum Residual Disinfectant Level (MRDL) the maximum level of total chlorine allowable by regulation.

### PERCHLORATE RESEARCH

Perchlorate is a naturally occurring as well as man-made compound. Its presence in drinking water is currently unregulated and utilities are not required to monitor for it. In 2007, the Washington Aqueduct and Fairfax Water began voluntarily participating in a non-regulatory perchlorate sampling project for the Potomac River funded by the EPA, which has established a reference dose of 24.5 ppb for perchlorate. A reference dose is a scientific estimate of a daily exposure level that is not expected to cause adverse health effects in humans, and will be used in EPA's ongoing efforts to address perchlorate in drinking water.

The samples collected in 2008 from our Potomac River water filtration plant sources and treated water have shown amounts of perchlorate at 1.1 ppb or less, far below the EPA reference dose level. # **LEAD IN DRINKING WATER**

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Town of Vienna is responsible for providing high quality drinking water, but cannot control the variety of materials used in private plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 15 to 30 seconds or until it becomes cold or reaches a steady temperature before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. ### **TURBIDITY IN DRINKING WATER**

Turbidity has no health effects. However, turbidity can interfere with disinfection and provide a medium for microbial growth. Turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses, and parasites that can cause symptoms such as nausea, cramps, diarrhea and associated headaches.

### 2008 SOURCE WATER CRYPTOSPORIDIUM INFORMATION

The Town's water suppliers have been monitoring the source waters for compliance with the EPA's Long Term 2 Enhanced Surface Water Treatment Rule (LT2ESWTR). The EPA created this rule to provide for increased protection against microbial pathogens, such as *Cryptosporidium*, in public water systems that use surface water sources.

Even though monitoring has been completed for the LT2ESWTR, the Town's suppliers have continued to test for *Cryptosporidium*, and the data collected in 2008 are summarized in the table below.
