COMMENT FROM THE COUNCIL TABLE

Freeman Store on National Register: How did they do that?

You may know that Historic Vienna, Inc. (HVI) is the group that staffs the Freeman Store and Museum, mounts historic exhibits and brings us events like Civil War movies, the Easter Egg Roll, the used book sale, the Church Street Holiday Stroll and Santa Claus. But did you know that these wonderful volunteers have recently taken on the role of history detectives?

First, a short version of the background: Vienna's Freeman Store and Museum was built in 1879 by Abram and Susan Lydecker as a store, hotel and residence for their family. The building has also been a train depot, hospital, officers' quarters, post office and fire department.

According to an HVI informational pamphlet about the Freeman Store, the building was used by the Federal army during the Civil War. The Lydeckers' son-in-law, Anderson Freeman, helped them rebuild. Anderson's son Leon and his family operated the business for many years. Leon formed the first

Vienna Volunteer Fire Department, was a director of Vienna's first bank and served as Mayor on the Town Council and as a member of the Virginia House of Delegates. It is no wonder that the building is remembered with the name of this very prominent citizen.

The Freeman Store closed for business in 1929, remained a residence through the 1950's, fell into disrepair and was acquired by the Town of Vienna in 1969. A committee of Town residents organized the restoration work, and this group became HVI in 1976.

Now, back to the part about history detectives: According to HVI president Anne Stuntz, the Historic Register process took about three years. Intensive online research was done by HVI board member Sarah Jane Brady as she recovered from an injury. Ultimately, the Town hired a consultant, History Tech, to undertake additional research, prepare the applications and make sure all the details were included in the 33-page document. HVI board member

Maud Robinson said the process was, "extremely complex, tedious and demanding."

Listing on the

Virginia Landmarks Register came first, and was celebrated by HVI and the Town in April. In May, word arrived that the building would be listed on the National Register of Historic Places. These recognitions convey prestige and confirmation of the building's place in history.

Volunteers like those in HVI contribute a great deal to our Vienna community. We wouldn't be the same place without them. If you do not have time to volunteer, you can make a donation by joining HVI. An annual membership is only \$20 and you get a 10% discount on all your Freeman Store purchases.

FIVE REASONS TO LOVE A DEAD TREE

With the development of more and more natural areas in Northern Virginia, our yards and neighborhoods are becoming vital homes for wild animals. If we are to continue to have beautiful songbirds, cute chipmunks, butterflies and other native wild animals in our area we need to open up our yards and invite wildlife in. Learning to appreciate dead trees (or "snags" as they are properly called) is one way to do this.

Here are five reasons to love a dead tree:

1. Many birds and mammals need dead trees for nesting. Snags are used for exterior nesting by birds of prey and brown creepers. Birds that make a nest in the interior of a dead July 2012

- tree are the chickadee, nuthatch and woodpecker. Squirrels also nest in these interior cavities.
- 2. Tree cavities are used by many animals to store their food supplies and for protection from weather.
- 3. Dead wood hosts insects that are a primary food source for many animals.
- 4. Most bat roosts are in dead trees. Bats are a primary source of mosquito control, as they eat thousands of insects each night. Other mammals, amphibians, reptiles and many insect species also seek refuge in natural cavities and dens provided by dead wood.
- Snags eventually decompose and create a rich soil for our trees and plants. Various microbial

species, such as bacteria fungi and mushrooms, flourish on and around logs, breaking down the organic matter to release important nutrients back into the forest soil.

Although dead trees and branches may not look attractive, you can now see their inner beauty and importance for our natural world. In this way, they become more appealing. Our family cut one of our dead trees back to about 20 feet tall and took off most of the branches and we call it our "woodpecker pole." It is fascinating for me and my children to watch its evolution and see the multitude of wildlife that it supports. So the next time a tree or large branch on a tree dies, consider leaving it in your yard as a home for our wild animals.

The Town of Vienna 2012 Annual Water Quality Report

for the Town of Vienna and the surrounding service area

MESSAGE FROM THE TOWN MANAGER

This is the Town of Vienna's fourteenth annual report to inform you about your drinking water quality. As a part of the Safe Drinking Water Act of 1996, the U.S. Environmental Protection Agency (EPA) requires all water utilities across the nation to mail their customers a Water Quality Report by July 1 every year. Our goal is to provide you with a safe and dependable supply of drinking water and we want you to understand our efforts to protect your water supply.

The quality of your drinking water must meet state and federal requirements administered by the Virginia Department of Health and the US Environmental Protection Agency. We constantly monitor the water supply for various contaminants to ensure we meet all regulatory requirements. The tables in this report list only those contaminants that had some level of detection. Many other contaminants have been analyzed but were either not present or were below the detection limits of the laboratory equipment. All of our water quality data is from testing done in 2011; however, the Commonwealth allows us to monitor for some contaminants less than once a year because the concentration of these contaminants does not change frequently. Even though some of our data may be more than one year old, it is accurate.

On page two of this report, we have provided detailed information regarding an omission in our sampling requirements for the year 2010. To determine sampling locations with high disinfection byproducts (DBP) levels, our system was required to conduct a system evaluation to characterize disinfection byproducts and identify the monitoring locations. We were required to complete six sampling campaigns at multiple locations from December 2009 through October 2010; however, we did not complete this sampling and as a result we did not complete the system evaluation and identify the monitoring locations. We are in the process of completing the system evaluation and based off of this year's first quarter sampling, we are well below the maximum contaminant levels.

OPPORTUNITIES FOR PUBLIC PARTICIPATION

Decisions concerning Vienna's water are made by the Town Council. Regular meetings are normally held the first and third Mondays of the month (except July and August) at 8 p.m. in the Council Chamber at Town Hall.

GENERAL INFORMATION

As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and can pick up substances resulting from the presence of animals or from human activity. Substances (referred to as contaminants) in source water may come from septic systems, discharges from domestic or industrial wastewater treatment facilities, agricultural and farming activities, urban storm water runoff, residential uses and many other types of activities. Water from surface sources is treated to make it drinkable while groundwater may or may not have any treatment. All drinking water, including bottled drinking water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water possesses a health risk. More information can be obtained by calling the Environmental Protection Agency's (EPA) Safe Drinking Water Hotline at 1-800-426-4791, TTY711.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immunocompromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly and infants, can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. Environmental Protection Agency/Center for Disease Control guidelines on appropriate means to lessen the risk of infection by cryptosporidium and other microbiological contaminants are available from the Safe Drinking Water Hotline.

NOTICE TO CUSTOMERS

In keeping with National Primary Drinking Water Regulations, we are obliged to inform you that we may be in violation of state and federal regulations. The US Environmental Protection Agency (EPA) has been proactive in regulating drinking water contaminants and protecting public health. Disinfectants such as chlorine used during water treatment react with natural organic matter (coming from decaying vegetation), and form disinfection byproducts (DBPs). The formation of DBPs continues in the distribution system, therefore DBP levels increase as water travels in the distribution system. At elevated concentrations, some disinfection byproducts can increase the risk of cancer.

As part of the disinfectants/disinfection byproducts rule (D/DBP), water utilities are required to monitor DBP levels at various locations in the distribution system, and ensure that they remain below certain limits. For the Town of Vienna water system, during 2011, disinfection byproduct levels averaged 28ppb and 13ppb for the two major groups of regulated DBPs named Total Tri-Halomethanes (TTHM) and Haloacetic Acids (HAA5). For these two groups of byproducts, the maximum contaminant levels (MCL) are set at 80ppb and 60ppb for TTHMs and HAA5, respectively. Starting in 2012, the D/DBP rule will become more stringent (Stage 2). DBP samples will be required to be collected at locations where water retention times and DBP levels are likely to be high.

To determine sampling locations with high DBP levels, our system was required to conduct a system evaluation to characterize disinfection byproducts and identify the monitoring locations. We were required to complete six sampling campaigns at multiple locations from December 2009 through October 2010; however, we did not complete this sampling and as a result we did not complete the system evaluation and identify the monitoring locations. We will complete the system evaluation, July 2012

including the required sampling campaigns, during 2012, select the monitoring locations and start Stage 2 compliance monitoring in 2013.

THERE IS NOTHING YOU NEED TO DO AT THIS TIME.

We are attempting to prevent further violations by ensuring that all required sampling in our distribution system is done in accordance with the state drinking water regulations. Future violations will be reported as required by state regulations in order to increase consumers' awareness of conditions that exist in their public water system. WATER SOURCES

For the calendar year 2011, the Town of Vienna was supplied with treated surface water from the Potomac River by the City of Falls Church. The Town purchases treated water from the Washington Aqueduct supplied by Falls Church.

HOW DO I READ THIS CHART?

Our water is tested to assure that it is safe and healthy. Contaminants in the drinking water are routinely monitored according to Federal and State regulations. The table contained in this report shows the most recent results of our monitoring. Typical sources of contamination show where this substance usually originates. The following definitions are provided to help you better understand terms and abbreviations.

- The Washington Aqueduct sampling program includes *Cryptosporidium*. Their results and information are included.
- Non-detects (ND) laboratory analysis indicates that the contaminant is not present.
- Parts per million (ppm) one part per million corresponds to one minute in two years or a single penny in \$10,000.
- Parts per billion (ppb) one part per billion corresponds to one minute in 2,000 years or a single penny in \$10,000,000.
- Parts per trillion (ppt) one part per trillion corresponds to one minute in 2,000,000 years or a single penny in \$10,000,000,000.
- Picocuries per liter (pCi/L) picocuries per liter is a measure of the radioactivity in water.
- Nephelometric Turbidity Unit (NTU) nephelometric turbidity unit is a measure of the clarity, or cloudiness, of water. Turbidity in excess of 5 NTU is just noticeable to the average person. Turbidity is monitored because it is a good indicator of the effectiveness of the filtration system.
- Action Level (AL) the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- Treatment Technique (TT) a required process intended to reduce the level of a contaminant in drinking water.
- Maximum Contaminant Level (MCL) The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology. In developing the standards, EPA assumes that the average adult drinks two liters of water each day throughout a 70-year life span. EPA generally sets MCLs at levels that will result in no adverse health effects for some contaminants or a one-in-ten-thousand to one-in-one million chance of having the described health effect for other contaminants.
- Maximum Contaminant Level Goal (MCLG) The level of a contaminant in drinking water below which there is not known or expected risk to health. MCLGs allow for a margin of safety.

- Maximum Residual Disinfectant Level (MRDL) The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- Maximum Residual Disinfectant Level Goal (MRDLG) The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

PERCHLORATE RESEARCH

Perchlorate is a naturally occurring as well as man-made compound. Its presence in drinking water is currently unregulated and utilities are not required to monitor for it. The Washington Aqueduct has been voluntarily monitoring for perchlorate since 2002. The EPA initially established a reference dose of 24.5 parts per billion (ppb) for perchlorate and beginning in 2009 has proposed an interim health advisory of 15 ppb. A reference dose is a scientific estimate of a daily exposure level that is not expected to cause adverse health effects in humans. The reference dose concentration was used in EPA's efforts to address perchlorate in drinking water and to establish the interim health advisory. In 2011, finished water sample results for perchlorate collected by Washington Aqueduct at both treatment plants ranged between none detected and 3.7 ppb. If you have special health concerns, you may want to get additional information from the EPA at www.epa.gov/safewater/contaminants/unregulated/perchlorate.html or by calling the EPA's Safe Drinking Water Hotline at 1-800-426-4791, TTY711.

LEAD IN DRINKING WATER

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Town of Vienna is responsible for providing high quality drinking water, but cannot control the variety of materials used in private plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 15 to 30 seconds or until it becomes cold or reaches a steady temperature before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Information on lead in drinking water, testing methods and steps you can take to minimize exposure is available at www.epa.gov/safewater/lead or by calling the Safe Drinking Water Hotline at 1-800-426-4791, TTY 711.

TURBIDITY IN DRINKING WATER

Turbidity has no health effects; however, turbidity can interfere with disinfection and provide a medium for microbial growth. Turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses and parasites that can cause symptoms such as nausea, cramps, diarrhea and associated headaches.

2011 SOURCE WATER CRYPTOSPORIDIUM INFORMATION

The Town's water supplier has been monitoring the source waters for compliance with the EPA's Long Term 2 Enhanced Surface Water Treatment Rule (LT2ESWTR). The EPA created this rule to provide for increased protection against microbial pathogens, such as *Cryptosporidium*, in public water systems that use surface water sources. *Cryptosporidium* was monitored in the source water monthly in 2011 but was not detected in any sample. The only detection of *Cryptosporidium* that has occurred since the initiation of source water monitoring was in October 2005.

THIS MONTH IN HISTORY

From the Vienna Newsletter Archives

July 2002: The results of the Transportation Safety Commission's (TSC) survey on speed humps indicates that the consensus is that speed humps are effective in controlling speed. The TSC is studying many different ways to calm the traffic in and through Vienna. The Virginia Department of Transportation has developed criteria for the use of speed humps and other calming devices. The TSC uses these criteria to determine if a device is appropriate for a specific street.

July 1992: The Vienna Police Department has initiated a voluntary "Emergency Notification List" service for town residents. The list will facilitate notification of participants' next-of-kin or other party in case of an emergency situation and should be especially helpful to those living alone.

July 1982: The Vienna (Host) Lions Club is celebrating its 40th anniversary this year. The club was chartered in 1942, and three of its original 18 members are still active in Lionism: Rev. Horace Lukens and Howard Rickert with the host club, and Norman Cobb with Vienna's Ayrhill Lions Club.

July 1972: Vienna has a new tradition! Vienna's first big 4th of July celebration was such a success that Bicentennial Chairman Paul Lyons promised that it will continue, at least for the next three years.

TRAIN STATION OPEN HOUSE

The Northern Virginia Model Railroaders will host an open house in the train station on Sat., July 14, from 1 to 5 pm. Admission is free; donations accepted. The station features a fully operational model railroad.

LANDLORD APPROVAL REQUIRED FOR NEW WATER/ SEWER SERVICE

Effective July 1, 2012, a State law change goes into effect that requires landlord approval in advance for a tenant to receive water and sewer service. The law change also requires tenants to pay a larger deposit to protect landlords.
