TOWN OFFICES CLOSED FOR PRESIDENTS' DAY

Town offices will be closed on Monday, February 18, in observance of Presidents' Day.

Refuse will be collected as normal.

The Vienna Community Center will be open from 10 am to 3 pm; no classes or drop-ins will be held.

TOWN HALL RENOVATIONS UNDERWAY

Renovations on Town Hall's 40 year old HVAC system began mid-January and will continue through the end of October 2013. In addition to a new HVAC system, the renovations include new windows, lighting, flooring and ceilings, in addition to upgrading the building's security system. In an effort to improve efficiency, many of the upgrades include energy saving components including low energy lighting, triple pane windows and integral blinds.

While work is being performed, Town Hall will continue to observe normal operating hours, Monday through Friday, 8 am to 4:30 pm. All services currently available at Town Hall will continue to be provided throughout the duration of the project.

Visitors are asked to be patient throughout the duration of the work as offices will be temporarily relocated while work is being performed in other parts of the building. In addition, meetings normally held in the Council Chambers have been moved during the month of February while the Chambers is being renovated.

LAST CHANCE TO ORDER LEAF MULCH

Thursday, February 28, is the last day to order a free delivery of ground leaf mulch from the Public Works Department. To place your order, call (703) 255-6388 and leave your name, address, daytime phone number and the number of loads to be delivered. One load is estimated to be 2.5 cubic yards (equivalent to 33-34 store bought bags.) Half loads are also available. Orders may also be placed online at <u>www.viennava.gov/index.</u> aspx?NID=164. Please note the following important conditions:

- All mulch deliveries are based on availability of mulch.
- Mulch deliveries will be placed only in the driveway at the end closest to the house.
- Once mulch is delivered, it becomes the property of the homeowner and the Town will not remove any excess mulch ordered.

Residents may pick up mulch themselves in any amount between the hours of 9:30 am and 3:30 pm, Monday through Friday (except holidays) through March 30. The mulch is stored on Town-owned property off Beulah Road near Glyndon Park. Look for the sign, "Free Leaf Mulch."

ANNUAL FINANCIAL REPORT AVAILABLE

The Town of Vienna's Comprehensive Annual Financial Report for fiscal year ending June 30, 2012, is now available for review online at www.viennava.gov/Archive.aspx?AMID=39. It is also available for review in the Finance Department at Town Hall or can be purchased for \$5 per copy.

The report summarizes the Town's financial position and results of operations of the various funds and account groups. It also includes the Auditor's Report on FYE 2012, information on internal controls for managing and safeguarding Town assets, and selected financial and demographic information from the last ten years.

According to the report, the Town ended last fiscal year in stable financial condition. General and Debt Service funds had combined revenues of \$22,675,656, an increase of \$1,388,218, or 6.5 percent, over the previous fiscal year. The main drivers of this increase were meals taxes which rose \$235,970 or 13 percent, other local taxes which rose \$208,873 or 3.6 percent and property taxes which rose \$384,891 or 4.5 percent. The increase in other local taxes was mainly due to increases in business license taxes. The meals taxes increase was mainly due to a number of new restaurants and general increased business.

Total expenditures of the General and Debt Service funds increased by \$640,587 or 2.8 percent from last year. The increase was due to a salary increase for personnel, increased equipment purchases in the General Fund and web site development costs.

Last year's Water and Sewer operating revenues were down by \$6,066 or 0.1 percent, to end the year at \$6,065,317, primarily due to a 3.8 percent decrease in the water rate. Operating expenses ended the year at \$6,223,267, up \$687,333 or 12.4 percent due to unexpected increases in the sewer treatment rate and increased depreciation expense over FY 2011.

General obligation debt of \$1,636,667 from issues dated 1998, 1999, 2002, 2006 and 2010 was retired during the year, bringing the total outstanding general obligation debt to \$10,543,335 at year end. This balance represented 0.3 percent of the fiscal 2012 assessed property values, well below the constitutional limit of ten percent and well within the Town's debt retirement capacity.

The Town's cash reserves were invested in U.S. Government Securities and interest-bearing deposit and cash accounts during the year. At year-end, \$23,754,915 or 92.5 percent was invested in the State's Local Government Investment Pool (LGIP) accounts. Total interest income for the year was \$38,395, down \$15,733 from the year before. The 29 percent decrease was due to continued declines in the market yields for 2012, which averaged 0.15 percent compared to 0.207 percent the year before.

TOWN ELECTION FILING DEADLINE

Tuesday, March 5, is the filing deadline for candidates in the May 7 Town election. This year, voters will elect three Town Council members for two-year terms beginning July 1. Candidates must be qualified to vote for and hold the office sought, a resident of the Commonwealth of Virginia for one year immediately preceding the election, and a resident, by the time of filing, of the Town of Vienna.

Candidates for office are required to file specific documents in order to appear on the ballot. The information packet for candidates is available at the State Board of Election's website, <u>www.sbe.virginia.</u> <u>gov</u>, or call toll-free 1-800-552-9745 and ask for the Election Services Division. SEWER BACKUPS ARE EXPENSIVE; BACKUP **INSURANCE IS NOT!**

The Town of Vienna makes every attempt to prevent sewer backups from occurring. Sewer lines are specially designed to reduce accumulation and stoppages. In addition, a maintenance crew is devoted to inspecting and cleaning sewer lines throughout the Town on a regular basis. Degreasing chemicals are also injected into lines in areas that are prone to stoppages, such as those near restaurants and apartments. Even with this rigorous maintenance schedule; however, backups can still occur.

All insurance companies writing homeowner policies in Virginia offer special coverage for damage resulting from backups of drains and sewers, and this additional protection is available at very reasonable rates. For information on obtaining sewer backup coverage, contact your insurance company. The Town's insurance carrier rarely approves claims resulting from sewer backups unless negligence in maintaining the system can be shown. Therefore, residents are encouraged to protect their property by obtaining sewer backup insurance.

Financial Services Relocated

Throughout the duration of the project, all financial services including water and sewer bills and customer service, dog licenses, vehicle licenses, business licenses, meals taxes, parking tickets and all other cashier services will be located in a temporary facility behind Town Hall.

The current Finance space located on the first floor of Town Hall will serve as swing space and house services that are being impacted due to work occurring in other parts of the building. Temporary signage will be used to indicate the location of temporary workspace of impacted departments.

Construction Schedule

The work will be completed in phases and is approximately scheduled as follows:

• January - May: Phase I -Renovation of Town Council Chambers and 2nd floor offices

- May August: Phase II -Renovation of 1st floor offices
- August October: Phase III -Renovation of lower level offices

RECYCLING AT NORTHSIDE: DROP OFF USED MOTOR OIL, ANTIFREEZE AND BATTERIES

The recycling dav for used next quarterly motor oil. antifreeze and car batteries is Saturday, March 2 from 8 am to 2 pm at Northside Property Yard, 600 Mill Street NE (entrance at the dead end of the street). This service of the Public Works Department provides citizens a convenient and environmentally responsible way to dispose of vehicle waste products. For more information, call (703) 255-6380.

Too often, used oil is improperly poured down storm drains or into sewers. Just one quart of oil can pollute 250,000 gallons of water, releasing toxic metals such as lead, cadmium and arsenic into the environment. Recycled oil is a valuable resource that can be remanufactured into new fuels. Antifreeze, like oil, can contaminate water and should never be disposed of in drains or sewers. In addition, antifreeze stored around the house presents a great danger to children and pets; it tastes sweet but is deadly poison. Improper disposal of automobile batteries is a leading cause of lead contamination in landfills and energy recovery facilities. In Virginia it is illegal to dispose of automobile batteries with refuse.

The Transportation Safety Commission (TSC) is seeking interested Town residents to serve on the newly established Pedestrian Advisory Committee (PAC), a subcommittee to the TSC.

BOARD AND COMMISSION SPOTLIGHT: PLANNING COMMISSION

The Vienna Planning Commission is a nine-member board charged by State statute with approving preliminary subdivision plats and making recommendations to the Town Council on final plats, site plan modifications, changes in zoning, amendments to the zoning ordinance and revisions to the Town's Comprehensive Plan. Commissioners also provide recommendations to the Board of Zoning Appeals on applications for conditional use permits.

In addition to multiple plan reviews, recent activities include the development of recommendations on the proposed PPEA Municipal Parking Structure at 120 Church Street NW and the 2013 update to the Comprehensive Plan.

The Vienna Planning Commission meets at 8 pm on the second and fourth Wednesdays in January through June, August and September, the second Wednesday and fourth Thursday in October and the second Wednesday in November and December. BUSINESS LICENSE RENEWAL DEADLINE: MARCH 1

Town businesses are reminded that March 1 is the deadline for payment of the annual business, professional, and occupational license (BPOL) tax. All businesses in the Town of Vienna, including home occupations, must renew their business licenses each year. The amount of the tax is based on gross receipts, and the rate varies according to the type of business. The gross receipts threshold is \$50,000 to use the tax rate. Businesses with gross receipts of \$50,000 or less pay only the minimum license fee of \$30 per year.

VIENNA WATT WATCHERS PROGRAM

In April 2011, the Community Enhancement Commission (CEC) launched a program called the Vienna Watt Watchers. Through this program, Vienna residents can borrow a whole house energy monitor or an appliance/electronics energy monitor at the Vienna Community Center and track their current energy consumption in hopes that as a result of their findings, they will make various changes in their home and at work to reduce their energy use and live more sustainably.

During the fall of 2012, local Boy Scout Mark Logan of Troop 1978 conducted his Eagle Scout project by assisting the CEC with marketing this program. He prepared an installation guideline for the monitors as well as enlisted fellow scouts to install them and collect data regarding home electricity use. He found that the newer Energy Star appliances use significantly less power than the older models and that when electronic devices such as the cable box, coffee maker and microwave oven are turned off they are still siphoning energy or a "phantom load". Even chargers for cell phones and MP3 players are using energy when plugged in – even if they aren't charging a thing!

Fellow scout David Godwin also of Troop 1978 is planning to continue along this vein with his Eagle Scout project by possibly collecting data about whole house usage, comparing different square footage, as well as a typical teenager's use of electricity and report on the effect small modifications of use can affect consumption. He'll be displaying his findings at this year's 5th Annual Green Expo on April 18, 2013 at the Town of Vienna Community Center.

We invite you to attend and discover how you can make small changes that lead to savings on your electricity consumption and bill. In addition, the monitors can be checked out from the Town of Vienna Community Center between 8 am to 4:30 pm, Monday through Friday. A refundable deposit is required. THIS MONTH IN HISTORY

From the Vienna Newsletter Archives

February 2003: At its February 3 meeting, the Town Council will hold a public hearing on proposed amendments to the Town's Chesapeake Bay Preservation Areas ordinance. Local governments in Virginia are required to change their Chesapeake Bay protection program no later than March 1. Revisions to the regulations include refining the definition of perennial streams, how these water bodies are determined and the intent to preserve the entirety of the required 100-foot wide buffer that adjoins them.

February 1993: Hunter Mill is now officially the name of Vienna's magisterial district, which was previously known as Centerville District. Fairfax County Supervisor Bob Dix, Jr. had sought the name change to eliminate confusion for residents of Centreville, which is not located in the district. The new name was selected from among dozens of citizen suggestions.

February 1983: The snowstorm of February 10-11 will go down in history as the "Blizzard of '83." It was one of the biggest and costliest storms ever. In all, 2,074.5 man-hours were spent on snow removal. Approximately 300 tons of salt and 300 tons of sand were spread on town streets. The total cost of digging out of the Blizzard of '83 is estimated at \$31,321.88.

February 1973: Vienna's newly adopted street map includes one new road and extensions of several existing roads. The new road will be the much discussed second access road into Vienna's Technology Park. Street extensions include Church Street extended to connect to Pleasant Street, which takes into consideration the possibility of a new Post Office being constructed on Lawyers Road and Church Street and may or may not be required.
