In addition, public hearings on the proposed tax rate and water & sewer rates will be held on Monday, April 15. Both meetings will be held in the Town Council Chambers in Town Hall, 127 Center Street, S and will begin at 8 pm. The public in encouraged to provide their comments during these public hearings.

# BOARD AND COMMISSION SPOTLIGHT: BOARD OF ZONING APPEALS

Vienna's Board of Zoning Appeals is a "quasi-judicial" board, the members of which are recommended by the Town Council to the Circuit Court of Fairfax County for appointment. The Board is empowered by the Code of Virginia to perform the following functions: hear and decide appeals of decisions made by the Director of Planning & Zoning in his capacity as the Town Zoning Administrator; grant variances from the zoning code; authorize conditional use permits; and interpret the zoning map, although it cannot rezone property, grant prohibited uses, make changes to the Town's zoning ordinance or substantially change zoning boundaries. Some recent decisions include the grant of a conditional use permit for a week-long Hypothermia Shelter within the Holy Comforter Church and the grant of conditional use permits for the construction of "brick-and-mortar" additions to Cunningham Park and Marshall Road elementary schools.

The Board meets the third Wednesday of each month, except August, at 8 pm in the Council Chamber at Town Hall, and interested citizens are always welcome to attend. 

In-person absentee voting will be conducted at the Fairfax County Government Center from March 22 through May 4, on Monday, Tuesday, Wednesday and Friday from 8 am to 4:30 pm, Thursdays from 8 am to 7 pm and Saturday, May 4, from 9 am to 5 pm. May 4 is the last day to vote absentee in person.

The deadline to apply for an absentee ballot by mail is April 30, at 5 pm. Ballots must be received in the Office of Elections by 7 pm on election day in order to be counted.

# A Look at the Proposed Budget For Fiscal Year 2013-2014

### MESSAGE FROM THE TOWN MANAGER

The Town of Vienna's Proposed Fiscal Year 2013-2014 Operating Budget has been presented to the Town Council. The proposed budget attempts to keep tax payers' cost down while maximizing the Town government's operational efficiencies with regard to service delivery to the Town's citizens and customers. Overall, the Town's fiscal position is strong.

For 2013, the average existing residential assessments increased by 6.99% over 2012 while the average commercial assessment decreased by 2.75%. The Town did experience new construction and improvements to existing residential properties of almost \$59 million during 2012, while during the same time period commercial properties decreased by \$3 million. As of January 1, 2013, the percentage ratio of residential to commercial value in Town is 80/20 versus a 78/22 ratio in 2012. While the change is slight it does show that commercial assessments are not keeping pace with the increase in residential assessments.

As in previous years, we have continued our practice of conservative revenue forecasting. The FY 2013-14 proposed budget is based on a real estate tax rate of 23.69 cents per \$100 of assessed valuation which represents a reduction from the FY 2012-13 rate of 24.21 cents, but is an effective tax rate increase of one percent as defined by law. During the March 9 and 11 work sessions, Town Council revised the proposed budget to reflect a tax rate of 23.44 cents per \$100 of assessed value.

Expenditures for the Water and Sewer Fund total \$7,622,000, an increase of \$124,788 or 1.7 percent. This puts the Town on course to recover \$300,000 of the \$900,000 loss to the Water and Sewer Fund balance experienced last year as part of our three phase recovery plan. This plan projects to make up \$170,000 of the amount identified in phase two of the recovery plan, without increasing the current Water and Sewer rates of \$4.75 per 1,000 gallons for water consumption and \$6.66 per 1,000 gallons for sewer use. The Water and Sewer availability fees are proposed to be increased to match Fairfax Water fees.

I invite you to read the entire budget message and proposed budget. The budget is available for public review at Town Hall, the Patrick Henry Library and online at <u>www.viennava.gov</u>. We also have a tax calculator widget on the website so that citizens can compute their actual Town taxes for 2013-2014 versus the 2012-2013 rate. Citizens are also encouraged to attend a public hearing on the budget, scheduled for the Town Council meeting on Monday, April 1, beginning at 8 pm in the Council Chamber at Town Hall. Also, a public hearing on the proposed tax rate and water and sewer rates is scheduled for Monday, April 15.



## BUDGET PREPARATION AND ADOPTION

The Code of the Town of Vienna requires that by July 1 of each year, the Vienna Town Council adopt by ordinance a budget establishing the tax rate for the incoming year. Estimated revenues must be equivalent to estimated expenditures. It is mandated in the Code that the fiscal year begin on July 1 and end on June 30.

At least one public hearing must be held on the budget prior to its adoption. Seven days prior to this hearing, the Town Clerk must publish a notice of Council's intention to hold such an event. The budget cannot be adopted at the same meeting at which the public hearing is held. Two notices, again at least seven days apart, must then be published in a paper of general circulation announcing Council's intention to adopt the budget. Following this advertisement, Council may then adopt the budget. After this action is taken, the Town Clerk publishes the final notice of adoption.

The Town of Vienna's budget process begins in January of each year when Council presents to the staff its budget priorities for the upcoming year. Citizens who have suggestions about what items should be given priority for funding are encouraged to express their views in writing to the Town Manager. In addition, non-profit Vienna organizations may apply for donations of Town funds.

The Town Manager then prepares and submits to the Town Council his proposed budget, and copies are made available to the public. This year, budget work sessions were scheduled for March 9 and 11. The public hearing on the proposed budget will be held at the Town Council meeting on April 1, which begins at 8 pm in the Council Chamber at Town Hall. If Council considers it necessary, a final budget work session to discuss comments made at the public hearing will be held on April 22, at 7:30 pm. A separate hearing on the proposed tax rate and water and sewer rates will be held on April 15. Adoption of the budget is scheduled for the May 13 Council meeting.

#### **THIS MONTH IN HISTORY** From the Vienna Newsletter Archives

**April 2003:** After a quarter century of efforts on many fronts to save the Moorefield house and restore it to a condition representative of the late 1700's, based on recommendations made by Historic Vienna, Inc., the Town Council voted to raze the building and to construct a commemorative park on the site. A commemorative park will be created on the site with appropriate markers and signs providing information on the life and contributions of Jeremiah Moore.

**April 1993:** As lawn mowing season approaches, the Public Works Department has announced that beginning April 5, it will collect grass clippings from town residents on the first pick up day each week. Collection of clippings early in the week will be more convenient for residents who mow the lawn on the weekend.

**April 1983:** A vigorous enforcement program has begun to halt the illegal posting of signs on utility poles, in median strips and in the right of way between sidewalks and roadways. Town personnel will remove and record all illegal signs, and as a follow-up, the Zoning Administrator will conduct a second survey to identify any signs that have been replaced.

**April 1973:** The U.S. Post Office Department has purchased the property on Lawyers Road directly opposite Church Street as the site of Vienna's new post office. Since 1965 the Town's Master Street Plan has provided for the extension of Church Street from Lawyers Road through to Pleasant Street. Postal officials have requested the Town to abandon the plan for the Church Street extension.

### TEMPORARY CHLORINE TASTE IN WATER

Beginning April 2 through July 2 you may notice a slight chlorine taste and odor in your drinking water as Vienna's drinking water supplier will temporarily switch the disinfectant it uses in the distribution system from chloramines to free chlorine. This temporary change is performed annually and is part of a regular process used to keep water mains clean and free from potentially harmful bacteria. As always, the Department of Public Works will continue to monitor the drinking water to ensure that it meets all federal and state drinking water standards.

If you are sensitive to the taste of chlorine, you may be able to reduce the taste by refrigerating a pitcher of drinking water overnight. If you have questions, please contact Acting Water and Sewer Superintendent Donald Kahn at (703) 255-8610 or <u>dkahn@viennava.gov</u>.
