Town Election Filing Deadline: March 4

Tuesday, March 4, is the filing deadline for candidates in the May 6 Town election. This year, voters will elect Mayor and three Town Council members for two-year terms beginning July 1. Candidates must be qualified to vote for and hold the office sought, a resident of the Commonwealth of Virginia for one year immediately preceding the election, and a resident, by the time of filing, of the Town of Vienna.

Candidates for office are required to file specific documents in order to appear on the ballot. The information packet for candidates is available at the State Board of Election's website, <u>www.sbe.virginia.gov</u>, or call toll-free 1-800-552-9745 and ask for the Election Services Division.

Last Chance to Order Leaf Mulch

Friday, February 28, is the last day to order a free delivery of ground leaf mulch from the Public Works Department. To place your order, call (703) 255-6388 and leave your name, address, daytime phone number and the number of loads to be delivered. One load is estimated to be 2.5 cubic yards (equivalent to 33-34 store bought bags.) Half loads are also available. Orders may also be placed online at <u>www.viennava.gov/index.</u> aspx?NID=164. Please note the following important conditions:

- All mulch deliveries are based on availability of mulch.
- Mulch deliveries will be placed only in the driveway at the end closest to the house.
- Once mulch is delivered, it becomes the property of the homeowner and the Town will not remove any excess mulch ordered.

Residents may pick up mulch themselves in any amount between the hours of 9:30 am and 3:30 pm, Monday through Friday (except holidays) through March 30. The mulch is stored on Town-owned property off Beulah Road near Glyndon Park. Look for the sign, "Free Leaf Mulch."

Mayor Seeman, Council Members Cole and Polychrones Announce Retirement

During the December 16 Town Council meeting, longtime Council member Laurie Genevro Cole announced her decision not to seek a seventh term during this year's Town election. In addition, during the January 6 Town Council meeting, Council member Michael Polychrones and Mayor M. Jane Seeman both announced their intent not to seek re-election this year.



Seeman, who has served for 18 years on the Vienna Town Council - the last 14 as Mayor, has been a Vienna resident since 1968 and was first appointed to the Town Council in 1996 to fill the unexpired term of the late Councilman Rodger W. Seeman. Throughout her time on Council, she has been involved with various boards including the Northern Virginia Regional Commission, Towns Association of Northern Virginia and the Tysons Partnership, and is a member of Historic Vienna, Inc., Rotary Club and numerous community organizations, including the Patrick Henry Library where she has volunteered more than 3,000 hours. She is planing to read a wide variety of books in her retirement as well as travel more.

Cole has been a resident of Vienna since 1986 and was first elected to Town Council in 2002 and has served as a Council member for twelve years. Prior to serving on Council, she has served on the Community Enhancement Commission (Chair), Planning Commission (Chair) and the Board of Zoning Appeals. Cole has been involved with and supported the Vienna Volunteer Fire Department, Louise Archer Elementary School PTA, Music Friends of the Fairfax County Library and actively volunteered for Vienna youth sports. She is currently volunteering as a pro bono attorney through the Veterans Consortium Pro Bono program and is a member of the Vienna Optimist Club of Greater Vienna and AAUW Vienna Branch. She is looking forward to spending more time with her family and traveling.





Polychrones is a life-long Vienna resident and was first appointed to Town Council in 1996, and has served for 17 years on Council. Prior to serving on Town Council, he was appointed to the Transportation Safety Commission and the Planning Commission. During his time on Council, he has served as President of the Virginia Municipal League, a member of the VML Executive Committee and the Beltway Improvement Task Force for Fairfax County. He is active in the community and through the years has been involved with the Vienna Jaycees and the Vienna Host Lions Club. He and his wife Patti are planning to relocate out of the area.

Sewer Backups are Expensive; Backup Insurance is Not!

The Town of Vienna makes every attempt to prevent sewer backups from occurring. Sewer lines are specially designed to reduce accumulation and stoppages. In addition, a maintenance crew is devoted to inspecting and cleaning sewer lines throughout the Town on a regular basis. Degreasing chemicals are also injected into lines in areas that are prone to stoppages, such as those near restaurants and apartments. Even with this rigorous maintenance schedule; however, backups can still occur.

All insurance companies writing homeowner policies in Virginia offer special coverage for damage resulting from backups of drains and sewers, and this additional protection is available at reasonable rates. For information on obtaining sewer backup coverage, contact your insurance company. The Town's insurance carrier rarely approves claims resulting from sewer backups unless negligence in maintaining the system can be shown. Therefore, residents are encouraged to protect their property by obtaining sewer backup insurance.

Board and Commission Spotlight: Planning Commission

The Vienna Planning Commission is a nine-member board charged by State statute with approving preliminary subdivision plats and making recommendations to the Town Council on final plats, site plan modifications, changes in zoning, amendments to the zoning ordinance and revisions to the Town's Comprehensive Plan. Commissioners also provide recommendations to the Board of Zoning Appeals on applications for conditional use permits.

Recent activities include the development of recommendations on a number of new subdivisions, conditional use permit applications for a variety of uses and the 2014 update to the Comprehensive Plan.

The Vienna Planning Commission meets at 8 pm on the second and fourth Wednesdays in January through June, August and September, the second Wednesday and fourth Thursday in October and the second Wednesday in November and December. Meetings take place in the Council Chambers at Town Hall and interested citizens are invited to attend. Commission members include Chairperson Jim Hendricks, Charles Anderson, Walter Basnight, Jr., William Daly, Jr., Michael Gelb, Stephen Kenney, David Lanphear, Melvin McCoy and David Miller. Business License Renewal Due March 3

Town businesses are reminded that March 3 is the deadline for payment of the annual business, professional and occupational license (BPOL) tax. All businesses in the Town of Vienna, including home occupations, must renew their business licenses each year.

The amount of the tax is based on gross receipts and the rate varies according to the type of business. The gross receipts threshold is \$50,000 to use the tax rate. Businesses with gross receipts of \$50,000 or less pay only the minimum license fee of \$30 per year.

Be On The Lookout for Your Water and Sewer Bill!

The yellow postcard is gone! In July 2013, the Town upgraded the Water and Sewer bills to an $8\frac{1}{2} \times 11^{\circ}$ bill in a standard envelope. Water and Sewer is billed quarterly and a ten percent late fee applies to any payment received after the due date. Annual Financial Report Available

The Town of Vienna's Comprehensive Annual Financial Report for fiscal year ending June 30, 2013, is now available for review online at <u>www.viennava.</u> <u>gov/Archive.aspx?AMID=39</u>. It is also available for review in the Finance Department at Town Hall or can be purchased for \$5 per copy.

The report summarizes the Town's financial position and results of operations of the various funds and account groups. It also includes the Auditor's Report on FYE 2013, information on internal controls for managing and safeguarding Town assets, and selected financial and demographic information from the last ten years.

According to the report, the Town ended last fiscal year in stable financial condition. General and Debt Service Funds ended the year with combined revenues of \$22,623,153, a decrease of \$52,503 or 0.23 percent from the previous year. The main driver of this decrease was the receipt of over \$500,000 in seized assets in 2012. Additionally, meals taxes rose \$196,333 or 9.7 percent and property taxes rose \$262,296 or 2.9 percent. The meals taxes increase was mainly due to a number of new restaurants and general increased business.

Total expenditures and transfers of the General and Debt Service funds increased by \$517,220 or 2.2 percent from the preceding year. The increase was due to retirement payouts for three department heads who retired in 2013 plus re-grading and new hires in the police, finance and information technology departments.

Last year's Water and Sewer operating revenues increased \$1,064,351 from 2012 or 17.5 percent, ending the year at \$7,129,668. This was primarily due a 19 percent increase in the combined water and sewer rates in 2013. Operating expenses ended the year at \$6,137,921, a decrease of \$69,460 or 1.17 percent. This decrease was due to aggressive management of expenditures in an effort to recoup the losses from the prior year. General obligation debt of \$1,636,667 from issues dated 1998, 1999, 2002, 2006 and 2010 was retired during the year, and new debt of \$6,310,000 was issued in 2013, bringing the total outstanding general obligation debt to \$15,216,668 at year end. This balance represented 0.4 percent of the fiscal 2013 assessed property values, well within the Town's legal debt limit.

The Town's cash reserves were invested in U.S. Government Securities and interest-bearing deposit and cash accounts during the year. At year-end, \$23,008,786 or 78 percent was invested in the State's Local Government Investment Pool (LGIP) accounts and \$4,938,399 or 16.7 percent was invested in the Virginia State Non-Arbitrage Program (Virginia SNAP). Total interest income for the year was \$55,273, up \$16,878 from the year before. The 44 percent increase was due to a slight increase in the rates earned at LGIP of 0.16 percent compared to 0.15 percent in 2012, plus the funds invested at SNAP at an average rate of 0.236 percent.

Tax-Aid Program at SunTrust, February 3 - April 15

The AARP Tax-Aide program is the nation's largest free, volunteer-run tax preparation service, available to low- and middle-income taxpayers with special attention to those age 60 and older. AARP Tax-Aide is administered by the AARP Foundation in cooperation with the IRS.

Tax-Aide volunteers are trained to assist with filing the 1040 form and the more standard of the schedules, including Schedules A and B. (Taxpayers with complex tax returns are advised to seek paid tax assistance.) Since 1968, AARP Tax-Aide volunteers, trained in cooperation with the Internal February 2014 Revenue Service, has helped nearly 50 million taxpayers file their tax returns each year.

From February 3 through April 15, Tax-Aide volunteers will be at SunTrust Bank, 515 Maple Ave E, Monday through Friday from 10 am to 2 pm. No appointment is required. You do not have to be retired or a member of AARP to benefit from this free program.

All tax returns will be filed electronically. All taxpayers MUST bring a government-issued picture ID and Social Security cards or other official documentation for yourself and all dependents. English Ivy: Beautiful, but Invasive

It is a great time of the year to notice deep dark green foliage on the trees in town. This lovely deep green starts from the ground and sometimes grows so profusely that it appears to be the leaves of the tree. But the tree's leaves have all fallen and the new growth isn't out yet so what can it be? It's a vine and it is probably English Ivy.

English Ivy is so vigorous that it kills the trees it inhabits. Ivy kills the tree because it eliminates the trees ability to manufacture it's own food from sunlight, a process known as photosynthesis. It only takes a couple of years once the ivy makes it's way into the canopy to kill your tree, therefore the best control is to keep it from growing up the trunk of the tree and it isn't hard to do.

To remove the ivy, cut the ivy's vine at the base of the tree (you don't want or need to pull the ivy off the tree as the vine will die and fall off eventually). Pull the ivy back on the ground,



removing it from the area. Better to remove the ivy periodically from the tree base than to have to pay to remove the tree when it dies.

Trees add thousands of dollars of resale value to your property along with their beauty and shade, saving you money on air conditioning in the summer. Dead trees are dangerous and are expensive to remove.

This Month in History

From the Vienna Newsletter Archives

February 2004: The Vienna Town Council amended the Town's program of tax relief for elderly and disabled residents, increasing the asset cap from \$160,000 to \$190,000. The increase makes the Town's tax relief asset cap the same as Fairfax County's.

February 1994: The Vienna Police Department is now a participating agency in the LoJack alarm system, a car security system designed to lead to rapid recovery of stolen vehicles. LoJack alarms are transmitters hidden in a vehicle. When the vehicle is reported stolen, the LoJack begins to transmit. Police vehicles equipped with LoJack tracking computers can receive the signal from up to five miles, track the vehicle, locate and recover it.

February 1984: A task force of Vienna residents has completed its review of the Route 123/Old Courthouse Road/Heads Hill Farm area. A proposed amendment to the Fairfax County Comprehensive Plan would allow commercial development in that area rather than the townhouse development provided for in the current plan. The task force recommends unanimously against any change, not only to buffer the town's residential areas but also to avoid setting any precedent for extending commercial development along Route 123.

February 1974: A proposed network of bikeways, designed to provide access to schools, parks, recreation areas and shopping centers has been proposed by the Vienna Bikeway Committee, which plans to hear residents' comments on the proposed network on February 16. The Bikeway Committee was established by Council last September to design a bikeway system that would serve in both recreational and commuting capacities.
