

Town of Vienna Automobile Tax Decal

MOTOR VEHICLE TAX

Vienna residents are favoring, two-to-one, the new decals over the traditional license plates for the Town's auto registration. Residents are given a choice this year of using either the decal or plate on their automobiles. After April 15 Town Council will decide which type of registration it wants to continue for future years. All autos regularly housed or stored in Town must be registered with a 1975 registration no later then April 15. The Finance Department will be open an hour later, until 5:45 p.m., on April 14 and 15 so residents who have not yet purchased their registrations may do so.

Church Street Extension Engineering Ok'd

Council approved proceeding with the acquisition of the necessary right-of-way for the extension of Church Street from Lawyers Road to the back property line of the proposed post office.

The extension will serve the new post office planned for the intersection of Church Street and Lawyers Road and will open Church Street through to Pleasant Street.

With the present economy in a tailspin, families have had unfortunate battles with galloping inflation. Meanwhile, the country as a whole suffers from a recession. Economic news is bad. Families are cutting corners in their household budget and are hampered with less buying power. So, when some 5,100 Vienna households received the County's new real estate assessments in the mail recently matters looked worse.

With this in mind the Vienna Town Council has announced a decision to cut the Town real estate tax rate which will be effective as of July $1 ext{.}$

On April 14, Council will have a public nearing on the establishment of a new tax rate. Presently, Vienna households are paying 98 cents per \$100 valuation in Town taxes. The sum is small compared to the walloping rate the County charges Vienna residents: \$4.10 per \$100 valuation. The public hearings on the Town tax rate will begin at 8 p.m. in Town Hall.

Presently Town Manager C. Clay Harrell, who prepares the Town's budget, does not know how much the present tax rate can be cut. He will have a recommendation by April 14.

However, Town Council has gone further than committing the Town to cutting its tax rate. It has asked the County to do the same.

Council has asked the County to declare a moratorium also. What's more, Council requested that if the Board of Supervisors finds it impossible to impose a moratorium on the application of new assessments until after July 1, then the Board instruct those of the County responsible for the collection of real estate taxes to not bill any taxpayer as of June 30 a greater amount than was billed for last year at that time.

Although Council plans to press hard for a cut in the County's tax rate it doesn't want to discourage individual citizen protests by Vienna residents aimed at the Board of Supervisors.

CONGRESSIONAL VISIT -- Congressman Joseph Fisher paid a courtesy visit to the Vienna Town Council during the meeting of March 17. Fisher offered his legislative assistance on issues that Council deems pertinent to the Town's residents and explained what his responsibilities will be on the important and powerful House Ways and Means Committee.

Fisher Makes Council Visit

Congressman Joseph Fisher told Town Council at a regular meeting of Council March 17 that he will "do anything I can do to get" the Dulles Access Road open to commuter traffic.

The road is presently open only to traffic going to and from the Dulles Airport. The Town would like to see the highway opened to relieve traffic now using the Town's roads.

Fisher also said he intends to introduce legislation in the House that would give homeowners a break on their federal income tax for local utility taxes.

Council originally requested the freshman Congressman to check into the possibility of initiating federal tax breaks on local utility taxes.

Fisher said he has opened two offices in Virginia to serve his constituents. The offices will be located in Falls Church and Leesburg.

Don't forget to register to vote for the Town's General Election. Deadline is April 5.

AFS Selling Discount Cards

The shopping dollar that buys the most in Vienna is probably the one spent on an American Field Service (AFS) Discount Card. Seventy-two local merchants and businessmen will be offering varying discounts from April 21 to May 3 to holders of an AFS Discount Card.

For the thirteenth year this discount is available for the community in a joint venture of the AFS and the business community. Monies received from the purchase of these cards at \$1 apiece aid the foreign exchange program of the Vienna Chapter of the American Field Service at Madison High School.

The card may be purchased and used (and reused) throughout the two week period. The card entitles the holder to specific discounts including automotive service, beauty parlor care, dry cleaning, merchandise and restaurant and food purchases.

The inflation-beating Discount Cards are on sale at Madison High School, at area PTA meetings, and at the following locations: Arlington Trust Bank, Cook's Photo Art Studio, First and Merchants Bank in the Giant Shopping Center, Ketterman's Gift and Jewelry Store, Marion's Dress Shop, Sewing Circle, Vienna Shoe Store, Vienna Hardware and Worthington's.

Tax Relief Guidelines for Elderly

Tax relief and rent subsidies to certain low-income senior citizens are available from the Town of Vienna and Fairfax County. Both the Vienna Town Council and Fairfax County Board of Supervisors have adopted ordinances providing relief.

Relief is provided for Real Estate Taxes, Rental Grants, Personal Property Taxes and Town Auto Registration Taxes. Qualifications are the same for all four types of relief.

To Qualify You Must:

*Be 65 years of age or older.

*Have a gross household income from all sources of not more than \$10,000 annually, excluding the first \$4,000 of income of each relative, other than spouse, residing in the household.

*Applicant, spouse and relatives living in the household must have a combined financial net worth of no more than \$35,000. (In determining the Real Estate eligibility only the assets of the applicant and spouse need be considered.)

Types of Relief:

REAL ESTATE TAXES:

As Town residents are subject to two real estate taxes, one from the Town (98 cents per \$100 valuation) and the other from Fairfax County (\$4.10 per \$100 valuation), relief is available for both taxes.

Property eligible for tax exemption is the homeowner's residence and the land it occupies, not exceeding one acre.

Forms for exemption from Real Estate taxes were mailed to those who previously qualified during 1974. Applications must be filed no later than May 1, 1975 for relief from 1975 Town and County Real Estate taxes.

AUTOMOBILE REGISTRATION TAX:

Persons qualifying for Real Estate tax relief, rental grants or personal property tax relief are also eligible for relief for the Town of Vienna's automobile registration tax. Persons should file for relief no later than December 31.1975 for the 1976 registration.

PERSONAL PROPERTY TAXES

The Town does not have a personal property tax, however, Fairfax County does. Relief is available for the entire personal property tax on one automobile per household.

If an automobile is jointly owned, all owners must be 65 years of age or older, except the applicant's spouse need not have attained the age of 65.

Personal property tax relief applications must be filed with your Personal Property Tax Return by May 1,1975 for relief from payment of taxes due on December 5, 1975.

RENT GRANTS:

Fairfax County offers rent grants for eligible Town residents.

Rent grant applications were mailed to previously qualified applicants in December 1974. Applications must be submitted no later than May 1, 1975. Rent receipts or cancelled checks will be required to support the rent grant application.

Persons not eligible for rent grants include:

*Residents of rental properties owned and leased by the Redevelopment and Housing Authority, or

*Residents of a non-profit facility whose owners are exempted from payment of real estate taxes.

How to Apply for Relief:

The County has two forms that cover all four types of tax relief. Candidates for relief should fill out the form and return it to the County as soon as possible. Those who have not received their forms should request them from the County, by calling 691-2371 for Real Estate tax relief and 691-2437 for all other types of tax relief.

After filing for relief with the County, candidates living inside the corporate limits of Town should fill out a Real Estate tax relief form and automobile registration tax relief form with the Town of Vienna's tax section of the Finance Department. Those who received relief last year were sent forms again this year. If you did not qualify last year, but are eligible this year, you can obtain these forms by calling Mrs. Lavern Hurst at 938-8000.

Food Stamps Increase Buying Power

You do not have to be unemployed or be on welfare to take advantage of food stamps. Eligibility depends on how much of your income is available to buy food.

By using food stamps, uou may increase your food buying power from 25 to 50 percent. The amount you pay for food stamps depends on your income.

You have a right to food stamps, just like Social Security or Unemployment Compensation.
