Town Is Recognized As **Bicentennial Community**

The Town of Vienna was officially recognized as a Bicentennial Community, Wednesday, May 21, by the American Revolution Bicentennial Administration (ARBA.)

Vienna was recognized because of its "meaningful Bicentennial activities." In order to receive the honor the Town had to have an active Bicentennial Commission with useful, sound and active programs.

According to Vienna Bicentennial Commission chairman Paul M. Lyons, the honor was "recognition of the commission's many active programs over the past three years. Our Fourth of July celebration is by far the best in the Washington area."

He said the honor will "build strength to the Town's program and will enable the Town to apply for certain federal grants for the commission's programs."



NEIL M. WALP Elected to Fourth Term

Hicks, Upchurch, Walp Are Elected

Donald E. Upchurch, 50, chairman of the Vienna Economic Policy Advisory Commission, was elected to Town Council along with incumbents Raymond E. Hicks and Neil M. Walp in the Town's 1975 General Election held in May.

Walp will be starting his fourth term on Council, Hicks will be starting his second term. All three will begin two-year terms July 1. The terms expire June 30, 1977.

Some 1,806 voters went to the polls at the Vienna Community Center. Walp was the top vote getter with 1,240 votes, Upchurch had 1,209 and Hicks received 1,148. Unsuccessful were incumbent Robert J. Skahan and E. Ross Buckley. Skahan polled 744 votes while Buckley received 691.

The three elected Councilmen will join Mayor Joseph R. Spriggs and Councilmen Paul M. Lyons, Stephen G. McConahey and Charles A. Robinson Jr., all of whom have one year remaining on their Council terms.

Newcomer Upchurch resides at 505 Roberts Dr. He holds a master's degree in government and politics and has experience in management systems in government and private enterprise.

Walp lives at 208 Yeonas Dr. SW, and Hicks resides at 209 Glyndon St. NE.

Budget Adopted

Town Council adopted a record \$4.33 million operating budget for fiscal year 1975-76.

Included in the adopted budget, which is slightly higher than the Town Manager's proposed document, are \$25,000 for expert legal services for two pending rezoning cases involving properties along Church Street, \$30,000 for a city status study, \$75,000 to be deposited in an interest-bearing account for the future reconstruction of Park Street and \$65,000 for a new employee retirement program.

The proposed budget includes a surplus of \$386,366.

City Status Study Requested by Council

Threatened with the loss of its option to ever become a city in the future, the Town Council met in a special meeting on Saturday, May 10, to plot the Town's future in this very important question.

Council decided to have a study made over the next nine months on the implications of transition to city status. There will be no attempt to petition the Fairfax County Court Circuit at this time.

The Council has never expressed its desire to become a city, nor has the Council ever committed itself to becoming a city. Council's major concern is preserving the Town's option of becoming a city if it ever becomes necessary to preserve Vienna's automony. Although Fairfax County has not taken any action to become a 406 square mile city, there has been speculation that such a move is possible in the future. Fairfax County has tried to incorporate as a city in the past. Vienna's future would be uncertain should Fairfax County become a city. Where other counties in Virginia became cities the towns were simply absorbed into the new city.

Council's main concern with not becoming a city now was because any such action would be like "leaping into the dark." The Town needs much more information before such a move could be done wisely. By becoming a city the Town would have to take over several of the services now provided by the county, namely operation of the schools, health and welfare programs and fire protection services.

Presently the Virginia General Assembly is considering new legislation governing the transition of Virginia towns to city status. It has imposed a 13 month moratorium on towns changing to city status while new legislation is being planned. Council and the Town Manager have committed themselves to take appropriate actions with state officials to preserve the right of the Town of Vienna to transition to city should the people of the Town so desire.

Making any move to become a city is a serious and difficult decision for each Town Councilman to make. The implications could be very drastic on Town taxpayers. There is no guarantee that any transition to city status would result in lower taxes for Vienna residents.

Any final decision by Council would probably not come until the General Assembly reconvenes. There would probably be no transition attempt unless the proposed study proved that city status was feasible and that the General Assembly seriously threatened the Town's most important option of ever being able to become a city in the future.

Vienna residents will be kept abreast of events concerning any question concerning city status. Should the issue reach the point that Council thought transition to city status would be a benefit to the community, a special advisory referendum would be conducted.

Vienna Newsline includes results of Town Council meetings and other meetings of various boards and commissions in Town. Prior to the meeting dates the Newsline includes agenda items.

Parks and Recreation news, public service announcements and notification of special meetings are also included on the Newsline.

The program is part of an expanded public information service planned for the upcoming fiscal year. The Town changes the program every one or two days. If anything "breaks" during the day it is recorded on the Newsline as soon as possible.

Vienna officials have already contracted Santa Claus and the Easter Bunny to make messages on the recorded Newsline during the holiday seasons.

Changes Slated This Fall In Pre-School Hours

Four-and five-year-old classes in Vienna's Fall pre-school program at the Community Center will be extended an additional three weeks each week. The schedule will also change for the three-and four-year-old classes but they will meet for the same amount of hours each week as before.

The older class, starting this fall will meet three days a week on Monday, Wednesday and Friday from 9:30 a.m. to 12:30 p.m. The younger class will meet on Tuesdays and Thursdays from 9:30 to 11:30 a.m.

Registration for pre-school begins Tuesday, Sept. 4. For additional information on the pre-school program offered by the Parks and Recreation Department, contact the Community Center at 938-8000.

Resignations Accepted

The Town Council accepted with regret the resignations of two Vienna civic leaders from the Town's commissions.

James O. Harris resigned his post with the Planning Commission and Jerry Barnett resigned from his duel duties with the Community Relations Commission and the Vienna Economic Policy Advisory Commission.

Police Pistol Range Contract Awarded

Council awarded a \$46,860 contract to C&D Construction and Builders of Vienna for the construction of the Vienna police pistol range improvements. The range will be improved with Federal Revenue Sharing Funds.

Flag Day Geremony Set for Mini-Park

The Town of Vienna will share in a national Bicentennial event on Flag Day, June 14, starting at 11:30 a.m. "In a brief ceremony at the Mini-Park (corner of

Maple Avenue and Center Street), we will hoist the United States Flag and the official banner of the nation's Bicentennial," according to Councilman Paul M. Lyons, chairman of the Vienna Bicentennial Commission. Similar ceremonies are scheduled to take place in thousands of communities across the country at the same time.

This event will designate several points of commemoration at one ceremony. It will honor the 198th anniversary of the adoption of the Stars and Stripes as the national emblem. The American flag to be used in Vienna was flown over the U.S. Capitol building on Feb. 28, 1975-- the 85th anniversary of Vienna's incorporation as a Town.

The raising of the Bicentennial flag will be the first public view of Vienna's official recognition as a Bicentennial Community by the American Revolution Bicentennial Administration.

It is hopeful that Federal and State officials will be on hand to make the presentation of the Bicentennial flag.

A color guard of the American Legion, Dyer-Gunnell Post 180, will participate.

A newly installed flag staff will also be dedicated at the ceremony which will display the Bicentennial banner daily to December 1976.

Identical Bicentennial flags will be presented to the Vienna Volunteer Fire Department, the American Legion Post, the Town Hall, the Patrick Henry Library and the Community Center for display on their respective flag staffs.

"We urge all Vienna citizens to participate in the ceremony," Lyons said. "This is an opportunity for the entire family to share in a bit of histroy as well asa timely patriotic celebration."

The Vienna Bicentennial Commission also urges all residents and businesses in Vienna to display Old Glory on Flag Day to really show our true colors.
