

VIENNA POLICE HIGHLIGHTS

January 17, 2020

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from January 10, 2020 – January 16, 2020. Readers are reminded that an "arrest" is based upon probable cause and does not always mean that someone was physically taken into custody. Furthermore, it does not mean that an individual is automatically guilty of a crime. Judicial outcomes and post-arrest proceedings can be researched through the appropriate court's website.

INCIDENTS

Lost Property 20-000464
900 Block Frederick Street, SW
Between July 1, 2019 at 12:00 p.m. and December 30, 2019 at 12:00 p.m.
A resident reported that they lost their passport.

Suspicious Event 20-000427 400 Block Kingsley Road, SW Between August 1, 2019 at 8:21 p.m. and January 13 at 8:21 p.m.

A tenant reported ongoing issues with her landlord. The landlord advised it is the tenant that is causing the problems.

On January 11, a citizen reported that were concerned about their relative who had not been heard from since December 15. On January 10, a resident reported a fraud that happened on December 23. The resident advised that his wife went to the Burke & Herbert Bank to pay their mortgage. She gave the mortgage check to a female at the bank. The resident was later informed that the payment was never received. An employee at the bank found the check had been cashed in another state and was made payable to an individual, instead of the mortgage company.

A resident reported that an unknown person used her personal information to open a PayPal account and unsuccessfully attempted to open another line of credit.

A resident advised that on two separate occasions, people have arrived at his residence to collect a puppy they have purchased. The resident is concerned that scammers may be using his address while defrauding people.

A resident reported a sick fox that was in her yard. Ofc. Gucwa found the fox in grave condition and euthanized the animal.

Robbery 20-000329

Cunningham Park Elementary School

1002 Park Street, SE

January 10 between 2:50 p.m. and 3:00 p.m.

A citizen flagged down an officer and reported that there was a child in front of the school crying, and stating that his cell phone had just been stolen. The child and his friend were last seen going into the elementary school. Ofc. Gucwa located the two boys in the school with the school's staff. The boys advised they are students at Thoreau Middle School. One of the boys stated that a group of students at Thoreau has been bothering him for several months. As he and his friend were walking home from school, the same group of students approached him. During the incident, one of the juveniles in the group slapped the boy and the group ran off. The boy then realized his cell phone had been taken. The boy was not injured during the incident.

A citizen turned in a wallet that she found in the parking lot.

Officers responding to a noise complaint found several people, including juveniles, in an abandoned house. The officers identified all of the individuals. Four of the juveniles were in possession of alcohol. One of them was also in possession of tobacco and provided officers with false identification. The four juveniles were transported to the Vienna Police Station where they were verbally counseled and released to their parents. The homeowner was notified and advised of the warrant process should he wish to pursue charges.

A resident received a suspicious package in the mail from a foreign country. She brought the package to the Vienna Police Station. Officers inspected the package and notified the Fairfax County Fire & Rescue Hazmat Unit. The Hazmat units determined the package may contain hazardous material and notified the FBI for further assistance. Units from the FBI examined the package and determined the package contained glue manufactured in the country it was shipped from. They advised that the product was not hazardous and there was no threat of harm.

An unknown person spray-painted the playground equipment at the Tot Lot.

Reminder Prevention of Stolen Vehicles/Vehicle Tamperings

With the advent of warmer weather, the Town of Vienna Police Department would like to remind all Town of Vienna residents to secure their vehicles and personal belongings. Recently there have been several vehicle tamperings to include stolen vehicles from Vienna and the neighboring jurisdictions.

The Vienna Police Department would like to remind citizens of the following steps to assist in the prevention of your vehicle being tampered with or stolen:

Lock your Car Doors.

The majority of the vehicles being entered and/or stolen have been unlocked.

Remove all Valuables.

In most cases, the subjects responsible for these acts have been targeting vehicles which contain valuables such as, but not limited to, laptop computers, GPS's, pocketbooks/purses, loose change, cameras, etc. If you must leave valuables in your vehicle, please be sure to conceal the items, in the trunk, under the seats or use any other means to make them undetectable. Also, make sure to record all serial numbers, and if possible, engrave them or permanently mark the items with easily identifiable markings, in the event the items are recovered.

Remove all Keys.

The subjects who commit these crimes are aware that most new vehicles come with valet keys. Most of these keys are kept inside the vehicles, either in the center consoles, or the glove compartments or other areas easily accessible. In some instances the owners have left their keys rings containing their house keys, providing access to their homes.

Report Suspicious Activity

In some cases, the subjects have been observed wearing several layers of clothing, not consistent with the weather conditions. This is used to conceal stolen items and also to make identification difficult as they will shed layers of clothing as they flee the area when they suspect they have been observed committing a crime.

The Town of Vienna Police Department is dedicated to the safety and protection of all persons and property in the Town of Vienna. However, much of our success comes from the assistance of its concerned and observant residents.
