

VIENNA POLICE HIGHLIGHTS

April 12, 2019

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from

April 5, 2019 – April 11, 2019. Readers are reminded that an "arrest" is based upon probable cause and does not always mean that someone was physically taken into custody. INCIDENTS

Assault 19-003534 Cedar Lane School 101 Cedar Ln, SW March 27 12:00 p.m.

A staff member reported that while attempting to break up a fight between students, she was struck in the face by one of the students.

Suspicious Event 19-003665 1100 Block Drake Street, SW April 3 between 12:00 a.m. and 8:00 p.m.

A citizen advised that her 3-year-old daughter was injured while she was in the custody of the child's father.

Arrest – Warrant Service 19-003527 Wolftrap Hotel 430 Maple Avenue, West April 5 3:27 a.m.

Ofc. Colligan was in the parking lot of the hotel when he observed three men in the lot. One of the men was found to have an active arrest warrant in Prince William County. Upon the officer's interaction with the man, he found the man was in possession of marijuana.

He was transported to the Fairfax County Adult Detention Center where the warrant charging Destruction of Property was served, and he was charged with Possession of Marijuana. The man was then released from custody on an unsecured \$2000 bond.

While officers were speaking with the three individuals, one of the men became irate and began acting aggressively. The man was found to have an outstanding warrant with Fairfax County.

An employee advised that a man staying in one of their rooms was arrested the evening before and his dog was still in the room. ACO Barker checked on the dog and found it to be in good condition with access to food and water. On April 11 it was noted that the person who was supposed to take care of the dog for the owner never returned to the room. The dog was transported to the Fairfax County Animal Shelter.

A resident reported a man sleeping in the grass near a retaining wall. Ofc. Wallace located the man and, upon his interaction with the man, determined he was intoxicated.

Officers responded to assist rescue personnel with an elderly customer who suffered a medical emergency and collapsed in the store. The customer was transported to an area hospital by rescue personnel for further treatment.

Sgt. Ruddy observed a vehicle traveling at a high rate of speed and initiated a traffic stop. Upon her interaction with the driver, the officer detected signs of impairment. After the driver failed to complete a series of field sobriety tests he was arrested and transported to the Vienna Police Station where he provided a sample of his breath for analysis.

Sgt. Ruddy and Ofc. Gucwa transported the 31-year-old man with no fixed address to the Fairfax County Adult Detention Center where he was charged with Driving While Intoxicated and Reckless Driving.

Vehicle-2 was parked facing westbound on Moore Avenue, SE. Driver-2 was in the vehicle with the driver's side door open. Vehicle-1 was traveling westbound on Moore Avenue and struck the door of Vehicle-1.

Vehicle-2 was traveling eastbound on Maple Avenue. Vehicle-1 was traveling westbound on Maple Avenue, attempting to turn left onto southbound Nutley Street when he struck Vehicle-2.

Vehicle-2 was exiting the parking lot of the library to turn left onto southbound Center Street. Vehicle-1 was traveling northbound on Center Street when the driver crossed the double yellow line to go around traffic and get into the left turn lane on Maple Avenue. Vehicle-2 struck the passenger side door of Vehicle-1 causing minor damage to both vehicles.

Vienna Police Department to Participate in the D.E.A. Prescription Drug Take Back Initiative

Saturday, April 27, 2019 from 10:00 a.m. to 2:00 p.m.

In conjunction with the United States Drug Enforcement Administration (D.E.A.) and state and local law enforcement agencies, the Vienna Police Department will again participate in a one-day initiative to remove potentially dangerous controlled substances from area homes.

On April 27, 2019, between the hours of 10:00 a.m. and 2:00 p.m. the Vienna Police Department will have a collection site for old, expired, unused, or unwanted medications. Prescription medications, controlled or non-controlled substances, and over the counter drugs may be turned in anonymously at the collection point inside the Vienna Police Department located at 215 Center Street, South, Vienna, Virginia 22180.

Participants may dispose of medication in its original container or by removing it and disposing of it directly into the collection box. If an original container is used the individual should consider removing any identifying information from the prescription label.

Liquid products should remain sealed in their original container to prevent leakage.

Intravenous solutions, injectables, and syringes will not be accepted due to associated hazards.

Commercial businesses, pharmacies or other medical facilities may not use this as a means to discard expired medications or medical waste.
