

VIENNA POLICE HIGHLIGHTS

INCIDENTS

Suspicious Event 19-003884 100 Block Dogwood Street, SW

Between April 8 at 7:00 a.m. and April 12 at 6:07 p.m.

A resident reported that there have been a couple of occasions when someone as left bags of dog excrement and trash in her yard.

A resident reported she has received packages from Amazon that she never ordered. The person placing the order is using some of the resident's personal information.

Arrest – Drunk In Public 19-003810 Vienna Inn 120 Maple Avenue, East April 11 8:49 p.m.

Officers responded to assist rescue personnel with an injured man in the parking lot. Upon the officers' arrival, they observed another man, the injured man's son, interfering with rescue personnel as they were trying to treat his father. Officers observed signs of impairment with the son, and he became hostile with the officers, refusing to cooperate.

Ofc. Gucwa arrested the 24-year-old man from McKinley Street, NE in Vienna. He was transported to the Fairfax County Adult Detention Center where he was charged with Drunk In Public. Rescue personnel transported his father to an area hospital for treatment.

A citizen was walking on Park Street when she heard a scream from a residence and saw a man inside the home strike a woman. Officers responded to the residence and spoke to a woman who stated she argued with another person in the home, but there was no physical altercation. The woman refused any police assistance.

Officers responded to assist rescue personnel with a resident in need of medical attention. The man was transported to an area hospital for further treatment.

CRASHES

100 Block Glyndon Street, SE 19-003921

April 13 11:30 a.m.

Vehicle-2 was traveling southbound on Glyndon Street. Vehicle-1 was traveling northbound on Glyndon Street. Another vehicle was legally parked in the northbound lane with the driver side door open. Driver-1 attempted to pass the parked vehicle by crossing the double yellow line and proceeding northbound in the southbound lane, striking Vehicle-2 head-on.

Driver-1 was issued a summons charging Passing on a Solid Line.

Vienna Police Department to Participate in the D.E.A. Prescription Drug Take Back Initiative

Saturday, April 27, 2019 from 10:00 a.m. to 2:00 p.m.

In conjunction with the United States Drug Enforcement Administration (D.E.A.) and state and local law enforcement agencies, the Vienna Police Department will again participate in a one-day initiative to remove potentially dangerous controlled substances from area homes.

On April 27, 2019, between the hours of 10:00 a.m. and 2:00 p.m. the Vienna Police Department will have a collection site for old, expired, unused, or unwanted medications. Prescription medications, controlled or non-controlled substances, and over the counter drugs may be turned in anonymously at the collection point inside the Vienna Police Department located at 215 Center Street, South, Vienna, Virginia 22180.

Participants may dispose of medication in its original container or by removing it and disposing of it directly into the collection box. If an original container is used the individual should consider removing any identifying information from the prescription label.

Liquid products should remain sealed in their original container to prevent leakage.

Intravenous solutions, injectables, and syringes will not be accepted due to associated hazards.

Commercial businesses, pharmacies or other medical facilities may not use this as a means to discard expired medications or medical waste.
