

VIENNA POLICE HIGHLIGHTS

INCIDENTS

Forgery 19-003248 900 Block Fairway Drive, NE Between July 7, 2018, at 12:00 p.m. and January 1, 2019, at 12:00 p.m. A resident reported forgery of his signature. The resident intentionally did not sign a page of a rental contract due to an issue he had with the page. He later received a copy of that page where he is signature had been fraudulently added to it.

Fraud 19-003315 400 Block Yeonas Drive, SW Between March 18 at 7:01 p.m. and March 25 at 7:01 p.m. A resident reported that multiple unauthorized charges were made to his credit card.

A resident reported hearing a neighbor, a woman, screaming and throwing objects. The woman refused to speak to police officers and requested the officers leave. The resident called again, later in the afternoon, advising the woman was becoming more agitated. Officers again responded, but the woman refused to speak to them. Mental health workers were notified and suggested the resident go to the magistrate for an Emergency Commitment Order for the woman.

Assist EMS 19-003309 1000 Block Pickett Place, SW March 30 5:30 p.m. Officers responded to assist rescue personnel with a resident who was suffering from an alcohol overdose. The resident was transported to an area hospital for treatment.

Vienna Police Department to Participate in the D.E.A. Prescription Drug Take Back Initiative

Saturday, April 27, 2019 from 10:00 a.m. to 2:00 p.m.

In conjunction with the United States Drug Enforcement Administration (D.E.A.) and state and local law enforcement agencies, the Vienna Police Department will again participate in a one-day initiative to remove potentially dangerous controlled substances from area homes.

On April 27, 2019, between the hours of 10:00 a.m. and 2:00 p.m. the Vienna Police Department will have a collection site for old, expired, unused, or unwanted medications. Prescription medications, controlled or non-controlled substances, and over the counter drugs may be turned in anonymously at the collection point inside the Vienna Police Department located at 215 Center Street, South, Vienna, Virginia 22180.

Participants may dispose of medication in its original container or by removing it and disposing of it directly into the collection box. If an original container is used the individual should consider removing any identifying information from the prescription label.

Liquid products should remain sealed in their original container to prevent leakage.

Intravenous solutions, injectables, and syringes will not be accepted due to associated hazards.

Commercial businesses, pharmacies or other medical facilities may not use this as a means to discard expired medications or medical waste.
