

# VIENNA POLICE HIGHLIGHTS

August 23, 2019

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from August 16 – August 22, 2019. Readers are reminded that an "arrest" is based upon probable cause and does not always mean that someone was physically taken into custody. # **INCIDENTS**

Lost Property 19-008806 Shell Gas Station 252 Maple Avenue, West August 4 between 12:00 p.m. and 2:00 p.m. A citizen advised she lost her wedding rings while she was at the gas station.

Fraud 19-008671 700 Block Hunter Court, SW August 13 between 12:00 p.m. and 10:18 p.m. A resident reported an attempted fraud after applying for a job through an on-line internet offer for an assistant elder care provider.

Ofc. Colligan observed a vehicle commit a traffic offense and initiated a traffic stop. Upon his interaction with the occupants, the officer detected an odor of marijuana. The vehicle was occupied by three juveniles. The officer found a measurable amount of marijuana belonging to the driver and one of the passengers.

The vehicle was towed, and the officer transported the driver to Reston, where she was released to the custody of her mother. Petitions charging Possession of Marijuana are pending.

A resident expressed concern for her husband's welfare. Officers spoke to the husband and determined there was no issue.

A resident called to report that an unknown woman that showed up at his residence requesting permission to enter his home to survey his backyard. The resident refused to give access to his property.

A resident reported her bicycle was missing from her home. A few hours later, an officer located the bicycle behind some bushes in a neighbor's yard.

#### Natural Death 19-008731 100 Block Wilmar Place, NW August 18 6:06 p.m.

Officers responded to assist rescue personnel with a medical emergency after a relative found the elderly resident unresponsive. It was determined that the elderly woman was deceased from natural causes.

PFC Williams observed a driver traveling above the posted speed limit and initiated a traffic stop. The officer found the driver was illegally in possession of alcohol underage and was in possession of a fake identification.

PFC Williams issued two summonses to the driver, a 20-year-old man from Westwood Forest Drive in Vienna charging Possession of Alcohol Underage and Possession of False Identification. The man was released on his signature.

Ofc. Williams observed a vehicle traveling above the posted speed limit and initiated a traffic stop. Upon his interaction with the driver he detected an odor of marijuana. The officer found a measurable amount of marijuana in the vehicle.

Ofc. Williams issued a summons to the driver, a 19-year-old man from Glyngyle Drive in Vienna, charging Possession. The driver was released on his signature.

A caseworker requested an officer to assist in escorting a man back to the hospital who needed additional treatment. Ofc. Gucwa located the man in the area and provided him with the escort.

Accident 19-0008515 Maple Avenue, East / Mashie Road, SE August 13 3:57 p.m.

Vehicle-1 was traveling Eastbound on Maple Avenue, East. The driver of vehicle-1 stated a fox ran into the road. While attempting to avoid the fox driver-1 drove over a curb and struck a tree.

Hit and Run 19-0008625 120 Branch Road, SE August 15 between 6:45 p.m. and 7:15 p.m. Vehicle-1 was parked inside a parking lot. An unkown vehicle struck vehicle-1 and left the scene.

# Accident 19-0008640 Maple Avenue, East / Center Street

August 15 between 6:45 p.m. and 7:15 p.m.

Vehicle-1 and vehicle-2 were traveling westbound on the 100 Block of Maple Avenue, East. As they approached the intersection with Center Street vehicle-2 started to slow down because there was another vehicle ahead. The Driver of vehicle-1 was not paying attention and rear ended vehicle-2.

Driver of vehicle-2 was issued a citation for failure to pay full time and attention.

### Hit and Run 19-0008669 Patrick Street, SE / Desale Street, South August 16 8:00 p.m.

Vehicle-2 was driving westbound on Patrick Street, SE. Vehicle-2 stopped at a stop sign and stated he was rear ended by vehicle-1. Vehicle-1 left the scene. The driver of vehicle-1 was later located and interviewed.

Due to conflicting stories and lack of evidence the officer was unable to determine fault for the accident.

### Accident 19-0008677 127 Center Street, South August 17 6:15 a.m.

Vehicle-1 was driving in the back parking lot of Town Hall. Vehicle-2 was parked inside the lot. Vehicle-1 struck vehicle-2 while backing into a parking space, knocking the license plate bracket off vehicle-2 and scratching vehicle-1.

### Accident 19-0008778 544 Maple Avenue, West August 20 2:03 p.m.

Vehicle-2 was making a left turn from James Madison Drive onto Maple Avenue, West traveling eastbound in the left lane. Vehicle-1 was westbound Maple Avenue, West making a U-Turn at James Madison Drive. Vehicle-1 was unable to complete the U-Turn and backed up stricking vehicle-2 in the right front fender causing property damage.

Driver-1 was issued a citation for improper backing.

### Accident 19-0008818 Nutley Street, SW / Courthouse Road, SW August 21 2:10 p.m.

Vehicle-1 and vehicle-2 were traveling northbound on Nutley Street, SW approaching the intersection with Courthouse Road, SW. Vehicle-1 rear ended vehicle-2 who was stopped at a red traffic signal.

Driver of vehicle-1 was issued a citation for failure to pay full time and attention.

# Accident 19-0008831

# Maple Avenue, East / Follin Lane, SE

## August 21 7:35 p.m.

Vehicle-1 was traveling westbound on Maple Avenue, East when the driver suffer a medical emergency and lost control of the vehicle. Right after vehicle-1 crossed Follin Lane, SE it ran onto the curb on the right side of the road. Vehicle-1 then struck the concrete base of a traffic pole signal, causing it to roll over coming to a rest right side up.

The driver was extricated from the vehicle by the fire department and transported to a hospital with non-life threatening unjuries.

### Accident 19-0008849 515 Maple Avenue, East August 22 1:05 p.m.

Vehicle-1, vehicle-2 and vehicle-3 were traveling westbound on the 500 block of Maple Avenue, NE. Vehicle-2 and vehicle-3 stopped due to heavy traffic. The driver of vehicle-1 stated that he was attempting to stop when his foot slipped from the brake, causing his vehicle to strike the rear of vehicle-2 causing vehicle-2 to rear end vehicle-3.

There were no injuries and damage to the vehicles was minimal.

**Indecent Exposure Suspect Arrested** 

The Vienna Police Department has arrested a 33-year-old Vienna man after several incidents of Indecent Exposure were reported on the W&OD trail. Enoc Isaac Vasquez has been charged with four counts of obscene sexual display which is a charge similar to the Indecent Exposure statute, 18.2-387. The arrest is the result of an investigation that was conducted by the Vienna Police Department's Patrol Division and Criminal Investigations Section.

The charges relate to several reports of a man who was seen exposing himself on the W&OD trail. The first incident was reported on August 2nd and subsequent incidents occurred on August 12, August 13, and August 15 of 2019.

Patrol Officers received a tip from citizens which led CIS detectives to the 200 Block of Park Terrace Court in Vienna. Detectives began surveillance in the area and eventually identified a person of interest. After interviewing numerous witnesses and obtaining corroborating statements from the suspect, police detectives obtained arrest warrants to charge Vasquez. Mr. Vasquez was arrested and transported to the Fairfax County Adult Detention Center where he was released on a \$1,000 unsecured bond.

The Vienna Police Department would like to acknowledge the citizens and witnesses who came forward to provide information about these cases and to thank residents for their patience during this investigation. # Reminder

# **Prevention of Stolen Vehicles/Vehicle Tamperings**

With the advent of warmer weather, the Town of Vienna Police Department would like to remind all Town of Vienna residents to secure their vehicles and personal belongings. Recently there have been several vehicle tamperings to include stolen vehicles from Vienna and the neighboring jurisdictions.

The Vienna Police Department would like to remind citizens of the following steps to assist in the prevention of your vehicle being tampered with or stolen:

## Lock your Car Doors.

The majority of the vehicles being entered and/or stolen have been unlocked.

## **Remove all Valuables.**

In most cases, the subjects responsible for these acts have been targeting vehicles which contain valuables such as, but not limited to, laptop computers, GPS's, pocketbooks/purses, loose change, cameras, etc. If you must leave valuables in your vehicle, please be sure to conceal the items, in the trunk, under the seats or use any other means to make them undetectable. Also, make sure to record all serial numbers, and if possible, engrave them or permanently mark the items with easily identifiable markings, in the event the items are recovered.

## **Remove all Keys.**

The subjects who commit these crimes are aware that most new vehicles come with valet keys. Most of these keys are kept inside the vehicles, either in the center consoles, or the glove compartments or other areas easily accessible. In some instances the owners have left their keys rings containing their house keys, providing access to their homes.

## **Report Suspicious Activity**

In some cases, the subjects have been observed wearing several layers of clothing, not consistent with the weather conditions. This is used to conceal stolen items and also to make identification difficult as they will shed layers of clothing as they flee the area when they suspect they have been observed committing a crime.

The Town of Vienna Police Department is dedicated to the safety and protection of all persons and property in the Town of Vienna. However, much of our success comes from the assistance of its concerned and observant residents.
