

VIENNA POLICE HIGHLIGHTS

Assault 19-001144 Oakton Vienna Animal Hospital 320 Maple Avenue, East

Between December 7 at 4:30 p.m. and January 18 at 4:30 p.m.

A citizen, whose employment was recently terminated from the animal hospital, came to the police station to report that one of the other employees assaulted her on three separate occasions. The citizen was advised of the warrant process should she wish to pursue charges.

On December 7, 2018, Town of Vienna Police Department Detective Steve Simon and Master Police Officer Juan Vazquez graduated from the Leadership in Police Organizations program. The program was held in conjunction with the Fairfax County Criminal Justice Academy.

The Leadership in Police Organizations (LPO) training program is based on a behavioral science approach to leadership. The original course material was developed and taught for many years at the U.S. Military Academy at West Point. The three-week course is the focus on the systematic development of leaders at all levels of an organization. The concept is "every officer is a leader."

The Leadership in Police Organizations program was held at the Fairfax County Criminal Justice Academy in Chantilly, Virginia. The class included personnel from a total of 7 Virginia area law enforcement agencies.

Detective Steve Simon has been a police officer with the Vienna Police Department since 2004 and is currently assigned to the Criminal Investigation Section. MPO Juan Vazquez has been with the Vienna Police Department since 2007 and is currently the Public Information Officer for the Vienna Police Department.

Vienna hires Downey & Scott as police facility project manager

At its January 7 meeting, Vienna Town Council approved a contract with Warrenton-based Downey & Scott, LLC to provide project management services for design, construction, and post-construction of a new police facility. The contract price for project management services is not to exceed \$318,950.

The Town currently is working with Dewberry to design the new police facility, on which construction is expected to begin in 2020. Town Council will consider high-level conceptual layout options at its January 14 work session.

Over the past five years, Downey & Scott, which has 34 years' experience in construction management, has provided services for more than 500 projects in Virginia, including police and public safety facilities to schools.
