



## **VIENNA POLICE HIGHLIGHTS**

**February 22, 2019**

### **INCIDENTS**

#### **Fraud 19-001585**

**900 Block Ware Street, SW**

**February 8 12:00 p.m.**

A resident reported a suspicious transaction on one of her bank accounts.

Officers responded to a residence for a 911 hang-up. A resident advised officers that there were no issues at the home. The officers then spoke to the wife who advised she had called 911 while she and her husband were having a verbal dispute.

Employees requested assistance with two men who were sleeping in the restaurant. Officer Colligan arrested the 39-year-old man with no fixed address. During the arrest, the man began to resist the officers. Officer Colligan transported the man to the Fairfax County Adult Detention Center where he was charged with Trespassing and Obstruction of Justice.

Officers responded to the report of a fight in progress. One of the men was located with a minor injury to his head. The other man involved was located inside the shelter at Vienna Presbyterian Church. Both men gave inconsistent stories and did not wish to press charges. Both men were trespassed from the Church and were advised that they may be arrested if they returned.

### **Vienna hires Downey & Scott as police facility project manager**

At its January 7 meeting, Vienna Town Council approved a contract with Warrenton-based Downey & Scott, LLC to provide project management services for design, construction, and post-construction of a new police facility. The contract price for project management services is not to exceed \$318,950.

The Town currently is working with Dewberry to design the new police facility, on which construction is expected to begin in 2020. Town Council will consider high-level conceptual layout options at its January 14 work session.

Over the past five years, Downey & Scott, which has 34 years' experience in construction management, has provided services for more than 500 projects in Virginia, including police and public safety facilities to schools.
