

# VIENNA POLICE HIGHLIGHTS

## **INCIDENTS**

Suspicious Event 19-006151 400 Block Old Courthouse Road, NE

Between May 1 at 3:00 a.m. and June 13 at 6:00 a.m.

A resident reported that someone has been leaving tacks under her vehicle tires continuously for the past few months.

#### Animal Case 19-006254 100 Block Melody Lane, SW May 28 6:30 p.m.

A resident reported that she was walking her dog when they came across another person who was walking his two dogs. The dogs initially approached each other normally. However, the two dogs began attacking the resident's dog. The resident's dog was injured and was taken to a vet for medical treatment. The incident was the first time the two dogs had ever acted aggressively. The owner is taking measures to ensure there are no further issues with their dogs' behavior.

A resident advertised furniture for sale on the online app, "Offer Up." A buyer agreed to send a check to cover the payment for the furniture and the shipping charges. The resident set up electronic payment for the movers before he realized that the check he received from the buyer was fraudulent.

#### Suspicious Event 19-006207 Park Street, SE June 13 1:16 p.m.

A resident reported a suspicious incident involving his infant son's nanny. The resident observed the incident on his home security camera, and it made him concerned for his son's welfare. The mother of the child immediately responded to the home, and the nanny left without further incident. This case is being investigated.

A resident reported that an unknown man made multiple phone calls to her threatening to charge her a significant amount if she did not renew her computer anti-virus software.

#### Arrest – Narcotics Violation 19-006223 400 Block Old Courthouse Road, NE June 13 8:52 p.m.

Sgt. Elias observed a vehicle traveling above the posted speed limit and initiated a traffic stop. Upon his interaction with the driver, the officer detected an odor of marijuana. Both the driver and the passenger were found to have marijuana and drug paraphernalia.

Sgt. Elias issued summonses to the 19-year-old man from Weller Avenue in McLean, Virginia and the 19-year-old man from Leonard Road in Falls Church, Virginia charging Possession of Marijuana and released them on their signatures.

An argument escalated into a physical altercation between two men in the parking lot. One of the men shoved the other, causing him to fall and strike his head. The man suffered a minor laceration to his head but refused medical treatment. Both men refused to prosecute.

Ofc. Colligan observed a man walking in the area of the Wolftrap Hotel. Upon his interaction with the man, the officer found he was wanted by Manassas City Police Department on an outstanding capias. The man was also found to be in possession of marijuana.

Ofc. Colligan arrested the 28-year-old man from June Street in Springfield, Virginia. He was transported to the Fairfax County Adult Detention Center. The capias charging Failure to Obey a Court Order on Disorderly Conduct was served and he was charged with Possession of Marijuana.

The property manager for the shopping center reported that the owner's of Silva's Patisserie moved out of their rented space, breaking their lease. A resident was checking on her new home that is under construction when she found a woman walking around inside the house. # **Prevention of Stolen Vehicles/Vehicle Tamperings**

With the advent of warmer weather, the Town of Vienna Police Department would like to remind all Town of Vienna residents to secure their vehicles and personal belongings. Recently there have been several vehicle tamperings to include stolen vehicles from Vienna and the neighboring jurisdictions.

The Vienna Police Department would like to remind citizens of the following steps to assist in the prevention of your vehicle being tampered with or stolen:

## Lock your Car Doors.

The majority of the vehicles being entered and/or stolen have been unlocked.

## **Remove all Valuables.**

In most cases, the subjects responsible for these acts have been targeting vehicles which contain valuables such as, but not limited to, laptop computers, GPS's, pocketbooks/purses, loose change, cameras, etc. If you must leave valuables in your vehicle, please be sure to conceal the items, in the trunk, under the seats or use any other means to make them undetectable. Also, make sure to record all serial numbers, and if possible, engrave them or permanently mark the items with easily identifiable markings, in the event the items are recovered.

## **Remove all Keys.**

The subjects who commit these crimes are aware that most new vehicles come with valet keys. Most of these keys are kept inside the vehicles, either in the center consoles, or the glove compartments or other areas easily accessible. In some instances the owners have left their keys rings containing their house keys, providing access to their homes.

## **Report Suspicious Activity**

In some cases, the subjects have been observed wearing several layers of clothing, not consistent with the weather conditions. This is used to conceal stolen items and also to make identification difficult as they will shed layers of clothing as they flee the area when they suspect they have been observed committing a crime.

The Town of Vienna Police Department is dedicated to the safety and protection of all persons and property in the Town of Vienna. However, much of our success comes from the assistance of its concerned and observant residents.
