

## **VIENNA POLICE HIGHLIGHTS**

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from

March 1, 2019 – March 7, 2019. Readers are reminded that an "arrest" is based upon probable cause and does not always mean that someone was physically taken into custody. ### <u>INCIDENTS</u>

Grand Larceny 19-002351 Brooke Rental 321 Mill Street, NE

#### Between January 28 at 1:13 p.m. and March 6 at 12:00 p.m.

An employee reported that a customer had not returned property that they had rented in January. On March 6 the employee notified the investigating officer that the customer returned the property and no further police assistance was required.

#### Civil 19-002200 Al Nakheel 340 Maple Avenue, West February 16 12:00 p.m.

The business owner reported a former employee had taken several thousand dollars. Arrangements had been made for the former employee to pay the money back. However, no payments had yet been made.

#### Fraud 19-002139 300 Block Tapawingo Road, SW Between February 25 at 12:01 a.m. and February 27 at 11:59 p.m.

A resident reported that an unknown person used his personal information on numerous applications for various accounts and credit cards.

An employee reported that a man and woman entered the store, concealed cases of Oil of Olay and left the store without paying for the merchandise.

#### Threats 19-002180 Cedar Lane School 101 Cedar Lane, SW February 28 1:00 p.m.

A school administrator reported that a student became disorderly in class and was sent to the principal's office. As the teacher was escorting the student to the office, he began making verbal threats toward the teacher. The school administration will handle the disciplinary action.

#### Shoplifting 19-002220 Giant Food 359 Maple Avenue, East February 28 4:28 p.m.

An employee reported that an unknown woman concealed several cans of crab meat and left the store without paying for it.

#### Arrest – Driving While Intoxicated and Accident with Injury 19-002168 200 Block Cedar Lane, SE February 28 11:47 p.m.

Officers and rescue personnel responded to the report of an accident in the parking lot of the Cedar Lane Apartments. The driver of the vehicle struck a legally parked, unoccupied vehicle at a high rate of speed, causing his vehicle to overturn. The driver, the only occupant in the vehicle, was injured in the accident. Upon MPO Borja's interaction with the driver she detected signs of impairment. The driver was transported by rescue personnel to an area hospital for treatment of his injuries.

At the hospital, MPO Borja issued a summons to the driver, a 22-year-old man from Galvez Street from Silver Spring, Maryland charging Driving While Intoxicated.

#### Arrest – Driving on Revoked License 19-002191 400 Block Maple Avenue, West March 1 5:26 p.m.

Ofc. Nesbitt observed a driver commit a traffic offense and initiated a traffic stop. The officer found the driver's license had been revoked in Virginia.

Ofc. Nesbitt arrested the 27-year-old man from Barbara Lynn Place in Herndon, Virginia. He was transported to the Fairfax County Adult Detention Center where he was charged with Driving on a Revoked License.

A resident brought his teenage son to the police station to speak to an officer for advice in handling domestic dispute issues.

Officers responded to the report of an open door at the snack bar at Glyndon Park. The door appeared to have been damaged as a result of forced entry into the snack bar.

An employee requested assistance with two women who were refusing to leave the hotel. The women were trespassed from the property and were advised that they may be charged with trespass if they return.

#### **Domestic Dispute 19-002257**

#### Upham Place, NW March 3 2:50 p.m.

A resident reported a domestic dispute between family members. The dispute escalated to a mutual physical altercation between two adult sisters. The mother and one of the sisters left the residence, and no further police assistance was needed.

#### Juvenile Case 19-002299 200 Block Cedar Lane, SE March 5 10:56 a.m.

Officers confirmed that a teenage juvenile resident, who was reported as missing to Loudoun County authorities on Saturday, had returned home safely.

#### Civil Case 19-002304 1400 Block Cottage Street, SW March 5 1:30 p.m.

A landlord requested a welfare check on her tenant, concerned that she may need medical assistance. The landlord advised she had not been able to contact the tenant for over a week. When she went to the house to check on her she found that the tenant had changed the locks on the doors and mail was overflowing from the mailbox. Officers searched the residence finding a woman who was subleasing the house from the tenant without the landlord's knowledge. The landlord was referred to the Sheriff's Department for information on the eviction process.

#### Arrest – Fraud 19-002307 700 Block Ninovan Road, SE March 5 3:00 p.m.

A resident reported that someone used one of his credit accounts to make unauthorized purchases. The purchases were being delivered to the resident, who advised the delivery man he had not placed the order. Police detectives used the phone number on the invoice to arrange for the suspect to pick up the fraudulently purchased property in the rear lot of a shopping center.

When the man arrived at the shopping center, he was placed under arrest. Ofc. Gucwa transported the 22year-old man from Muirkirk Road in Laurel, Maryland to the Fairfax County Adult Detention Center where he was charged with Credit Card Fraud and Credit Card Larceny

A resident advised his dog began digging in a pile of leaves in his backyard and uncovered three purses. The owner appears to be a neighbor.

Officers responded to the report of a juvenile who had made threats in class after becoming upset over a disciplinary action. Officers and school administrators spoke to the student and his parent regarding the seriousness of his statement. The student advised he was upset when he made the statement and never intended to act on the threat.

Ofc. Colligan observed a driver commit a traffic offense and initiated a traffic stop. Upon his interaction with the driver, the officer detected the odor of marijuana. The driver was found the be in possession of a measurable amount of marijuana.

Ofc. Colligan issued a summons charging Possession of Marijuana to the 20-year-old woman from Tysons Landing Court in McLean, Virginia. The woman was released on her signature.

#### Arrest – Drunk In Public 19-002364 Tapawingo Road and Ware Street, SW March 7 2:33 a.m.

Officers responded to the report of a suspicious person sitting on the sidewalk. Upon the officers' interaction with the woman, they detected signs of impairment.

Ofc. Farr arrested the 25-year-old woman from Renwick Court in Burke, Virginia. She was transported to the Fairfax County Adult Detention Center where she was charged with Drunk In Public.

### <u>CRASHES</u>

#### Park Street and Maple Avenue, SE 19-002118

#### February 28 7:40 a.m.

Two vehicles were northbound in the left turn lane on Park Street, SE. Vehicle-2 stopped for the yellow traffic light at Maple Avenue. Vehicle-1 was unable to stop in time and struck the rear of Vehicle-2.

Driver-1 was issued a summons charging Following Too Closely.

#### Branch Road and Maple Avenue, SE 19-002138

#### February 28 1:30 p.m.

Vehicle-2 was southbound on Branch Road, stopped at the red traffic light to turn right onto Maple Avenue. Vehicle-1 sideswiped the left rear corner of Vehicle-2, causing minor damage, as Driver-1 went around the vehicle and proceeded onto Maple Avenue. Driver-1 left the scene without providing their information. Driver-1 was located and advised he was not aware that he had struck Vehicle-2 and provided his information.

#### 300 Block Maple Avenue, East 19-002145 February 28 7:12 p.m.

Three vehicles were traveling westbound in the left lane of Maple Avenue. Vehicle-3 slowed to move into the center turn lane. Vehicle-2 was behind Vehicle-3 and also slowed. Vehicle-1 struck the rear of Vehicle-2, pushing it into the rear of Vehicle-3.

#### 300 Block Patrick Street, SW 19-002258

#### March 3 3:13 p.m.

Vehicle-2 was legally parked on the road when it was struck by Vehicle-1 (an unknown vehicle). Driver-1 fled the scene without stopping to provide their information.

#### 200 Block Berry Street, SE 19-002261

#### March 3 9:06 p.m.

Vehicle-1 was turning from Pine Street onto Berry Street. Driver-1 cut the corner short and became stuck in the grass shoulder. A tow truck was used to pull the vehicle back onto the road.

#### Cottage Street and Battle Street, SW 19-002283 March 4 5:58 p.m.

Vehicle-1 was eastbound on Battle Street at the stop sign for Cottage Street. As the driver proceeded into the intersection, they were struck by Vehicle-2, which was northbound on Cottage Street.

Driver-1 was issued a summons charging Failure to Pay Full Time and Attention.

#### Beulah Road and Ayr Hill Avenue, NE 19-002298

#### March 5 9:45 a.m.

Vehicle-2 was traveling northbound on Beulah Road approaching Ayr Hill Avenue. Vehicle-1 was traveling eastbound on Ayr Hill Avenue, failed to yield the right of way, and collided with Vehicle-2.

Driver-1 was issued a summons charging Failure to Pay Full Time and Attention.

#### 203 Maple Avenue, West 19-002305 March 5 1:54 p.m.

A driver was attempting to park in the parking lot, accidentally accelerated and drove into the side of the building.
