

# VIENNA POLICE HIGHLIGHTS

May 10, 2019

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from May 3, 2019 – May 9, 2019. Readers are reminded that an "arrest" is based upon probable cause and does not always mean that someone was physically taken into custody. # **INCIDENTS**

Civil Dispute 19-004592 IGS Diamonds 444 Maple Avenue, East

#### Between April 10 at 7:00 a.m. and April 18 at 7:00 p.m.

A citizen advised that she sent a ring to IGS Diamonds to appraise and possibly sell for her. An employee appraised the ring at an amount that was lower than a previous appraisal she had received. The citizen requested the ring be returned. The employee sent a photo of the ring before returning it. The citizen stated that the ring had been changed when she received it back. She stated the prongs were now bent and the diamonds were different. The employee showed the officer a photo of the ring that the owner sent before sending the ring to their business and the photos taken by the employee before returning the ring. Both photos showed the ring in the same condition. Both parties were advised this was a civil matter.

An officer was driving northbound on Nutley Street when his vehicle was struck multiple times with a green laser pointer. A Fairfax County Police Officer also advised his vehicles had been struck by the laser pointer that night. A similar incident happened to another officer a few weeks before this incident.

PFC Williams transported the 36-year-old woman from Meadowland Court in Chantilly, Virginia to the Fairfax County Adult Detention Center where she was charged with Driving While Intoxicated.

# **CRASHES**

James Drive near Kelly Street, SW 19-004610

Vehicle-1 was traveling eastbound on James Drive when the driver drifted to the right and struck Vehicle-2 and Vehicle-3 which were both legally parked.

Driver-1 was issued a summons charging Failure to Maintain Control.

Arrest – Driving While Intoxicated / Accident 19-004657 Nutley Street and Marshall Road, SW May 4 5:45 p.m.

Two vehicles were traveling northbound on Nutley Street. Vehicle-1 was in the left lane; Vehicle-2 was in the right lane. Driver-1 swerved to the right and sideswiped Vehicle-2. After the collision, Driver-1 overcorrected to the left, jumped the curb, drove over the median and struck the "Town of Vienna" sign. Upon Ofc. Murray's interaction with Driver-1 he detected signs of impairment. Driver-1 failed to complete a series of sobriety tests successfully and was placed under arrest. Driver-1 was transported to the Vienna Police Station where he provided a sample of his breath for analysis.

Ofc. Murray transported the driver, a 22-year-old man from Jermyn Lane in Virginia Beach, Virginia to the Fairfax County Adult Detention Center where he was charged with Driving While Intoxicated.

A driver left her vehicle legally parked in the parking lot while she was shopping. When she returned, she found another vehicle had struck her vehicle and fled without providing their information.
