

## VIENNA POLICE HIGHLIGHTS

May 24, 2019

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from May 17, 2019 – May 23, 2019. Readers are reminded that an "arrest" is based upon probable cause and does not always mean that someone was physically taken into custody. Furthermore, it does not mean that an individual is automatically guilty of a crime. Judicial outcomes and post-arrest proceedings can be researched through the appropriate court's website.

### **INCIDENTS**

A resident reported an individual going through parked vehicles. Officers located a juvenile in the area and found he had property that did not belong to him, including a wallet, credit cards, a bottle full of change and a bottle of cologne.

MPO Shaw placed the 16-year-old juvenile under arrest. The juvenile was transported to the Fairfax County Juvenile Detention Center where he was charged with three counts of Credit Card Theft, two counts of Vehicle Tampering, Petit Larceny and Drunk In Public. The juvenile was so combative with the officer and with the staff at the detention center that he was unable to be medically cleared and was transported to Fairfax Hospital for medical evaluation. The juvenile's parent was notified, and, after the medical evaluation, he was returned to the Juvenile Detention Center and left in their custody.

A citizen reported that she parked her vehicle along the grassy area of Southside Park. She left her purse on the passenger seat and locked the vehicle.
