

VIENNA POLICE HIGHLIGHTS

October 4, 2019

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from September 27 – October 3, 2019. Readers are reminded that an "arrest" is based upon probable cause and does not always mean that someone was physically taken into custody. Furthermore, it does not mean that an individual is automatically guilty of a crime. Judicial outcomes and post-arrest proceedings can be researched through the appropriate court's website.

Fraud 19-010277

Between March 25 at 12:00 p.m. and September 10 at 12:00 p.m.

A resident reported that an unknown person used two of her credit accounts to make unauthorized purchases.

An employee reported US currency missing from a cashbox in the office of the restaurant.

A resident observed two juveniles in a black Mercedes SUV smoking from a drug paraphernalia device.

A teenage juvenile ran from her mother at the Vienna Dog Park, 700 Courthouse Road, SW. The juvenile went to Meadow Lane Park and requested to speak to an officer. The juvenile is in treatment for emotional issues. The juvenile agreed to go home with her mother. A short time later, the juvenile called the police from the Walgreens, 225 Maple Avenue, West. The juvenile advised that while she and her mother were on their way home, she exited the vehicle at a stoplight. The mother responded to the Walgreens to pick up her daughter.

Officers responded to assist rescue personnel with a medical emergency after a relative found the elderly resident unresponsive. It was determined that the elderly woman was deceased from natural causes.

Cottage Street and Moore Avenue, SW

Between September 27 at 8:00 p.m. and September 28 at 6:58 a.m.

A citizen reported a moped lying in the roadway close to the curb. Officers contacted the owner who advised they had parked the moped in their driveway in the 100 block Moore Avenue, SW and were unaware the vehicle had been moved.

Petit Larceny 19-010105 Subway 222 Maple Avenue, West September 27 9:20 p.m.

On September 28, the manager reported that on the previous day, three men entered the restaurant, distracted the employee, and took US currency.

Animal Case 19-010082 700 Block Nutley Street, SW September 27 9:22 p.m.

A resident reported an injured deer that had fallen into the drainage ditch in his yard. It appeared the deer had been struck by a vehicle and was gravely injured. Due to the extent of injury, an officer euthanized the deer.

Arrest – Assault 19-010089 100 Block Wilmar Place, NW September 28 2:28 a.m.

A resident reported that her adult son was intoxicated and acting irate. The son fled the home before officers arrived. Officers searched the area for the man but were unable to locate him.

At 4:17 a.m., officers responded to the area of Cottage Street and Plum Street for the report of a man lying in the roadway. Officers found the man in the 700 block of Cottage Street, crouched behind a vehicle and acting very agitated. Upon the officers' interaction with the man, they detected signs of impairment. The man was acting both belligerent and combative with the officers. As officers were placing the man under arrest, he assaulted one of them.

Ofc. Colligan arrested the 30-year-old man from Wilmar Place, NW, Vienna, and transported him to the Fairfax County Adult Detention Center, where he was charged with Assault on a Police Officer and Drunk In Public and held without bond.

Arrest – Destruction of Property 19-010134 Vienna Police Station 215 Center Street, South September 28 between 3:31 a.m. and 3:40 a.m.

An officer was leaving work when he found that his personal vehicle had been damaged. It was determined that the same man officers had arrested during their shift, had entered the police station parking lot during the night, and vandalized the officer's personal vehicle (*Incident 19-010089*).

On September 30, Ofc. Colligan obtained a felony warrant for the 30-year-old man charging Destruction of Property. The warrant was served on the man at the Fairfax County Adult Detention Center, where he was still being held on the previous charges.

Officers responded to the complaint of a customer who was acting disorderly and refusing to leave the restaurant. An employee advised the man in front of the officers to leave the establishment; however, he still refused and became uncooperative with the officers.

Sgt. Sheeran arrested the 60-year-old man from Park Street, NE, in Vienna. The man was transported to the Fairfax County Adult Detention Center, where he was charged with Trespassing and Drunk In Public. A Vienna Inn employee advised the man that he was not permitted to return to the property.

An employee requested assistance with a solicitor. Officers located a man who was standing in the parking lot median with his son while playing the accordion. The man had a sign posted requesting donations. The employee had spoken to the man earlier in the week and advised him he could play his accordion only if he stayed on the sidewalk. Several customers began complaining, advising they were in fear he may get struck by a vehicle in the parking lot. After officers spoke to the man, he agreed to leave and not return to the property.

A resident reported that earlier in the day, she and her husband had a verbal dispute that escalated when her husband assaulted her. The two had another physical altercation that night, prompting the resident to call the police.

Ofc. Farr arrested the 55-year-old man from Carole Court, SE. He was transported to the Fairfax County Adult Detention Center, where he was charged with Domestic Assault and released on an unsecured bond.

A juvenile advertised items of clothing for sale through an online application. The juvenile was meeting a buyer at the backside of the shopping center for the sales transaction. CRASHES

Nutley Street and Roland Street, SW 19-010020 September 26 5:35 p.m.

Vehicle-1 was traveling southbound on Nutley Street, attempting to turn left onto Roland Street. Northbound vehicles in the left lane were stopped due to heavy traffic. Vehicle-2 was traveling northbound in the right lane on Nutley Street and struck Vehicle-1 as he entered the intersection.

Vehicle-2, a construction truck, was backing out of the intersection with a loaded bucket of materials. Driver-1 was directed into the intersection by an employee directing traffic when her vehicle was struck by Vehicle-2.

Vehicle-2, Vehicle-3, and Vehicle-4 were in the left northbound lane of Nutley Street, stopped for the red traffic light at Courthouse Road. Vehicle-1 was traveling northbound in the same lane of traffic when Driver-1 suffered a medical emergency, causing him to strike the rear of Vehicle-2, sending it into the rear of Vehicle-3, which then struck the rear of Vehicle-4. Rescue personnel transported Driver-1 to an area hospital for treatment. The airbags in Vehicle-2 deployed. A passenger in Vehicle-2 suffered non-life-threatening injuries.

Park Street and Moore Avenue, SE 19-010133 September 29 6:26 p.m.

Two vehicles were traveling southbound on Park Street, approaching the stop sign at Moore Avenue. Vehicle-2 stopped at the sign. Vehicle-1 ran into the rear of Vehicle-2.

Driver-1 was issued a summons charging Failure to Pay Full Time and Attention.

Vehicle-2 was legally parked on the roadway when it was struck by Vehicle-1 (an unknown vehicle). Driver-1 fled the scene without providing their information.

Reminder

Prevention of Stolen Vehicles/Vehicle Tamperings

With the advent of warmer weather, the Town of Vienna Police Department would like to remind all Town of Vienna residents to secure their vehicles and personal belongings. Recently there have been several vehicle tamperings to include stolen vehicles from Vienna and the neighboring jurisdictions.

The Vienna Police Department would like to remind citizens of the following steps to assist in the prevention of your vehicle being tampered with or stolen:

Lock your Car Doors.

The majority of the vehicles being entered and/or stolen have been unlocked.

Remove all Valuables.

In most cases, the subjects responsible for these acts have been targeting vehicles which contain valuables such as, but not limited to, laptop computers, GPS's, pocketbooks/purses, loose change, cameras, etc. If you must leave valuables in your vehicle, please be sure to conceal the items, in the trunk, under the seats or use any other means to make them undetectable. Also, make sure to record all serial numbers, and if possible, engrave them or permanently mark the items with easily identifiable markings, in the event the items are recovered.

Remove all Keys.

The subjects who commit these crimes are aware that most new vehicles come with valet keys. Most of these keys are kept inside the vehicles, either in the center consoles, or the glove compartments or other areas easily accessible. In some instances the owners have left their keys rings containing their house keys, providing access to their homes.

Report Suspicious Activity

In some cases, the subjects have been observed wearing several layers of clothing, not consistent with the weather conditions. This is used to conceal stolen items and also to make identification difficult as they will shed layers of clothing as they flee the area when they suspect they have been observed committing a crime.

The Town of Vienna Police Department is dedicated to the safety and protection of all persons and property in the Town of Vienna. However, much of our success comes from the assistance of its concerned and observant residents.
