INCIDENTS

Fraud 19-009339 500 Block Windover Avenue, NW May 17, 2014 11:00 a.m.

A resident reported a fraud in 2014 when an unknown person opened a credit account using her personal information and accumulated a large amount of debt on the account. The incident was investigated at that time, and the resident's debt was dismissed by the credit card company as it was a case of fraud. The resident has now received a garnishment summons regarding the previously dismissed case, and her bank account funds have been frozen

A resident reported that she and her 3-year-old son were visiting a friend in Catlett, Virginia, when the friend's dog bit her son. ACO Barker notified the Fauquier County Animal Control who is handling the 10-quarantine on the dog.

She was then transported to the Fairfax County Adult Detention Center where she was charged with Driving While Intoxicated.

Officers responded to the report of an assault between a resident and her niece. The incident occurred as a result of a missing necklace that the niece believed was taken by her aunt. Both women claimed they were assaulted by the other.

Officers advised the women of the warrant process should they wish to pursue charges against each other.

Vehicle-1 was left legally parked in the parking lot when it was struck by an unknown vehicle.

Courthouse Road, SW near Maple Avenue, West 19-009305 September 6 10:30 a.m.

Vehicle-2 was traveling northbound on Courthouse Road approaching Maple Avenue. Vehicle-1 was traveling southbound on Courthouse Road, attempting to turn left into the shopping center. Driver-1 turned in front of Vehicle-2, causing Vehicle-2 to strike the right front quarter panel of Vehicle-1.

Driver-1 was issued a summons charging Failure to Yield Right of Way.

Maple Avenue near Niblick Drive, SE 19-009521 September 12 9:41 a.m.

Two vehicles were traveling eastbound on Maple Avenue in adjacent lanes. Due to construction, one lane was closed. Vehicle-1 was traveling in the closed lane and improperly changed lanes and struck Vehicle-2. Driver-1 initially fled the scene, but later responded to the police station for the accident report.

Driver-1 was issued a summons charging Failure to Pay Full Time and Attention.

Reminder

Prevention of Stolen Vehicles/Vehicle Tamperings

With the advent of warmer weather, the Town of Vienna Police Department would like to remind all Town of Vienna residents to secure their vehicles and personal belongings. Recently there have been several vehicle tamperings to include stolen vehicles from Vienna and the neighboring jurisdictions.

The Vienna Police Department would like to remind citizens of the following steps to assist in the prevention of your vehicle being tampered with or stolen:

Lock your Car Doors.

The majority of the vehicles being entered and/or stolen have been unlocked.

Remove all Valuables.

In most cases, the subjects responsible for these acts have been targeting vehicles which contain valuables such as, but not limited to, laptop computers, GPS's, pocketbooks/purses, loose change, cameras, etc. If you must leave valuables in your vehicle, please be sure to conceal the items, in the trunk, under the seats or use any other means to make them undetectable. Also, make sure to record all serial numbers, and if possible, engrave them or permanently mark the items with easily identifiable markings, in the event the items are recovered.

Remove all Keys.

The subjects who commit these crimes are aware that most new vehicles come with valet keys. Most of these keys are kept inside the vehicles, either in the center consoles, or the glove compartments or other areas easily accessible. In some instances the owners have left their keys rings containing their house keys, providing access to their homes.

Report Suspicious Activity

In some cases, the subjects have been observed wearing several layers of clothing, not consistent with the weather conditions. This is used to conceal stolen items and also to make identification difficult as they will shed layers of clothing as they flee the area when they suspect they have been observed committing a crime.

The Town of Vienna Police Department is dedicated to the safety and protection of all persons and property in the Town of Vienna. However, much of our success comes from the assistance of its concerned and observant residents.

**A reminder to secure your vehicles and remove all valuables! ** Even if your vehicle is parked in your driveway, please secure all windows and doors and remove all valuables.
