

VIENNA POLICE HIGHLIGHTS

September 27, 2019

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from September 20 – September 26, 2019. Readers are reminded that an "arrest" is based upon probable cause and does not always mean that someone was physically taken into custody. Furthermore, it does not mean that an individual is automatically guilty of a crime. Judicial outcomes and post-arrest proceedings can be researched through the appropriate court's website.

INCIDENTS

Civil Dispute 19-009986 200 Block Park Terrace Court, SE

Between August 1 at 12:00 p.m. and September 24 at 8:00 p.m.

A resident reported an on-going civil dispute she is having with her neighbor.

Stalking 19-009941

100 Block East Street, NE

Between August 20 at 12:00 p.m. and September 24 at 7:27 p.m.

A resident hired a man she had recently met to do some work around her house. The two had an argument regarding payment, and the man left the house in a disorderly manner. Over the past several weeks, the man has continued to harass the resident through text messages and other means of intimidation.

A resident posted an add on Craigslist for a motorcycle that he was selling. A woman replied to the add by email stating she wished to purchase the motorcycle. The woman mailed a check to the resident. The resident was advised by the bank that the check was fraudulent.

September 21 2:34 a.m.

PFC Williams observed a vehicle back into an unoccupied parked vehicle in the 7-11 parking lot. Upon the officer's interaction with the driver, he detected an odor of alcohol and observed signs of impairment.

PFC Williams arrested the 29-year-old man from Limb Tree Lane in Vienna. He was transported to the Fairfax County Adult Detention Center where he was charged with Driving While Intoxicated.

September 22 between 12:00 p.m. and 12:30 p.m.

A resident reported that she received a phone call advising that her iCloud account had possibly been compromised. During the phone call, she was transferred to a technician who informed the resident that she would need to make a payment in gift cards to safeguard her computer and banking information. The man also attempted to obtain her banking account numbers. The resident provided them with the gift cards but did not release any personal banking information.

A citizen parked his bicycle outside of the Exxon while he ran in to make a purchase. When he returned, he found his bicycle had been taken.

Juvenile Case 19-009910 Cedar Lane School 101 Cedar Lane, SW September 23 12:38 p.m.

School administration reported that a 17-year-old student came to school under the influence of marijuana. The student became involved in a verbal dispute with another student, and the administration believed the dispute might escalate to a physical altercation. When officers arrived at the school, the students were separated, and the 17-year-old had calmed down and was with the school security officer. The administration advised they would handle the incident and no further police assistance was needed.

Suspicious Event 19-009913 Navy Federal Credit Union 820 Follin Lane, SE September 23 1:13 p.m.

Officers responded to the report of a suspicious package that employees at the credit union received the in the mail. The package was placed in a safe area, and the Fairfax County Police Bomb Squad responded to examine the package. The Bomb Squad determined the package was not a threat and only contained bank statements that a citizen was returning to the credit union.

Arrest – Domestic Assault 19-009918

Officers responded to the report of a domestic assault in progress. A 17-year-old juvenile returned home upset after an incident at school earlier in the day. The juvenile pushed his mother and began yelling and throwing things. The juvenile continued to act out when the officers arrived. PFC Post arrested the juvenile and transported him to the Fairfax County Juvenile Detention Center where a petition was issued charging Domestic Assault.

An unknown person forced entry into two of the residents' property lockers in the basement of the condominiums. Tools were taken from one of the lockers.

A resident advised that he watched as his juvenile son walked to the bus stop. The resident observed a woman in a vehicle approach his son and ask him if he needed a ride. The juvenile declined the ride, and the woman drove off, stopping her vehicle near the intersection of MacArthur and McKinley. The resident immediately called his son to question the interaction. The resident then searched the area but was unable to locate the woman or her vehicle.

An officer observed a vehicle with defective equipment and initiated a traffic stop. Upon the officer's interaction with the driver, he detected an odor of marijuana. An immeasurable amount of marijuana was found in the vehicle.

Arrest – Drunk In Public 19-010007 Vienna Drug Center 150 Maple Avenue, West

Officers observed a woman in the parking lot who showed signs of impairment. Upon their interaction with the woman, the officers determined she was impaired and placed her under arrest.

Ofc. Wallace transported the 55-year-old woman from Manvell Road, SE, Vienna to the Fairfax County Adult Detention Center where she was charged with Drunk In Public.

Arrest – Assault 19-010040 400 Block Kingsley Road, SW September 26 9:54 p.m.

Officers responded to the report of a man who had assaulted a woman. The woman advised that she and the man had just returned to the residence when they began arguing. During the argument, the woman felt threatened and attempted to call the police. The man took her phone and threw it to the ground. The man then began assaulting the woman, causing visible injury. Rescue personnel responded and treated the woman.

During the investigation, the man became loud and aggressive with officers and was placed under arrest. Once in the cruiser, the man continued to act aggressively. The man began complaining of chest pain, and rescue personnel were summoned to evaluate him. Rescue personnel transported him to an area hospital where he was medically cleared. Ofc. Murray then transported the 60-year-old man from Kingsley Road, SW to the Fairfax County Adult Detention Center. The man was charged with felony Strangulation, and misdemeanor charges of Assault, Preventing a 911 Call, Obstruction of Justice and Drunk In Public. The man was held without bond.

CRASHES

300 Block Maple Avenue, East 19-009909

September 23 11:23 a.m.

Vehicle-2 was stopped in the center turn lane waiting to merge into traffic. Vehicle-1 was exiting the parking lot of 315 Maple Avenue to turn left onto westbound on Maple. Driver-1 oversteered the vehicle and struck the rear left side of Vehicle-2.

100 Block Church Street, NE 19-009935 September 24 3:00 p.m.

Vehicle-2, a bicyclist, was traveling eastbound on Church Street. Vehicle-1 was exiting the parking lot at 115 Church Street, NE. and struck Vehicle-2. Rescue responded and treated Driver-2. Driver-2 refused transport to the hospital.

Two vehicles were traveling northbound on Nutley Street. Vehicle-2 slowed for traffic near the intersection of Nutley and Orchard. Vehicle-1 ran into the rear of Vehicle-2, causing minor damage.

Lawyers Road and Malcolm Road, NW 19-009983 September 25 3:05 p.m.

Two vehicles were stopped on southbound Lawyers Road at the stop sign with Malcolm Road. Vehicle-1 began to move forward and struck the rear of Vehicle-2.

Reminder

Prevention of Stolen Vehicles/Vehicle Tamperings

With the advent of warmer weather, the Town of Vienna Police Department would like to remind all Town of Vienna residents to secure their vehicles and personal belongings. Recently there have been several vehicle tamperings to include stolen vehicles from Vienna and the neighboring jurisdictions.

The Vienna Police Department would like to remind citizens of the following steps to assist in the prevention of your vehicle being tampered with or stolen:

Lock your Car Doors.

The majority of the vehicles being entered and/or stolen have been unlocked.

Remove all Valuables.

In most cases, the subjects responsible for these acts have been targeting vehicles which contain valuables such as, but not limited to, laptop computers, GPS's, pocketbooks/purses, loose change, cameras, etc. If you must leave valuables in your vehicle, please be sure to conceal the items, in the trunk, under the seats or use any other means to make them undetectable. Also, make sure to record all serial numbers, and if possible, engrave them or permanently mark the items with easily identifiable markings, in the event the items are recovered.

Remove all Keys.

The subjects who commit these crimes are aware that most new vehicles come with valet keys. Most of these keys are kept inside the vehicles, either in the center consoles, or the glove compartments or other areas easily accessible. In some instances the owners have left their keys rings containing their house keys, providing access to their homes.

Report Suspicious Activity

In some cases, the subjects have been observed wearing several layers of clothing, not consistent with the weather conditions. This is used to conceal stolen items and also to make identification difficult as they will shed layers of clothing as they flee the area when they suspect they have been observed committing a crime.

The Town of Vienna Police Department is dedicated to the safety and protection of all persons and property in the Town of Vienna. However, much of our success comes from the assistance of its concerned and observant residents.
