Parks & Recreation Photography Contest



A photography contest, sponsored by the Department of Parks and Recreation, will be held at the Community Center on Saturday, April 8, from 10 a.m. to 4 p.m.

The contest is open to amateurs only. Professionals (those earning half of their income in photography) may enter for exhibit only. Entries are limited to four photographs per person, and previous winning photos may not be reentered. The entry dates are April 6 from 6 to 8 p.m. and April 7 from noon to 5 p.m. The entry fee is \$3 per person.

There will be two divisions: black and white, and color. The categories in each division are informal portraits, animal, action, children, scenic, still life and category "X" (open). Entries will be judged by local professional photographers, and first, second and third place ribbons will be awarded in each category.

All photos must be mounted and ready for hanging. For the protection of your photos, be sure the wire for hanging is very secure. The back of all photos must be labeled with name, address, phone number and category. Photo size may range from 5" X 5" to 16" X 20". Photos must be picked up between 4 and 6 p.m. April 8.

Jaycees' Walk for Mankind

The Vienna Jaycees will hold their eighth annual Walk for Mankind on Sunday, April 23. The largest share of the proceeds from the event will go to support Project Concern, an international program of medical assistance for underprivileged people. The remaining funds will be channeled into community projects such as a brace fund at Fairfax Hospital.

Bike Rodeo at Madison

The James Madison High School Safety Council is holding a free bicycle rodeo for the entire Northern Virginia community on Saturday, April 1, from 10 a.m. to 5 p.m. on the school grounds. The purpose of the rodeo is to increase knowledge of bicycle safety.

There will be three main areas of competition: a bicycle inspection, skills test and written test. Participants will be judged on a point basis in three age groups: 6 to 8, 9 to 11 and 12 to 16. Awards will be presented in each age group, including trophies, savings bonds, ribbons, gift certificates and bike accessories. Awards will be presented at 5 p.m.

In addition to the basic rodeo events, there will be bike demonstrations, repairs, literature, films, licensing and special activities and contests with bike accessories as prizes.

Every participant will receive a certificate of participation, literature, reflectors, stickers, a license and a bicycle flag.

Organizations involved in the rodeo include the Vienna Police Department, Fairfax County Police Traffic Safety Section, Insurance Women of Northern Virginia, Area Youth Hostels, Potomac Peddling Tours and Georgetown Cycle Sport.





Town Election May 2

Three incumbent Town Council members and two challengers will be seeking three available Council seats in the town's annual general election on Tuesday, May 2. Charles A. Robinson, Jr., will be unopposed for his second term as Mayor.

Polls will be open from 6 a.m. to 7 p.m. at the Community Center, 120 Cherry St., S.E. Plenty of parking space will be available at the Community Center and at the Vienna Volunteer Fire Department.

Seeking reelection to their second terms are Council members E. Ross Buckley, Vincent J. Olson and Wanda C. Pellicciotto. The challengers are Douglas A. Brook and Robert W. Robinson. See this month's *Newsletter* insert for a look at the candidates.

Town elections are non-partisan and winners are determined by popular vote. The three Council candidates receiving the largest number of votes will be elected to two-year terms that will expire June 30, 1980.

Election results are usually available one to two hours after the polls close. Results will be on the Vienna Newsline at 938-4499.

Spring Cleanup April 10

Start your spring cleaning now. The town's Spring Cleanup will begin on Monday, April 10. The cleanup will give residents a chance to dispose of brush, old furniture and household appliances, and other debris free of charge.

Residents should pile their debris at the curbside, taking care not to cover up fire hydrants or water meters. Brush and branches should be separated from other debris to help the cleanup go faster.

Public Works crews will start the pickup in the Southeast section of town and proceed clockwise through the Southwest, Northwest and Northeast. The time needed to cover each section is hard to determine; therefore, all residents should have their debris at the curbside by April 10. Once a section has been covered, crews will not double back.

Car Tag Deadline Extended

April 15, normally the deadline for obtaining town vehicle registrations, falls on a Saturday this year. To accommodate those residents who run late in purchasing their registrations, the deadline has been extended to Monday, April 17. In addition, the Finance Department will stay open until 7 p.m. April 13 and 14 for registrations.

The fee is \$20 for cars and trucks over 4,000 pounds, \$15 for lighter vehicles and \$8 for motorcycles. Most residents received registration applications in the mail. Applications are also available in the Finance Department at Town Hall. Completed applications may be returned in person or by mail.

Again this year, residents may choose either a windshield sticker or a metal plate to place below the front state license tag.

Comment from the Council Table:

Should We Expand The Community Center?

Since 1966 when the Community Center first opened it has been a focal point for recreational and civic affairs for the citizens of Vienna and the surrounding area. The original Center was enlarged to its present size in 1968. It is once again literally bursting at its seams as various groups and activities compete for space.

With this in mind, your Town Council has begun considering possible expansion of the Center.

Before any expansion can begin, there are many factors to be considered. First, we must decide whether or not expansion is really desirable. No significant amount of town money should be spent before

this initial question has been directly answered by the citizens of Vienna. Assuming that expansion is desired, we must determine the type of facility needed to compliment the present Center.

The second and probably most important factor that must be considered in any plan is cost. Where do we get the money to pay for expansion? There is approximately \$100,000 available. Can we get Fairfax County to contribute? Many county residents take advantage of the programs available at the Center. Should we under-

take a town-wide fund drive? This is how the original wing of the present Center was built. Can we get a grant from the state or federal government? Is this a desirable approach? What other alternatives are there?

Another factor to be considered is location. Is the present location the best possible? Should we decentralize and set up small centers in various areas of town? Two possible locations are the Moorefield and Bowman houses. The Moorefield house appears to have several disadvantages. It is quite small, and any expansion for recreational use would probably be in conflict with any historic restoration. There is very little space for parking at that site.


The Bowman house seems to have some real possibilities. It is close enough to the Community Center to be a convenient annex. Only

one block separates the two. Some parking is available on the property. Vienna Elementary School is nearby, and its parking lot could probably be used for evening and weekend activities. There is land available to the rear of the existing building for a sizeable addition. The exterior of the Bowman house needs refurbishing, but the building itself seems to be structurally sound. Or should the existing building be razed to make room for a completely new building? Is there some other more suitable location that has not been considered?

If the present location appears to be the most desirable, can the Center building be expanded? Apparently, it can but more land may be needed. Can we obtain land at a reasonable price?

These are but a few of the factors that must be considered in any plan for expansion of our Community Center. Your Town Council and the town staff would appreciate any thoughts and suggestions you may have at any time. Of course, there would be public hearings before any expansion is undertaken, so please give us your thoughts. It is your Community Center.

Council Action



Results of Town Council's January 9, 1978, Meeting

- * Directed the Town Manager and the Director of Public Works to prepare a series of alternate development schemes for the installation of sidewalk and other street improvements, including the installation of curbs and gutters, on Orchard St. in the vicinity of Nutley Rd. These estimates are to be returned to Council and copies of the estimates and the schemes provided to the residents on both sides of Orchard between Lewis and Nutley. These plans and alternatives are to be coordinated with the County School Board to find the extent of their participation in the cost.
- * Denied the request of Mr. Roger Darling to waive his real estate tax penalty.
- * Directed the Director of Public Works to install a guard rail on Westbriar Dr.
- * Accepted the audit of the town's records for fiscal year 1976-77 as prepared by the firm of Strean and Goldklang. Authorized payment of the auditor's bill of \$5.100 from budgeted funds.
- * Authorized the Town Manager to advise Fairfax County officials that the town will be supplying water, ample for all purposes, to the proposed DeLuca office-apartment complex to be located at the intersection of Nutley Rd. and I-66. The town will make it clear that its commitment will be conditioned on the acceptance by DeLuca of his commitment to advance to the town the cost of construction. The Town Manager will continue negotiations with all concerned, with final decision on any water service agreement to be submitted to Council for approval.
- * Voted to advise the Board of Supervisors that the Council believes that, including the amendments adopted by the Board on January 9, Chapter 19 of the proposed County Charter entitled "Intergovernmental Relationships" now meets the requirements of protecting the town in the exercise of its powers and in fulfilling the desire to continue as a self-governing town

within Fairfax County.

- * Voted to advise Fairfax County officials that the town is agreeable to the use of town-owned right-of-way for the proposed "pump-down" line, provided the town is reimbursed for the appraised value of the town's share of the right-of-way, and provided the county agrees that if the town is ever required to defray the cost of any expansion of the Accotink Trunk System, the town will at that time have the option of defraying the costs over a period of not more than 30 years and at an interest rate equivalent to that paid by the county on sewer bonds outstanding at the time the expense is incurred.
- * Requested the Planning Commission to hold a public hearing and make recommendations on the acquisition by the County Park Authority of additional land for Peterson Lane Park.
- * Authorized payment of the Assistant Town Manager's moving expenses from Illinois to Vienna of \$3,344.45.

Results of Town Council's January 23, 1978, Meeting

- * Adopted a Resolution of Appreciation to James R. Sineath.
- * Adopted a resolution upon the seventy-fifth anniversary of the Vienna Volunteer Fire Department.
- * Adopted an ordinance providing relief from town auto tax for totally disabled persons.
- * Approved the final plat of Wilson Estates Subdivision.
- * Voted to engage a qualified traffic engineering firm on a competitive bid basis to assess the possibility of installing a signal at the Beulah-Branch intersection and to request the Mitre Corp. for support in preparation of the following three items: work statement for the Beulah Rd. intersection study, time/distance diagrams and signal offset, review of study results and recommendations.
- * Authorized an additional \$422.10 to cover the cost of the Assistant Town Manager's move to Vienna.
- * Approved the regional grant application for the Northern Virginia Criminal Justice Center and approved \$145 in matching town funds for additional police training programs offered by the Center.
- * Voted to take no further action on acquisition of the Minipark at this time.
- * Authorized the Highway Safety Commission to meet once a month and Commission members to be paid \$25 per month, subject to approval by the Commission.

Community Center to Host Sister City Piano Recital

French pianist Nicole Chedeau will give a recital at the Community Center on Sunday, April 9, at 4 p.m. Her performance is being sponsored by the French Club as part of Vienna's ongoing exchange program with its sister city, Ceret, France. To help pay Ms. Chedeau's traveling expenses, admission will be \$2 for adults. Students will be admitted free.

Ms. Chedeau began her career as a pianist at the age of 16 and is a graduate of l'Ecole Normale Superieure de Musique de Paris, the leading conservatory in France. She has founded a music school on the Vermillion Coast in the south of France and teaches in the towns of Ceret, Port-Vendres and Banyuls -sur-mer.

Ms. Chedeau will give three other recitals in the area during her stay: 6 p.m. April 6 at St. John's Church in Washington, 8 p.m. April 11 at George Mason High School in Falls Church and 8 p.m. April 14 at the Fairfax County Library in Fairfax City.

Wanda C. Pellicciotto


