Tax Help for Senior Citizens

Senior citizens in the Vienna-Oakton area will again be able to obtain free assistance with their federal and state income tax forms beginning the first week in February. This program is sponsored by the Vienna chapter of the American Association of Retired Persons in cooperation with the U.S. Internal Revenue Service and the National Retired Teachers' Association.

Senior citizens will be able to get answers to questions, obtain additional tax forms, have their filled-in returns checked or have their returns filled in by one of the consultants.

A team of tax consultants will be available Tuesdays and Saturdays from 9 a.m. to noon at the Senior Citizens Lounge in the Vienna Community Center. No appointment is necessary. In addition, one consultant will be available on Wednesdays and Fridays from 10 a.m. to 2 p.m. in the Tysons Towers clinic, 8500 Tyspring Dr. Here, an appointment should be made by signing up on a sheet on the bulletin board.

Service at both sites will begin the first week of February. Service at the Community Center will not be available on Saturday, March 6, when an antique show will be held, or on Saturday, April 10, when the Center will be closed for Easter weekend.

Disabled senior citizens can arrange to have a consultant come to their homes by calling Willis Gehrke, Vienna coordinator of the Tax Counseling for the Elderly program, at 938-0829.

Citizen Action Team Formed To Assist in Metro Planning

The Town Council has created a citizen action team to assist the Town staff in planning for the Vienna Metrorail Station.

This three-man group is known officially as the Vienna Area Metro Station Citizen Action Team (VAMSCAT). Its members are Bennett Moss, Neil Walp and Frank Willingham, all selected by Council because of their expertise in the fields of transportation planning, land development engineering and urban affairs.

VAMSCAT will assist the Town staff in seeking to implement the recommendations of the Vienna Metro Station Planning Task Force. The Task Force, composed of residents from each section of town, was established in 1980 to assess the potential impact on the town of the Vienna Metrorail Station, scheduled to open in mid-1986 at the intersection of Nutley Road and 1-66.

The Task Force's final report, submitted last June, makes the following

- * Develop a local bus system to serve Vienna's own Metro riders and a radial network of buses on all major highways feeding into the Vienna Station.
- * Divert drivers away from the Vienna Station by providing fringe parking lots and express bus service to the station.
- * Evaluate traffic control problems at critical intersections and survey town residents on their planned use of Metro and routes of station access.
- * Prepare and test a contingency plan for controlling commuter parking on town streets.
- * Influence the final configuration of any new development plan for the area north of I-66 (the former DeLuca tract). Such a plan should reflect a 70-30 percent mix in favor of office versus apartment use.
 - * Support extension of the "K" Line to Dulles Airport.
- * Work with Metro planners to assure that the design of the Vienna Station provides adequate lighting and security in parking lots, platforms and exit areas; access for the handicapped, pedestrians and bicyclists; and covered walkways from bus bays to station entrances.

Town officials have requested meetings with representatives of the Washington Metropolitan Area Transit Authority, Fairfax County Office of Transportation and Virginia Department of Highways and Transportation to discuss these recommendations. Their first priority will be the design of the Vienna Station to adequately accommodate feeder buses.

Special Insurance Available

Two special types of insurance are now available for the increased protection of homeowners:

Sewer Backup. All insurance companies writing homeowner policies in Virginia are now required to offer an endorsement covering damages resulting from backups of drains and sewers. This additional coverage is available at very reasonable rates.

Flooding. Property owners within the Town of Vienna are also eligible to purchase flood insurance at reasonable rates through the Town's participation in the National Flood Insurance Program.



Council Action



Results of Town Council's December 7, 1981, Meeting

- * Authorized the Mayor to attend that evening's Fairfax County Board of Supervisors meeting to express Council's support for redistricting that maintains the entire town in one magisterial district, to express opposition to any plan that would divide the town into two or more districts and to recommend that the magisterial districts created be compact in size as well as equitably divided as to population.
- * Granted a request to rezone Lot 34 and part of Lot 22, Windover Heights. from RS-16 to Transitional Zoning, subject to the plans submitted to Council at the November 2, 1981, public hearing.
- * Approved the provisions of the Police Pension Plan document as presented by the Town Manager in his second draft of December 19, 1980. Police officers employed by the Town at the time this ordinance becomes effective will be given until March 8, 1982, to enter the new plan and thereafter be afforded an opportunity during January of each succeeding year to enter the new plan if they so desire. All sworn police personnel hired after March 8, 1982, will be authorized to participate only in the new plan. Proposed amendments to the existing plan will be considered at a work session in six months.
 - * Adopted amendments to the Cable Communications ordinance.
- * Adopted amendments to the Subdivision ordinance relative to variances, waivers and modifications that may be granted.
- * Authorized the Mayor to prepare a proclamation honoring Money & King Funeral Home on its 100th anniversary.
- * Adopted changes in job descriptions and titles for the Department of Parks and Recreation, to become effective as soon as possible.
- * Requested the Transportation Safety Commission to make a thorough study of the traffic situation in the Branch Road/Beulah Road/Maple Avenue area. The study is to include the possibility of realigning traffic lights to provide a complete intersection or the installation of additional lights to accomplish that purpose. The Commission is to advise all surrounding merchants of this study and to solicit their comments. The study is to be completed and a report made to Council by May 1, 1982.

Results of Town Council's December 21, 1981, Meeting

- * Appointed Frank Willingham. Neil Walp and Bennett Moss to the Vienna Area Metro Station Citizen Action Team.
- * Rescinded acceptance of the bid submitted by Fairfax Chrysler-Plymouth for three Plymouth Grand Fury squad cars in the amount of \$24,826.44 inasmuch as the Town's specifications were not met. Accepted instead the bid for three police cars submitted by Rosenthal Chevrolet in an amount not to exceed \$27,500.
- * Accepted the bid submitted by General Electric Co., Springfield, Va., for five hand-held portable two-way police radios in an amount not to exceed \$6.028.75.
- * Accepted the bid submitted by Meidinger, Inc., in an amount not to exceed \$5,000 for the actuarial study of the police and local retirement plans.

Results of Town Council's January 4, 1982, Meeting

* Reappointed the following members of the Transportation Safety Com-

mission: Gerald Miller for a two-year term and Charles Appleby and Lois Kirchschlager for three-year terms.

- * Adopted an ordinance to prohibit automatic dialing devices from using the 911 emergency system.
- * Approved the Town's continued employment of Mr. L. Clark Munn past his seventieth birthday, for a period of one year.

Free Leaf Mulch Delivery

The Vienna Department of Public Works will deliver leaf mulch to any residence in town during February and March, weather permitting. The minimum delivery is a dump truck load, and delivery is provided free of charge to in-town residents. To arrange for a delivery, call the Department of Public Works at 938-8000, ext. 241.

Residents may also pick up leaf mulch on their own Monday through Friday from 8 a.m. to 4:30 p.m. at Southside Park. The entrance to the Town's leaf mulch is located at the end of Ware Street, S.W. Leaf mulch may be picked up by town residents in any amount year round.

Did You Forget to Purchase Your Dog's 1982 Town Tag?

Dog owners are reminded that all dogs over six months old must be licensed annually. If your dog is not wearing a 1982 tag, please obtain one as soon as possible. There is no penalty for late purchase; however, you may be fined if your dog is found without a current tag. Also, a current tag can help identify your dog if he is lost.

Dog tags cost \$5 and will be sold only upon presentation of a current rables vaccination certificate. You may purchase tags in person in the Finance Department at Town Hall, or complete the form below and mail it to the address shown along with your check and an immunization certificate for each dog. Your immunization certificate will be returned along with the tag.
