Vienna's Youth Sports **Produce More Champions**



Town Council to Reconsider Marco Polo Rezoning Case

The Town Council will hold a public hearing on the rezoning of the Maple Avenue West Associates property on Monday, September 26. The hearing will be part of the regular Council meeting, which begins at 8 p.m. in Town Hall.

Last month, following a Fairfax County Circuit Court ruling in favor of Maple Avenue West Associates in their suit against the Town (known as the Marco Polo case after the restaurant behind which the property is located), Council voted not to appeal the case but rather to negotiate a settlement discussed at several previous meetings. This proposal calls for moving the commercial-residential zoning boundary to the north side of Church Street, making the property eligible for the transitional zoning category.

Maple Avenue West Associates sued the Town last year after Council denied their application to have their property rezoned from a residential to a commercial category. On August 11, the Court ruled that the Town could not enforce the current RS-10 resi-

dential zoning on the property and sent the rezoning application back to Council for reconsideration. A request for an award of \$300,000 in damages was denied.

Public Hearing on Changes At I-66/Nutley Intersection

A public hearing to consider the proposed location and design of additional and modified ramps at the Route I-66/Nutley Street interchange will be conducted by representatives of the Virginia Department of Highways and Transportation on Wednesday, September 14, at 7:30 p.m. at Marshall Road Elementary School, 730 Marshall Rd., S.W.

In addition to providing a full cloverleaf interchange, VDH&T proposes to widen Nutley Street to six lanes between the town boundary and Lee Highway (Route 29). This proposed construction is in conjunction with the Vienna Metro Station.

Maps, drawings, an environmental assessment and other information are available for public review and copying at VDH&T's Northern Virginia Division, 3555 Chain Bridge Rd. in

VDH&T representatives will be at Marshall Road School from 7:30 to 9:30 p.m. Wednesday, September 7. for an informal review of available information by interested citizens prior to the formal hearing.

Written statements and other exhibits relative to the proposed project may be presented in place of, or in addition to, oral statements at the hearing, and may also be submitted to VDH&T any time within 10 days after the hearing.

May 23, 1983

In the continuing debate about rush-hour restrictions on I-66, Council voted their support of recommendations made by Congressman Wolf and Senators Warner and Trible to Governor Robb. The recommendations include reducing the four-person carpool requirement to three persons and reducing the hours of restriction for a one-year trial period.

Other Council Action:

- * Authorized development of a large map of the commercial area under study by the Citizen Advisory Panel on Redevelopment of Commercial Zones, at a cost not to exceed \$500.
- * Accepted agreements for acquisition and maintenance of data processing equipment, funds to come from the FY 1983-84 budget.
- * Approved in principle a request by Vienna Villager Apartments for a waiver of lot coverage requirements to develop a subdivision plan. Voted to take the necessary steps to rezone, on Council's own motion, this land from C-1 to RM-2. Directed the Town Attorney to prepare the necessary amendment to the zoning code to require a masonry wall between RM-2 and Commercial zones.
- * Approved a waiver to allow 55% lot coverage of the property at 201 Park St., S.E.
- * Accepted the public improvements of lots 2 and 3, resubdivision part of lot 258, Onondio, and release of the bond.
- * Reappointed the following members of the Historic Windover Board of Review for two-year terms: Thomas Kamstra, Jerome Covel, Betty Henon, Jerry Barnett and Richard Burch.
- * Hired Potomac Energy Group of Alexandria to provide consulting services in the renovation of the Community Center heating, ventilating and air conditioning system at a

cost of \$6,800 to come from bond funds.

* Authorized the Town Attorney to develop a plan for researching the title to the Vienna Elementary School property to uncover any interest the Town may have in it.

June 6, 1983

Following an executive session, Council voted to pursue the case of *Maple Avenue West Associates vs. Town of Vienna* and not to accept the offer of settlement by the law firm representing the plaintiffs.

Other Council Action:

- * Accepted the bid of \$20,595.50 by Gallows Janitorial Service of Falls Church for servicing both the Town Hall and the Community Center for one year.
- * Accepted the reports by the Transportation Safety Commission on improvement of traffic on Maple Avenue and the requested left-turn signal from Maple Avenue onto North Center Street. Requested the Town staff to prepare recommendations for Council consideration based on the studies.

June 20, 1983

After a final public hearing, Council adopted the Town budget for FY 1983-84 and established the tax rates as follows: real estate, 33¢ per \$100 valuation; bank net capital, 80¢ per \$100 valuation; utility — residential, 20% of the first \$15, and commercial, 15% of the first \$300.

Other Council Action:

- * Forwarded to the Transportation Safety Commission for study and recommendations a letter concerning commuter parking on residential streets.
- * Authorized the Director of Public Works to proceed with the modification of the traffic light at Maple Avenue and Center Street to permit left turns from Maple Avenue onto North Center Street, as recommended by the Transportation Safety Commission.
- * Accepted the bid by Armanda, Inc., of Springfield for dumpster rental contract for FY 1983-84.

Keep Branches Cut Back

The Town Code requires property owners to keep tree branches, shrubs, vines and hedges trimmed so that they do not overhang sidewalks and other public rights-of-way. Such obstructions may endanger pedestrians and bicyclists using sidewalks and block the view of motorists. Residents of corner lots, in particular, should keep plants cut back.
