

This letter details the justification for a sole source selection of Siemens Industry Inc. as the Building Automation System provider for the Vienna Community Center

The Siemens Building Automation system uses proprietary parts and software that are only available as factory warranted replacement or upgrades from Siemens. The Beltsville, Maryland office of Siemens is the sole provider of these parts and the factory trained labor to install/repair the parts, serving the Washington DC area. Siemens Beltsville office has approximately 250 factory trained Building Automation System technicians to support the Vienna Community Center.

The Technical Support/Preventative Maintenance of the Building Automation System at the Vienna Community Center will be provided by factory trained Siemens staff. The Beltsville office of Siemens was the original manufacturer/installer of the Centralized Building Automation system for the Vienna Community Center. All replacement material will be Siemens factory authorized and warranted parts. Siemens has standard recommended diagnostics, testing, preventive maintenance, and troubleshooting routines which includes back-ups of field panel and server databases and standard procedures for reloading these databases in event of failures.

The Siemens Beltsville, Maryland has a complete training center to provide system operators with the training classes required to meet a Master Operators level. This training can only be provided by the local Siemens office with associated training center.
