

VIENNA POLICE HIGHLIGHTS

July 8, 2022

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from

July 1, 2022 to July 7, 2022. Readers are reminded that an "arrest" is based upon probable cause and does not always mean that someone was physically taken into custody. Furthermore, it does not mean that an individual is automatically guilty of a crime. Judicial outcomes and post-arrest proceedings can be researched through the appropriate court's website.

On July 1, 2021, citizens will be able to access Community Policing data via <u>https://data.virginia.gov/stories/s/rden-cz3h</u>. The Vienna Police Department had started complying with this state law in July of 2020. The portal will contain all non-consensual investigatory stops made by the Vienna Police Departments and other law enforcement agencies in the commonwealth.

Car Thefts and Tamperings

The National Capital Area and specifically the Northern Virginia area, has seen increased vehicle tampering incidents and vehicle thefts. In some incidents, suspects entered homes through unlocked doors and open garage doors to steal property and keys to vehicles. The suspects then used the vehicle keys to gain entry into vehicles and use them to get away. The Vienna Police Department would like to remind our community members to please stay vigilant, close, and lock all doors of residences and garages to prevent criminals from targeting your property.

Fraud 22-006756 500 Block Kibler Circle, SW Between May 24 at 8:00 a.m. and June 16 at 5:00 p.m.

A resident reported that someone had used her personal information to open two credit card accounts.

Petit Larceny 22-006578 400 Block Tapawingo Road, SW June 24 between 6:00 p.m. and 6:30 p.m. A resident reported that someone stole her bicycle while she was picking flowers.

Vandalism 22-006531 Giant Food 359 Maple Avenue, East June 27 2:02 p.m.

Officers responded to the report of vandalism in progress behind Giant. Officers located two involved juveniles walking on Glyndon Street. The Giant employees did not wish to pursue charges for the vandalism but requested that the boys be trespassed from the property. The juveniles were counseled and released to their parents.

Juvenile Case 22-006737

Between June 30 at 3:00 p.m. and July 1 at 12:34 a.m.

A resident reported that her teenage daughter left to pick up food in the afternoon and never returned home. The juvenile texted her mom to let her know she was out with friends. The resident did not wish to report the juvenile missing but wanted guidance in dealing with her.

Forgery 22-006715 400 Block Johnson Street, NW June 30 6:09 p.m.

A resident reported that she mailed a check for her mortgage payment at one of the Vienna Post Office's mailboxes. The check was stolen, forged for a larger amount, and cashed.

Vandalism 22-006886 120 Cherry Street, SE

Between July 1 5:00 p.m. and July 5 8:00 a.m.

A Town of Vienna Employee reported that someone had spray-painted the brick backside of a baseball dugout.

Petit Larceny 22-0006759 Popeyes 325 Maple Avenue, East July 1 5:50 p.m.

A citizen advised that he was inside the restaurant picking up food when he observed a person near his vehicle in the parking lot. When the citizen returned to his car, he found that his wallet and AirPods had been stolen. The citizen then saw the individual drive past in another vehicle. He began to follow him, and the driver threw his wallet out the window before exiting the parking lot onto Branch Road. The citizen stated that nothing appeared to be missing from the wallet. This case is being investigated.

Assault 22-006766 George Street and Cottage Street, SW

July 1 10:05 p.m.

A citizen reported walking eastbound on George Street towards Cottage when a woman in an SUV began driving too close to him and his family. He advised that after the driver ignored his requests to be more careful, he stopped in front of her vehicle to slow her down. The citizen stated the vehicle's bumper made contact with his back, but he was not injured. Officers spoke to the driver, who advised that the complaining citizen was causing the issue, stopping in front of her vehicle and sitting down on her bumper, refusing to move. The warrant process was explained to both parties should they decide to pursue charges.

Welfare Check 22-006810 300 Block Lawyers Road, NW

July 2 11:34 p.m.

A tenant reported that they had not seen the homeowner for the past day, and a dog she cared for was left out in the bad weather. Officers checked on the homeowner's welfare, who stated she had just been released from the hospital after suffering a medical emergency. The officers observed that she appeared weak and confused and requested rescue personnel respond to evaluate her. The homeowner was caring for four dogs at the residence whose owners were notified along with ACO Barker, who will follow up on this case.

Grand Larceny 22-006824 Terra Christa 130 Church Street, NW July 3 between 1:00 p.m. and 2:00 p.m.

An employee reported that her wallet was stolen from the back office area of the store. The wallet contained various credit cards, gift cards, currency, and identification. The credit cards were used to make fraudulent purchases.

Firearm Violation 22-006832 Nutley Street and Courthouse Road, SW July 3 6:35 p.m.

A resident reported that he was driving northbound on Nutley Street approaching Courthouse Road when he observed another vehicle approaching from behind him at a high rate of speed. Both vehicles stopped for the red traffic light. The resident yelled at the other driver to slow down, and the driver brandished a firearm. The driver placed the firearm in his lap and verbally threatened the resident before he made a left turn and continued westbound on Courthouse Road. Officers searched the area but did not locate the driver.

Peeping Tom 22-006897 1200 Block Cottage Street, SW July 4 12:02 a.m.

A resident reported that a person dressed as a ghost and wearing sunglasses was standing right outside her bedroom window for approximately 5 minutes. Once the resident saw the person, she ran out of her bedroom to alert her parents. The parents attempted to find the person but were unable to locate them.

Officers responded to an altercation between two roommates. Officers interviewed both roommates and determined that it was mutual combat. Both parties were advised of the warrant process.

IDENTITY THEFT/FRAUD

Town of Vienna, Virginia Police Department Media Information Release Warning: McAfee Scam Email

Detectives with the Vienna Police Department are investigating two separate scam incidents related to a "McAfee Antivirus" email. Detectives advised that the scam usually begins with an email that purports to be from McAfee informing citizens that they are being charged \$300 for "McAfee Total Protection anti-virus software" unless they cancel the order by calling a phone number provided in the email. If you call the number provided, you will be greeted by a scammer posing as a McAfee employee who will ask for personal information, including a bank account number supposedly to verify the account. After receiving the personal information, the scammer will request a wire transfer of funds which will be nearly impossible to reverse once it is completed. The Vienna Police Department provides the following guidelines for spotting and avoiding a "phishing" email:

- 1) Always check the sender's email. Phishing emails may look like they are from a legitimate company you trust. Most of the time, you can tell it is a phishing scam if the sender's email address consists of random numbers and letters. If you are unsure, research the email of the company.
- 2) Look for spelling and grammatical errors. Phishing emails tend to have multiple spelling and grammatical errors in them.
- 3) Phishing emails will attempt to trick you through a sense of urgency in order to click on a link or open an attachment. You can inspect the link by hovering the mouse over it without clicking on it—only open attachments from trusted and verified sources.
- 4) Phishing emails may trick you by saying:
 - a. They've noticed suspicious activity or login attempts
 - b. Claim there are account problems or problems with payment information
 - c. Ask to confirm personal information
 - d. Attach fake invoices
 - e. Provide a link to allow for a payment
 - f. Threaten to arrest
 - g. Offer money or free items

If you feel you have fallen victim to a phishing scam, please call the police non-emergency number, 703-255-6366, to report it. You can also report phishing emails to your email provider or the Federal Trade Commission (FTC) using their website.
