

VIENNA POLICE HIGHLIGHTS

August 5, 2022

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from July 29, 2022 to August 4, 2022. Readers are reminded that an "arrest" is based upon probable cause and does not always mean that someone was physically taken into custody. Furthermore, it does not mean that an individual is automatically guilty of a crime. Judicial outcomes and post-arrest proceedings can be researched through the appropriate court's website.

On July 1, 2021, citizens will be able to access Community Policing data via <u>https://data.virginia.gov/stories/s/rden-cz3h</u>. The Vienna Police Department had started complying with this state law in July of 2020. The portal will contain all non-consensual investigatory stops made by the Vienna Police Departments and other law enforcement agencies in the commonwealth.

Car Thefts and Tamperings

The National Capital Area and specifically the Northern Virginia area, has seen increased vehicle tampering incidents and vehicle thefts. In some incidents, suspects entered homes through unlocked doors and open garage doors to steal property and keys to vehicles. The suspects then used the vehicle keys to gain entry into vehicles and use them to get away. The Vienna Police Department would like to remind our community members to please stay vigilant, close, and lock all doors of residences and garages to prevent criminals from targeting your property.

Petit Larceny 22-007815 1000 Block Park Street, SE June 2 11:11 a.m.

A resident advised that he ordered a sound bar from Best Buy. The package was delivered and when the resident went to his front porch to retrieve it a few minutes later, he found the box was empty. Neither Best Buy nor UPS would claim responsibility for the stolen item.

Fraud 22-007799

500 Block Orchard Street, NW

Between July 5 at 12:01 a.m. and July 28 at 8:50 a.m.

A resident reported that she listed pavers for sale on Craig's List. An individual immediately replied and sent the resident a cashier's check for much more than the agreed-upon price. The resident took the check to the bank and found that it was fraudulent. A few days later the resident received another envelope with the same fraudulent cashier's check made payable to a different individual.

Arrest – Domestic Assault 22-008026

Between July 20 at 9:00 p.m. and July 21 at 9:00 p.m.

On August 4, an officer was approached by a juvenile who advised that her mother wanted to report a domestic assault. The resident advised the officer that her boyfriend assaulted her and locked her in a room in the apartment on July 20. The officer transported the resident to the magistrate's office where the magistrate issued two warrants for the boyfriend charging Abduction and Domestic Assault. A protective order was also issued.

Officers responded to the resident's apartment where they arrested the 23-year-old man from Patrick Street, SE. He was transported to the Fairfax County Adult Detention Center where the warrants and a protective order were served on him.

Results of the Stop Sign Enforcement Campaign

After a noticeable increase in stop sign violations, the Town of Vienna Police Department had a directed enforcement initiative during the month of June. Although the initiative focused on stop sign violations, officers cited other traffic infractions.

During the Stop Sign Enforcement Campaign, officers worked a total of 469 events utilizing stationary observation of stop signs, which generated 219 stop sign violations and 74 other violations.

The Vienna Police Department plans on conducting more directed traffic enforcement campaigns to increase awareness of the importance of obeying traffic laws to improve the safety of drivers and pedestrians.

Town of Vienna, Virginia Police Department Media Information Release Warning: McAfee Scam Email

Detectives with the Vienna Police Department are investigating two separate scam incidents related to a "McAfee Antivirus" email. Detectives advised that the scam usually begins with an email that purports to be from McAfee informing citizens that they are being charged \$300 for "McAfee Total Protection anti-virus software" unless they cancel the order by calling a phone number provided in the email. If you call the number provided, you will be greeted by a scammer posing as a McAfee employee who will ask for personal information, including a bank account number supposedly to verify the account. After receiving the personal information, the scammer will request a wire transfer of funds which will be nearly impossible to reverse once it is completed. The Vienna Police Department provides the following guidelines for spotting and avoiding a "phishing" email:

- 1) Always check the sender's email. Phishing emails may look like they are from a legitimate company you trust. Most of the time, you can tell it is a phishing scam if the sender's email address consists of random numbers and letters. If you are unsure, research the email of the company.
- 2) Look for spelling and grammatical errors. Phishing emails tend to have multiple spelling and grammatical errors in them.
- 3) Phishing emails will attempt to trick you through a sense of urgency in order to click on a link or open an attachment. You can inspect the link by hovering the mouse over it without clicking on it—only open attachments from trusted and verified sources.
- 4) Phishing emails may trick you by saying:
 - a. They've noticed suspicious activity or login attempts
 - b. Claim there are account problems or problems with payment information
 - c. Ask to confirm personal information
 - d. Attach fake invoices
 - e. Provide a link to allow for a payment
 - f. Threaten to arrest
 - g. Offer money or free items

If you feel you have fallen victim to a phishing scam, please call the police non-emergency number, 703-255-6366, to report it. You can also report phishing emails to your email provider or the Federal Trade Commission (FTC) using their website.
