
Consultants from Kilduff Associates, who are preparing the new master plans, will be present to explain their recommendations for upgrading the parks and to receive comments from the public on the park plans.

Vienna Acts to Insure Safe Drinking Water

Town officials have received a number of calls about news reports concerning a chemical in the Town's water supply called trihalomethane (THM). The Town wishes to assure citizens that Vienna's water is absolutely safe and meets all federal and state regulations governing water quality.

THM is a chemical compound formed in very small amounts (parts per billion) by the reaction of organic substances, such as decaying leaves, and chlorine at the point of treatment. THM's exist in all water systems that use chlorine to disinfect the water.

Tests on laboratory animals have shown THM's in heavy concentrations to be carcinogenic, but there is no evidence that THM's cause cancer in humans. The U.S. Environmental Protection Agency has described the risk as follows: A person must consume two quarts of water containing 100 ppb of THM for 70 years in order for a health risk to exist. As a precaution, however, EPA has established a limit of 100 ppb of THM for all water systems serving a population of over 10,000.

As of November 1983, the Town was required to be in compliance with the EPA limit for THM's. At that time.

Tracing History

The advent of Vienna's 1990 Centennial has prompted Historic Vienna, Inc., to undertake a historical landmarks survey of the town's homes and businesses. A block-by-block charting and photographic inventory of the community will be conducted this winter by interested citizens aided by history students from Oakton High School.

the State Health Department informed the Town that it was approaching the limit, and the Town immediately began to investigate ways to keep THM's within the established limit.

It was determined that the Town could not rely on its suppliers, the City of Falls Church and the U.S. Army Corps of Engineers, to help reduce the THM level should it exceed the limit, and so the Town hired a local consultant, Guy & Davis, to study the situation and make recommendations the Town could pursue.

The study was submitted in October. Subsequently, the Town held several meetings with representatives of Falls Church and the Fairfax County Water Authority to obtain commitments that will allow the Town to take remedial action if necessary to protect consumer health.

The Town is also involved in a stepped-up sampling program. Instead of sampling once every three months, samples are now taken once a month. As of December, the level of THM is 88 ppb.

It is possible that EPA may lower the limit on THM's from 100 to 50 ppb within the next few years. Should this happen. Falls Church and possibly the Corps of Engineers will be in violation and will be required to modify their facilities to meet the new limit. This facilities modification would also bring the Town into compliance. It is for this reason that the Town staff does not recommend a large capital expenditure at this time but rather to continue the current monthly sampling. along with plans for remedial action if necessary, to insure a high level of water quality for all.

Town Cleanup Survey Results

The Town has received 2,474 responses to its citizen survey on the Town cleanup program. This response represents the views of about 47% of the households in Vienna.

94% of those responding indicated they want the cleanup service continued in some form — either as it now exists, or on a quadrant-by-quadrant basis with a specific starting date for each quadrant, or even on an individual basis with the resident arranging for a pickup on a certain day. 6% said they favored eliminating the cleanup program entirely.

72% of the respondents said they were generally satisfied with the way cleanups are conducted. Of the 28% who had objections, the majority were dissatisfied with the unsightly appearance of the town during cleanups (35%) and the length of time spent on cleanups (31%).

67% of those answering the survey said they participate in both spring and fall cleanups, and over 85% use the cleanups to dispose of brush and branches. This type of debris accounts for over 40% of the total cleanup load.

The survey question concerning the possibility of a permanent dumpster where citizens could dispose of items at any time drew a mixed response. 54% said they favored such a proposal, another 14% said they would favor it only in addition to regular cleanups, and 31% were opposed to the idea.

Again, thanks to everyone who participated in the survey. The Town Council and Town staff will consider the results in making proposals for the future of the cleanup program.

In a related action, Council has adopted an ordinance to prohibit bringing in debris from outside of town to be collected during cleanups or the regular trash pickups.
