

VIENNA POLICE HIGHLIGHTS

January 6, 2023

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from December 30, 2022 to January 5, 2023. Readers are reminded an "arrest" is based upon probable cause and does not always mean someone was physically taken into custody. Furthermore, it does not mean an individual is automatically guilty of a crime. Judicial outcomes and post-arrest proceedings can be researched through the appropriate court's website.

On July 1, 2021, citizens will be able to access Community Policing data via https://data.virginia.gov/stories/s/rden-cz3h. The Vienna Police Department had started complying with this state law in July of 2020. The portal will contain all non-consensual investigatory stops made by the Vienna Police Departments and other law enforcement agencies in the commonwealth.

UPDATE – Car Thefts and Tamperings

The National Capital Area, specifically the Northern Virginia area, has seen increased vehicle tampering incidents and vehicle thefts. A recent pattern has been identified where suspects enter the area in stolen vehicles and cruise streets between 3:00 AM and 7:00 AM. In addition to rifling through unlocked cars for valuables and money, they steal the vehicle when they encounter keys left in it. The Vienna Police Department would like to remind our community members to please stay vigilant, secure their cars and take the keys inside, and close and lock all doors of residences and garages to prevent criminals from targeting your property. Additionally, please call the police if you notice suspicious vehicles or people in your area, and share Ring doorbell or other security camera footage with us if you capture video related to these incidents. The Vienna Police Department is working closely with other Law Enforcement agencies in the region, coordinating our resources to investigate these crimes.

On January 1, a resident reported a violation of a protective order when her neighbor aggressively approached her in the parking lot on December 31. An officer transported the resident to the magistrate's office where she obtained a misdemeanor warrant for the neighbor charging Violation of a Protective Order. A resident requested transportation to an area facility for emotional counseling.

Arrest – Violation of Protective Order 22-012336 200 Block Park Terrace Court, SE December 31 2:02 p.m.

A resident reported her neighbor was yelling and approaching her in violation of a protective order.

The resident went immediately to the magistrate's office and obtained a warrant. PFC Gucwa served the warrant on the 37-year-old man from Park Terrace Court, SE charging Violation of a Protective Order. The man was released on his signature.

Assault 23-000003 Bear Branch Tavern 133 Maple Avenue, East January 1 12:30 a.m.

An employee reported one of their customers had just been assaulted by another man who they are familiar with. The customer stated he was outside when he observed the man walking through the parking lot shouting at the parked vehicles. The man then aggressively approached the customer and began to threaten him. The customer went back into the restaurant. The man followed and assaulted the customer. Employees stepped in to assist and the man left the restaurant.

Ofc. Crandall responded to the magistrate's office and obtained a warrant for the man. (*Reference Incident # 23-00038 for the warrant service*).

Arrest – Driving on Suspended License 23-000007 100 Block Maple Avenue, East January 1 2:31 a.m.

An officer observed a traffic violation and initiated a traffic stop. The officer found the driver's license privilege had been suspended in Virginia.

Ofc. Garcia arrested the 26-year-old man from Grand Central Square in Sterling, Virginia. He was transported to the Fairfax County Adult Detention Center and charged with Driving on a Suspended License – Driving While Intoxicated Related.

Destruction of Property 23-000013 200 Block Park Terrace Court, SE January 1 12:25 p.m.

A resident reported her neighbor threw garbage and liquids on her security camera and doormat. PFC Gucwa obtained a warrant for the neighbor charging Destruction of Property. (*Reference Incident # 23-000038 for warrant service*).

Arrest – Drunk In Public 23-000021 Wawa 465 Maple Avenue, West January 1 4:15 p.m.

An officer responded to Wawa for the report of a man attempting to purchase alcohol with invalid identification. Upon the officer's interaction with the man, they detected signs of impairment.

Ofc. Stroh arrested the 28-year-old man with no fixed address. He was transported to the Fairfax County Adult Detention Center and charged with Drunk In Public.

A resident believes his electronic devices were hacked and his personal information compromised.

An employee reported a man came into the store and stole a bottle of alcohol.

Arrest – Assault and Warrant Service 23-000038 200 Block Park Terrace Court, SE January 2 2:48 p.m.

Officers responded to a report of a male resident acting disorderly, throwing objects from his second story balcony. It was reported he began a confrontation with two subjects, throwing glass jars and metal objects at them. The two subjects immediately responded to the magistrate's office to obtain warrants. The Vienna Police Department had warrants on file for the resident from prior calls for service. Officers attempted to speak to the resident, however, he continued to act disorderly, throwing objects and making threats towards officers and others in the area.

Fairfax County Police and Fairfax City Police K-9 units responded to assist in negotiating with the man. The other residents in the building were evacuated for their safety. After several hours, officers from the Fairfax County Special Weapons and Tactics unit were able to safely extract the resident from his condo. He was transported by fire and rescue personnel to an area hospital for treatment of minor injuries. Once he was cleared by the medical staff, the resident was transported to the Fairfax County Adult Detention Center where multiple warrants were served on him charging three counts of misdemeanor Assault (*reference Incident 23-0003*, *and the two assaults listed in this incident*), Destruction of Property (*reference Incident 23-0013*), Violation of a Protective Order (*reference Incident 23-0014*), and a felony warrant from Prince William County Police charging Written Threats to do Bodily Harm.

Arrest – Assault 23-000047 400 Block Nutley Street, NW January 3 7:14 a.m.

A resident reported her grandson threw a shoe at her during an argument. When her other grandson intervened to stop his cousin from injuring their grandmother a struggle ensued.

MPO Tremont arrested the 36-year-old man from Nutley Street, NW in Vienna. He was transported to the Fairfax County Adult Detention Center where he was charged with misdemeanor assault and an Emergency Protective Order was served on him. The man was released on a \$2000 unsecured bond. (*Reference Incident #23-000053*).

A resident reported his cousin was inside the home in violation of a protective order.

Town of Vienna, Virginia Police Department Media Information Release Warning: McAfee Scam Email

Detectives with the Vienna Police Department are investigating two separate scam incidents related to a "McAfee Antivirus" email. Detectives advised that the scam usually begins with an email that purports to be from McAfee informing citizens that they are being charged \$300 for "McAfee Total Protection anti-virus software" unless they cancel the order by calling a phone number provided in the email. If you call the number provided, you will be greeted by a scammer posing as a McAfee employee who will ask for personal information, including a bank account number supposedly to verify the account. After receiving the personal information, the scammer will request a wire transfer of funds which will be nearly impossible to reverse once it is completed. The Vienna Police Department provides the following guidelines for spotting and avoiding a "phishing" email:

- Always check the sender's email. Phishing emails may look like they are from a legitimate company you trust. Most of the time, you can tell it is a phishing scam if the sender's email address consists of random numbers and letters. If you are unsure, research the email of the company.
- 2) Look for spelling and grammatical errors. Phishing emails tend to have multiple spelling and grammatical errors in them.
- 3) Phishing emails will attempt to trick you through a sense of urgency in order to click on a link or open an attachment. You can inspect the link by hovering the mouse over it without clicking on it—only open attachments from trusted and verified sources.
- 4) Phishing emails may trick you by saying:
 - a. They've noticed suspicious activity or login attempts
 - b. Claim there are account problems or problems with payment information
 - c. Ask to confirm personal information
 - d. Attach fake invoices
 - e. Provide a link to allow for a payment
 - f. Threaten to arrest
 - g. Offer money or free items

If you feel you have fallen victim to a phishing scam, please call the police non-emergency number, 703-255-6366, to report it. You can also report phishing emails to your email provider or the Federal Trade Commission (FTC) using their website.
