### **Handicapped Parking Signs**

The Vienna Police Department advises town businesses and organizations having parking spaces reserved for handicapped drivers that those spaces must now be identified by above ground signs.

The Virginia General Assembly adopted an amendment to the State Code effective last July 1 requiring the above ground signs to be posted for handicapped spaces on public property and in privately owned parking areas open to the public.

Spaces must be marked in this manner in order for handicapped parking restrictions to be enforceable by the police.



## **Cleanup Begins in Southeast**

The Fall Cleanup begins October 7 in southeast Vienna. Cleanup crews will then move on to the southwest quadrant on October 16, northwest on October 29, and northeast on Novem-

Residents are asked not to place cleanup items at the curbside more than a week prior to the starting date for each quadrant. Those who put out discards too early may be required to remove them or to pay \$30 for a special trash pickup.

During the cleanup, Department of Public Works crews will pick up free of charge household discards and debris not normally included in the regular trash pickups. The only limitations are as follows:

Each residence is limited to 300

pounds each of concrete and scrap metal.

- Whole automobile bodies will not be picked up.
- Only two major appliances may be discarded per residence.
- Leaves will not be picked up by cleanup crews.
- No debris of any kind may be brought in from outside of town for pickup.

Please separate brush and branches from other discards, and keep all cleanup items away from regular trash, fire hydrants, water meters, gas valves, fences and utility poles.

## **Permit Parking Public Hearings**

Public hearings on a proposed residential parking permit ordinance will be held this month. The Permit Parking Task Force, composed of Planning Commission and Transportation Safety Commission members and Town staff, will conduct a hearing on Thursday. October 3, prior to the Town Council's hearing during its regular meeting on Monday, October 21. Both meetings will begin at 8 p.m. at Town Hall, and interested citizens are encouraged to attend.

The proposed ordinance would allow the Town Manager to designate streets for permit parking in order to eliminate commuter parking and preserve the residential character of the neighborhood. All parking would be restricted during set weekday hours, except for the residents, their quests. and others having business there, who would be issued parking permits by the Town.

To qualify for permit parking, 75% of the parking space on a street must be occupied by commuter vehicles on weekdays, and average over 25% during a month. A public hearing would be required before any street could be designated for permit parking.

- Approved a request to waive sidewalk construction for Moore Mews Subdivision, corner of Frederick St. and Tapawingo Rd., S.W., and escrow \$3,591 in the Town's sidewalk fund.
- Denied a request to reinstall the left-turn traffic signal into Danor Shopping Center from Maple Ave. at Beulah Rd.
- \* Accepted a recommendation from the Transportation Safety Commission that a four-way stop at Hine St. and Follin La. is not needed at this time since the sight distance has been improved for Hine St. traffic, the stop bar moved closer to the intersection and a "stop sign ahead" warning posted.
- Requested the Fairfax County School Board to provide bus service for students now crossing Maple Ave. at Nutley St. to attend James Madison High School. Requested the Virginia Department of Highways and Transportation to study that intersection and also Maple Ave. and Center St. to determine if pedestrian walk lights are warranted.
- Requested the Transportation Safety Commission to study the intersection of Lewis and Orchard Streets, including traffic counts at different times of day, and recommend action to alleviate the traffic hazard there.
- Awarded a contract for storm drainage improvements on Johnson St. to Landcraft Co. of Alexandria at a bid price of \$126,543, to come from bond funds.

## **Zoning Laws Cover Fences, Cars**

The Zoning Office requires that residents obtain a fence permit prior to constructing fences on their property. A permit costs \$5, and the main purpose for requiring permits is to assure that strict height limitations are followed.

Three restrictions to keep in mind are:

- Any fence located between the front of the house and the front property line cannot be more than four feet high.
- Any fence must have the finished side facing the street or adjacent property.
- The use of barbed wire is not permitted.

STATE OF THE STATE OF

The Town Code states, "In any residential or multi-family zone in town it is unlawful for any person, firm, or corporation to keep, except within a fully-enclosed building or structure, any automobile or automobiles in such condition that it is economically impractical to make them operative." Vehicles not regularly kept in a completely enclosed structure must display current State license plates or a stored vehicle tag issued by the Town.

## Master Plans for Three Parks Ready for Council Approval

At its October 7 meeting, the Town Council will consider approval of master plans for three of the Town's parks and funding to implement some of the planned improvements. It is anticipated that the initial phase of improvements will require approximately \$130,000.

The meeting will begin at 8 p.m. at Town Hall and interested citizens are encouraged to attend.

The Town staff has spent more than a year considering master plan options with its landscape architects, Kilduff Associates, as well as gathering input from area residents through a series of public meetings. Master plans have been developed for Meadow Lane, Glyndon and Southside Parks. The primary objective of each plan is to upgrade existing facilities to make the parks more functional and pleasant for park users.

Improvements will be made to ball-fields and play areas, picnic facilities will be improved or expanded, new playground equipment is to be installed, and landscaping and site amenities added to improve the appearance of the parks. Kilduff Associates estimate the total cost of completing all three parks to be somewhat over \$600,000.

The Parks and Recreation Department is recommending that Phase I of improvements include a new restroom and concession building for Glyndon Park to replace the existing building damaged by fire last summer (\$30,000), minor ballfield and parking lot improvements at Southside Park to maintain an acceptable level of safety for park users (\$10,000), and completion of all improvements at Meadow Lane Park (\$90,620). With the limited bond funds currently available for park improvements, it is possible to complete only the smallest of the three parks, which is Meadow Lane.

Upon Council's approval of the master plans and Phase I funding, Kilduff Associates will prepare detailed drawings for development of the various improvements proposed for each park. Construction of some facilities could begin as early as this fall.

## House Numbers Must Be Seen

When responding to emergencies, one of the recurrent problems fire and rescue personnel encounter is missing or difficult-to-read house numbers.

When houses do not have numbers properly placed, emergency personnel often have to guess which is the correct house. This wastes valuable time, especially in the case of heart attacks and other life-threatening emergencies.

In some cases, the plain numerals (310, for example) have been replaced with words (three hundred ten) in what

looks like handwriting. The writing may look appealing, but trying to read it from a moving vehicle is very difficult.

The Town Code states that numbers "shall be conspicuously placed immediately above, on or at the side of the proper door of each building so that the number can be seen plainly from the street. Whenever any building is situated more than fifty feet from the street line, the number of such building shall be conspicuously displayed at the street line, near the walk, driveway or common entrance to such building and upon the gate post, fence, tree, post or other appropriate place so as to be easily discernible from the sidewalk."

Be sure your house number is big enough and clear enough to be read from the street in both directions to help protect your life and property.

## Look for Gypsy Moth Egg Masses


The Fairfax County Department of Extension's Gypsy Moth Office is again urging citizens and community groups to become involved in hunting for gypsy moth egg masses.

Each gypsy moth egg mass contains from 500 to 1,000 eggs, and if left undisturbed will produce a similar number of hungry caterpillars in the spring. The egg masses are buff-colored, measure approximately ¾ x 1½ inches, and resemble a small piece of chamois cloth. They typically may be found

plastered to the undersides of branches, house eaves, tree trunks, wood and stone fences, bird houses, and firewood.

When found, egg masses should be scraped off, collected in a jar, and taken to any County library to be forwarded to the Plant Diagnostic Library. The sample will be confirmed and a report sent to you. This is a free service. For more information, contact the Gypsy Moth Office at 11212 Waples Mill Rd., Fairfax, VA 22030.

of the requirement. Under the County Code, there is a 10% penalty, with a \$5 minimum, if a vehicle is not reported within 30 days of acquiring tax situs in Fairfax County.

(Vienna residents are not required to purchase the County vehicle registration decals mentioned in the letter; the Town issues its own decals.)

With the advent of proration of personal property tax on motor vehicles in 1984, it became necessary for tax-payers to report vehicles for assessment throughout the year. Last year, many taxpayers were unaware of the change and became liable for the late filing penalty.
