

VIENNA POLICE HIGHLIGHTS

January 13, 2023

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from January 6, 2023 to January 12, 2023. Readers are reminded an "arrest" is based upon probable cause and does not always mean someone was physically taken into custody. Furthermore, it does not mean an individual is automatically guilty of a crime. Judicial outcomes and post-arrest proceedings can be researched through the appropriate court's website.

On July 1, 2021, citizens will be able to access Community Policing data via https://data.virginia.gov/stories/s/rden-cz3h. The Vienna Police Department had started complying with this state law in July of 2020. The portal will contain all non-consensual investigatory stops made by the Vienna Police Departments and other law enforcement agencies in the commonwealth.

UPDATE – Car Thefts and Tamperings

The National Capital Area, specifically the Northern Virginia area, has seen increased vehicle tampering incidents and vehicle thefts. A recent pattern has been identified where suspects enter the area in stolen vehicles and cruise streets between 3:00 AM and 7:00 AM. In addition to rifling through unlocked cars for valuables and money, they steal the vehicle when they encounter keys left in it. The Vienna Police Department would like to remind our community members to please stay vigilant, secure their cars and take the keys inside, and close and lock all doors of residences and garages to prevent criminals from targeting your property. Additionally, please call the police if you notice suspicious vehicles or people in your area, and share Ring doorbell or other security camera footage with us if you capture video related to these incidents. The Vienna Police Department is working closely with other Law Enforcement agencies in the region, coordinating our resources to investigate these crimes.

Vehicle-2 was traveling southbound on Park Street. Vehicle-1 was traveling northbound on Park Street. Vehicle-1 crossed the centerline and struck Vehicle-2 near the intersection of Park Street and Fardale Street, SE. Driver-1 fled the scene of the accident.

Vehicle-1 was located at the intersection of Nutley Street and Marshall Road when a citizen reported a driver asleep in the vehicle. The keys were in the ignition and the vehicle was running. Upon the officer's interaction with the driver, they detected signs of impairment. After the driver failed a series of field sobriety tests, he was placed under arrest.

Ofc. Rodriguez transported the 51-year-old man from Blake Lane in Vienna to the Fairfax County Adult Detention Center where a sample of his blood was taken for analysis and he was charged with Hit & Run and Driving While Intoxicated.

Firearm Discharge Incident

On January 8th, 2023, around 3:40 PM, officers from the Vienna Police Department responded to the report of a firearms discharge near the Giant Food, 359 Maple Ave E. Investigation determined two subjects, both identified by the Vienna Police Department, were involved in a family civil dispute. One subject sustained minor injuries and was transported to a local hospital where they were treated and released. The second subject suffered minor injuries that did not require medical attention.

The criminal investigations section of the Vienna Police Department will continue to investigate the incident. Investigators will consult with the Fairfax County Commonwealth Attorney's Office to determine which charges will apply.

Shooting incidents are rare in the Town of Vienna and citizens should expect a full and complete investigation. Grand Larceny

On October 25, 2022, between 1pm and 2pm, the subject pictured below is suspected of stealing a wallet from a purse of an unattended shopping cart at Giant, located in Vienna, VA. Town of Vienna, Virginia Police Department Media Information Release Warning: McAfee Scam Email

Detectives with the Vienna Police Department are investigating two separate scam incidents related to a "McAfee Antivirus" email. Detectives advised that the scam usually begins with an email that purports to be from McAfee informing citizens that they are being charged \$300 for "McAfee Total Protection anti-virus software" unless they cancel the order by calling a phone number provided in the email. If you call the number provided, you will be greeted by a scammer posing as a McAfee employee who will ask for personal information, including a bank account number supposedly to verify the account. After receiving the personal information, the scammer will request a wire transfer of funds which will be nearly impossible to reverse once it is completed. The Vienna Police Department provides the following guidelines for spotting and avoiding a "phishing" email:

- Always check the sender's email. Phishing emails may look like they are from a legitimate company you trust. Most of the time, you can tell it is a phishing scam if the sender's email address consists of random numbers and letters. If you are unsure, research the email of the company.
- 2) Look for spelling and grammatical errors. Phishing emails tend to have multiple spelling and grammatical errors in them.
- 3) Phishing emails will attempt to trick you through a sense of urgency in order to click on a link or open an attachment. You can inspect the link by hovering the mouse over it without clicking on it—only open attachments from trusted and verified sources.
- 4) Phishing emails may trick you by saying:
 - a. They've noticed suspicious activity or login attempts
 - b. Claim there are account problems or problems with payment information
 - c. Ask to confirm personal information
 - d. Attach fake invoices
 - e. Provide a link to allow for a payment
 - f. Threaten to arrest
 - g. Offer money or free items

If you feel you have fallen victim to a phishing scam, please call the police non-emergency number, 703-255-6366, to report it. You can also report phishing emails to your email provider or the Federal Trade Commission (FTC) using their website.
