

## VIENNA POLICE HIGHLIGHTS

February 17, 2023

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from January 10, 2023 to February 16, 2023. Readers are reminded an "arrest" is based upon probable cause and does not always mean someone was physically taken into custody. Furthermore, it does not mean an individual is automatically guilty of a crime. Judicial outcomes and post-arrest proceedings can be researched through the appropriate court's website.

On July 1, 2021, citizens will be able to access Community Policing data via <a href="https://data.virginia.gov/stories/s/rden-cz3h">https://data.virginia.gov/stories/s/rden-cz3h</a>. The Vienna Police Department had started complying with this state law in July of 2020. The portal will contain all non-consensual investigatory stops made by the Vienna Police Departments and other law enforcement agencies in the commonwealth.

### **UPDATE** – Car Thefts and Tamperings

The National Capital Area, specifically the Northern Virginia area, has seen increased vehicle tampering incidents and vehicle thefts. A recent pattern has been identified where suspects enter the area in stolen vehicles and cruise streets between 3:00 AM and 7:00 AM. In addition to rifling through unlocked cars for valuables and money, they steal the vehicle when they encounter keys left in it. The Vienna Police Department would like to remind our community members to please stay vigilant, secure their cars and take the keys inside, and close and lock all doors of residences and garages to prevent criminals from targeting your property. Additionally, please call the police if you notice suspicious vehicles or people in your area, and share Ring doorbell or other security camera footage with us if you capture video related to these incidents. The Vienna Police Department is working closely with other Law Enforcement agencies in the region, coordinating our resources to investigate these crimes.

#### Between February 9 at 4:00 p.m. and February 11 at 11:45 a.m.

The owner of the restaurant found a contractor online to make repairs in the bakery's kitchen and to a wall. The contractor deposited the payment, and his workers began the job. The owner found the workers caused a large amount of damage instead of making any repairs and notified the contractor. The contractor agreed to cover the damage and requested another payment to finish the job. The contractor deposited the second payment but never returned to complete the work and stopped communicating with the owner.

# Arrest - Hit & Run, Driving While Intoxicated, and Assault on Police Officer 23-001247 and 23-001260

**Nutley Street and Lincoln Street, NW** 

February 10 2:00 a.m.

Vehicle-2 was traveling northbound in the right lane on Nutley Street and was slowing to make a right onto Kingsley Road. Vehicle-1 was traveling in the left lane, crossed into the right lane, and struck the rear of Vehicle-2. Vehicle-1 fled northbound on Nutley Street. Sgt. Sheeran located the vehicle and initiated a traffic stop in the area of Nutley Street and Lincoln Street, NW. The driver failed to comply with the officer's directions, and the officer detected signs of impairment. The officer placed the man under arrest and he became combative. Rescue personnel responded to assess the man and transport him to an area hospital for evaluation where he continued to be uncooperative and aggressive with the medics and hospital staff. As the officers were preparing to transport the man from the hospital to the Fairfax County Adult Detention Center he continued to resist arrest, assaulting the officers and damaging the cruiser.

Sgt Sheeran transported the 33-year-old man from Deming Drive in Gainesville, Virginia to the Fairfax County Adult Detention Center where he was charged with felony Hit & Run, felony Assault on a Police Officer, Driving While Intoxicated, Obstruction of Justice, Destruction of Property, and Refusal.

Grand Larceny 23-001273 Giant Food 359 Maple Avenue, East February 10 between 10:00 a.m. and 11:00 p.m.

A resident reported his gun was stolen from his unlocked vehicle while it was parked in the lot.

### Arrest - Abduction and Domestic Assault 23-1268 200 Block Locust Street, SE February 10 10:31 a.m.

A resident reported her adult son threatened her with a firearm, insisting she go with him to the police station to file a false report.

Det. Murray obtained four warrants and served them on the 23-year-old man from Locust Street, SE in Vienna charging Abduction, Use of a Firearm in the Commission of a Felony, Brandishing a Firearm, and Domestic Assault. An Emergency Protective Order was also served on him.

A resident reported her husband assaulted her in front of their young child. After the assault, the man took his wife's identification, credit card and left the home. The resident did not feel safe remaining in the home and made other lodging arrangements for herself and her children.

Ofc. Fitchue obtained warrants charging Domestic Assault and Credit Card Theft. Later that day, the husband came to the police station for service of the warrants. Ofc. Mayar transported the 31-year-old man from Moorefield Hill Court, SW in Vienna to the Fairfax County Adult Detention Center where the warrants and a protective order were served on him.

### **Driver Safety Tips**

The Town of Vienna Police Department is continuing to investigate the carjacking incident, which occurred on Saturday, January 28<sup>th</sup>. We would like to thank citizens who have contacted The Town Vienna Police Department seeking information on how to best prepare themselves. Listed below are some helpful tips to keep in mind if you ever find yourself in a suspicious situation:

- -Beware of your surroundings:
  - -Garage and parking lots
  - -Intersections with stop signs and traffic signals
  - -Residential streets and driveways
  - -Anywhere you need to stop or slow down

#### -When possible:

- -Park in well-lit areas
- -Stay alert
- -Stay off your phone
- -Keep your doors and windows locked while driving
- -Allow enough room between your car and the one ahead/behind you to avoid being boxed in
- -Keep your cell phone on your person, not left in the vehicle
- -If your vehicle is bumped into and you are suspicious of the incident, turn on your emergency flashers, drive to a well-lit, heavily populated area and contact the police department
- -If you are the victim of a carjacking:
  - -Give up your vehicle and leave the scene
  - -Avoid verbal or physical altercations with the suspect
  - -Take note of the suspect's description
  - -If there is a child in the vehicle, tell the suspect, "My child is in the vehicle"
  - -Call 911 immediately

If you ever find yourself in doubt of how to handle a suspicious situation, call the Town of Vienna Police Department, 703-255-6366, and ask to speak to an officer. # **Grand Larceny**

On October 25, 2022, between 1pm and 2pm, the subject pictured below is suspected of stealing a wallet from a purse of an unattended shopping cart at Giant, located in Vienna, VA. The suspect is seen on security camera approach a shopper's cart as her back was turned, reach into her purse which was in the top "seat" area of the cart and take the victim's wallet from the purse.
