

VIENNA POLICE HIGHLIGHTS

March 31, 2023

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from March 24, 2023 to March 30, 2023. Readers are reminded an "arrest" is based upon probable cause and does not always mean someone was physically taken into custody. Furthermore, it does not mean an individual is automatically guilty of a crime. Judicial outcomes and post-arrest proceedings can be researched through the appropriate court's website.

On July 1, 2021, citizens will be able to access Community Policing data via https://data.virginia.gov/stories/s/rden-cz3h. The Vienna Police Department had started complying with this state law in July of 2020. The portal will contain all non-consensual investigatory stops made by the Vienna Police Departments and other law enforcement agencies in the commonwealth.

UPDATE – Car Thefts and Tamperings

The National Capital Area, specifically the Northern Virginia area, has seen increased vehicle tampering incidents and vehicle thefts. A recent pattern has been identified where suspects enter the area in stolen vehicles and cruise streets between 3:00 AM and 7:00 AM. In addition to rifling through unlocked cars for valuables and money, they steal the vehicle when they encounter keys left in it. The Vienna Police Department would like to remind our community members to please stay vigilant, secure their cars and take the keys inside, and close and lock all doors of residences and garages to prevent criminals from targeting your property. Additionally, please call the police if you notice suspicious vehicles or people in your area, and share Ring doorbell or other security camera footage with us if you capture video related to these incidents. The Vienna Police Department is working closely with other Law Enforcement agencies in the region, coordinating our resources to investigate these crimes.

Suspicious Event 23-002231 300 Block Locust Street, SE March 9 7:04 p.m.

On March 10, a resident reported receiving a suspicious phone call the night before from an unknown individual who knew her name and made some concerning comments.

On March 20, an employee reported a shoplifting incident that occurred the previous day when a man and woman came into the store. The subjects each concealed a bottle of alcohol, then left the store without paying for the items.

Arrest – Driving While Intoxicated 23-002675 Maple Avenue and Niblick Drive, SE March 25 9:08 p.m.

An officer observed a vehicle traveling at a high rate of speed and initiated a traffic stop. Upon the officer's interaction with the driver, he detected signs of impairment. The driver failed to complete a series of field sobriety tests and was placed under arrest.

Ofc. Crandall transported the 56-year-old man to the Fairfax County Adult Detention Center where he was charged with Driving While Intoxicated and Speeding.

Arrest – Warrant Service 23-002702 Vienna Police Station 215 Center Street, South March 27 2:01 a.m.

A man and woman were traveling in a vehicle when they began having a verbal dispute and the woman drove to the police station to report the incident. Officers found no evidence of a physical assault. However, they found there were outstanding warrants for the man in Fairfax County.

Ofc. Garcia arrested the 20-year-old man from Karen Boulevard in Capital Heights, Maryland. He was transported to the Fairfax County Adult Detention Center where the two felony warrants charging Strangulation and Abduction and the misdemeanor warrant charging assault were served on him. He was held without bond.

Officers responded to assist rescue personnel with an elderly female who was unresponsive. Rescue personnel determined the woman, who suffered from medical issues, was deceased.

School staff reported a woman was in the office trying to see her son who she believes attends the school. The father has sole guardianship of their son and the woman is to have no contact with him. An officer trespassed the woman from the school and advised her she would be arrested if she returned.

CRASHES

1200 Block Cottage Street, SW 23-002230

March 10 7:58 p.m.

Vehicle-2 was legally parked on Cottage Street, SW. Vehicle-1 was traveling southbound on Cottage Street at a low speed when it sideswiped Vehicle-2 causing minor damage to the side view mirrors of both vehicles.

Three vehicles were traveling eastbound on Maple in the right lane, approaching the red traffic signal at Nutley Street. Vehicle-3 and Vehicle-2 stopped for the light. Vehicle-1 ran into the rear of Vehicle-2, pushing it into the rear of Vehicle-3.

Driver-1 was issued a summons charging Failure to Pay Full Time and Attention.

Maple Avenue and Lawyers Road, NW 23-002749 March 28 1:30 p.m.

Two vehicles were stopped in the same lane of traffic for the red traffic signal on Maple Avenue and Lawyers Road. As the light turned green, Vehicle-1 ran into the rear of Vehicle-2 causing minor damage to Vehicle-1.

East Street and Maple Avenue, NE 23-002821 March 30 9:27 p.m.

Vehicle-1 was traveling westbound on Maple Avenue and turned right onto East Street, NE. As the driver attempted the turn, they went over the curb, ran over the two signs, and struck a large decorative rock. Vehicle-1 left the scene without stopping.
