

VIENNA POLICE HIGHLIGHTS

June 16, 2023

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from June 9, 2023 to June 15, 2023. Readers are reminded an "arrest" is based upon probable cause and does not always mean someone was physically taken into custody. Furthermore, it does not mean an individual is automatically guilty of a crime. Judicial outcomes and post-arrest proceedings can be researched through the appropriate court's website.

On July 1, 2021, citizens will be able to access Community Policing data via https://data.virginia.gov/stories/s/rden-cz3h. The Vienna Police Department had started complying with this state law in July of 2020. The portal will contain all non-consensual investigatory stops made by the Vienna Police Departments and other law enforcement agencies in the commonwealth.

UPDATE – Car Thefts and Tamperings

The National Capital Area, specifically the Northern Virginia area, has seen increased vehicle tampering incidents and vehicle thefts. A recent pattern has been identified where suspects enter the area in stolen vehicles and cruise streets between 3:00 AM and 7:00 AM. In addition to rifling through unlocked cars for valuables and money, they steal the vehicle when they encounter keys left in it. The Vienna Police Department would like to remind our community members to please stay vigilant, secure their cars and take the keys inside, and close and lock all doors of residences and garages to prevent criminals from targeting your property. Additionally, please call the police if you notice suspicious vehicles or people in your area, and share Ring doorbell or other security camera footage with us if you capture video related to these incidents. The Vienna Police Department is working closely with other Law Enforcement agencies in the region, coordinating our resources to investigate these crimes.

Grand Larceny 23-005499

Center Street and John Marshall Drive, NE

Between May 18 at 5:00 p.m. and June 13 at 9:30 a.m.

An employee reported scrap copper wiring was taken from a crate at the Dominion Power Sub Station.

Animal Case – Quarantine 23-005439 200 Block Commons Drive, NW June 5 7:00 a.m.

A resident transported their dog to the Hope Advanced Veterinary Center after it was injured by their other dogs. It was unclear if the resident may have been bitten during the incident. Due to the age of the dog and its wounds, the dog was euthanized by the vet. At the request of the Health Department, the dog was transported to the Fairfax County Animal Shelter where it was tested for rabies. On June 13, the Health Department reported the rabies test was negative.

A citizen reported he had an argument with a man in the parking lot and the man struck his truck. The citizen advised he was also assaulted by the man several months prior. The citizen was advised of the warrant process should he wish to pursue charges.

Officers responding to the report of a residential alarm found an open door. The officers searched the home and observed nothing suspicious.

She also expressed her fear for her safety, citing previous incidents of physical abuse during her husband's mental health episodes. To ensure her immediate protection, an officer accompanied the wife to a magistrate to obtain an Emergency Protective Order against her husband. Subsequently, the officer served the protective order to the husband, assisted him in retrieving some personal belongings, and then escorted him out of the residence. However, at around 4:00 a.m., the wife reported her husband shouting at her outside the house.

PFC Reed arrested the 45-year-old man from Springwood Court, NE, Vienna. He was transported to the Fairfax County Adult Detention Center and charged with Violation of a Protective Order.

Officers responded to a dispute between a husband and wife. The parties agreed to separate for the night.

An employee reported she was bitten and scratched by a cat during a procedure. The employee received medical treatment for the injury. ACO Barker will follow up on this case.

On June 13, a citizen reported she passed out after drinking alcohol and using narcotics with two men behind the 7-11. When she woke up, she was being treated by rescue personnel who transported her to an area hospital for treatment. She believes one of the men she was with stole money from her wallet and took cigarettes before rescue personnel arrived.

Officers responded to the report of a man who grabbed a juvenile. An officer located the man who advised he was with the Babe Ruth Baseball League. The man explained there was a game in progress at Water's Field when a group of boys ran onto the field and interrupted the game. He stated that he chased them off the field, grabbing one of them in an attempt to bring him to the police station. The man reported there has been an ongoing issue with the games being interrupted by juveniles. An officer located the juveniles involved and their parents. The juveniles stated they were with their soccer team at the Vienna Inn when they decided to go to Water's Field and climb the fence onto the ballfield. They advised they did not realize they were interrupting a game until a man began chasing them. The father of the juvenile who was grabbed was advised of the incident and will decide if he wishes to pursue assault charges.

The Fairfax County Police Department received a report of a sexual assault. They believe the assault may have occurred in the parking lot of the Navy Federal Credit Union between a man and a woman who had become acquainted through an online dating application. A detective will follow up on this investigation.

The Vienna Police Department Launches Stop Sign Enforcement Campaign

The Town of Vienna is launching another traffic safety campaign focused on enforcing all traffic laws, particularly targeting stop sign violations. In response to a noticeable increase in such violations, officers will be actively present to issue tickets and remind drivers about the importance of coming to a complete stop when approaching a stop sign. Whether facing a solid or flashing red light, drivers must stop before entering the crosswalk, intersection, or stop line. It's worth noting that, under certain circumstances, a stop sign violation can be cited as reckless driving.

Motorists who receive a ticket for a stop sign or red light violation will face a fine and three demerit points on their driving record. The Vienna Police Department emphasizes the need for defensive driving, courteous behavior, and strict adherence to all traffic laws to ensure safe arrival at destinations.

Remember: STOP MEANS STOP!
