

VIENNA POLICE HIGHLIGHTS

June 23, 2023

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from June 16, 2023 to June 22, 2023. Readers are reminded an "arrest" is based upon probable cause and does not always mean someone was physically taken into custody. Furthermore, it does not mean an individual is automatically guilty of a crime. Judicial outcomes and post-arrest proceedings can be researched through the appropriate court's website.

On July 1, 2021, citizens will be able to access Community Policing data via https://data.virginia.gov/stories/s/rden-cz3h. The Vienna Police Department had started complying with this state law in July of 2020. The portal will contain all non-consensual investigatory stops made by the Vienna Police Departments and other law enforcement agencies in the commonwealth.

UPDATE – Car Thefts and Tamperings

The National Capital Area, specifically the Northern Virginia area, has seen increased vehicle tampering incidents and vehicle thefts. A recent pattern has been identified where suspects enter the area in stolen vehicles and cruise streets between 3:00 AM and 7:00 AM. In addition to rifling through unlocked cars for valuables and money, they steal the vehicle when they encounter keys left in it. The Vienna Police Department would like to remind our community members to please stay vigilant, secure their cars and take the keys inside, and close and lock all doors of residences and garages to prevent criminals from targeting your property. Additionally, please call the police if you notice suspicious vehicles or people in your area, and share Ring doorbell or other security camera footage with us if you capture video related to these incidents. The Vienna Police Department is working closely with other Law Enforcement agencies in the region, coordinating our resources to investigate these crimes.

An employee reported a man entered the store, emptied the contents of the tip jar, then fled the area.

Between June 6 at 3:24 p.m. and June 19 at 3:24 p.m.

A resident reported they mailed a check at the post office, then later found the check was stolen, forged, and passed.

Grand Larceny 23-005136 Giant Food 359 Maple Avenue, East June 6 3:30 p.m.

An elderly resident reported someone stole her purse from her shopping cart while she was in the store. She was later notified by her credit card company that there were unauthorized transactions on her credit card.

A construction contractor reported someone dumped a washing machine into their dumpster. A witness provided the officer with a description of the man who dumped the washing machine and the vehicle he was driving. The officer contacted the man who agreed to respond to the site and remove the machine from the dumpster.

Suspicious Event 23-005480 Maple Avenue and Niblick Drive, SE June 13 6:10 a.m.

An Uber driver reported he became involved in an argument with his passenger over driving directions. The passenger exited the vehicle on Maple Avenue, then quickly realized he wanted back in the vehicle, which the driver refused. The passenger fled the area when the driver called for police assistance.

Animal Case 23-005573 1100 Block Ware Street, SW June 14 12:00 p.m.

A resident reported his neighbor's cats are continuously on his property and defecating in his yard. ACO Barker informed the resident that no ordinance prohibits cats from roaming onto other's property. ACO Barker spoke to the neighbor and advised her of the resident's complaint regarding her cats.

Missing Person – Juvenile 23-005837 200 Block Cedar Lane, SE Between June 14 at 6:00 p.m. and June 19 at 10:19 a.m.

A resident had previously reported her teenage daughter left the apartment with her infant grandson without permission (*reference June 16 Vienna Police Highlights Incident #23-005593*). The two juveniles were located in Baltimore, Maryland with the infant's father and his family and were cleared from the system.

On June 19, the resident reported her daughter and grandson had not returned home. The juveniles were again entered as missing into the national database. Detectives are investigating this case.

Civil Case 23-005671 200 Block Cedar Lane, SE June 16 10:00 a.m.

An employee with a social services department reported they evicted a man from one of their apartments on June 5. They have since found the man's brother has been living there. Officers attempted to contact the brother, however, no one answered the door. The employee was advised this was a civil matter and that they would need to contact the Fairfax County Sheriff's Department for further assistance in this case.

Officers responded to the report of a man playing the violin and collecting money in the parking lot after being asked by management to leave the premises. The man quickly left the area as he saw officers arriving. A short time later, an employee called to report the man had returned. The employee further advised they had been having issues with the man for a few weeks.

PFC Sterling issued a summons to the 30-year-old man from S. Gillfield Drive in Petersburg, Virginia charging Trespassing. The man was released on his signature.

Two vehicles were traveling southbound on Beulah Road. The vehicles were waiting in traffic at a red traffic signal when Vehicle-1 ran into the rear of Vehicle-2.

Vehicle-1 was traveling southbound, attempting to turn into the parking lot of 118 Park Street, SE. Vehicle-2 was traveling northbound on Park Street. There was a vehicle stopped in front of Vehicle-1 attempting to turn left into another parking lot. Vehicle-2 went around the right of the vehicle in front of her and collided with Vehicle-1 as they were turning.

The emergency technology company, **RapidSOS**, has partnered with the American Heart Association, American Red Cross, and Direct Relief to sponsor a no-cost voluntary health database. RapidSOS is an intelligent safety platform that securely links life-saving data from 500M+ connected devices, apps, and sensors from 90+ global technology companies to over 450,000 first responders across 15,000 agencies nationwide. Whether there's an unsafe moment or an emergency, RapidSOS Ready devices, homes, or buildings deliver essential data to first responders when it matters most.

Town of Vienna residents may create a free emergency health profile that can be easily shared with first responders during a crisis or emergency to ensure they can access your critical health and medical information when you need help. Your created profile provides real-time details about your medical history, emergency contacts, allergies, etc. It only takes a few minutes to set up and is voluntary.

You can enter behavioral health information, pre-existing medical conditions, allergies, emergency contacts, and other relevant details into the database. This information is associated with your mobile phone number and will only be available to first responders when they receive an emergency call from your provided telephone number. You can choose the amount of information you provide based on your discretion.

Regularly reviewing and updating your profile is vital to ensure first responders have the most up-to-date information, especially after significant health or life changes.

The Vienna Police Department Launches Stop Sign Enforcement Campaign

The Town of Vienna is launching another traffic safety campaign focused on enforcing all traffic laws, particularly targeting stop sign violations. In response to a noticeable increase in such violations, officers will be actively present to issue tickets and remind drivers about the importance of coming to a complete stop when approaching a stop sign. Whether facing a solid or flashing red light, drivers must stop before entering the crosswalk, intersection, or stop line. It's worth noting that, under certain circumstances, a stop sign violation can be cited as reckless driving.

Motorists who receive a ticket for a stop sign or red light violation will face a fine and three demerit points on their driving record. The Vienna Police Department emphasizes the need for defensive driving, courteous behavior, and strict adherence to all traffic laws to ensure safe arrival at destinations.

Remember: STOP MEANS STOP!
