

### VIENNA POLICE HIGHLIGHTS

July 21, 2023

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from July 14, 2023 to July 20, 2023. Readers are reminded an "arrest" is based upon probable cause and does not always mean someone was physically taken into custody. Furthermore, it does not mean an individual is automatically guilty of a crime. Judicial outcomes and post-arrest proceedings can be researched through the appropriate court's website.

On July 1, 2021, citizens will be able to access Community Policing data via <a href="https://data.virginia.gov/stories/s/rden-cz3h">https://data.virginia.gov/stories/s/rden-cz3h</a>. The Vienna Police Department had started complying with this state law in July of 2020. The portal will contain all non-consensual investigatory stops made by the Vienna Police Departments and other law enforcement agencies in the commonwealth.

### **UPDATE – Car Thefts and Tamperings**

The National Capital Area, specifically the Northern Virginia area, has seen increased vehicle tampering incidents and vehicle thefts. A recent pattern has been identified where suspects enter the area in stolen vehicles and cruise streets between 3:00 AM and 7:00 AM. In addition to rifling through unlocked cars for valuables and money, they steal the vehicle when they encounter keys left in it. The Vienna Police Department would like to remind our community members to please stay vigilant, secure their cars and take the keys inside, and close and lock all doors of residences and garages to prevent criminals from targeting your property. Additionally, please call the police if you notice suspicious vehicles or people in your area, and share Ring doorbell or other security camera footage with us if you capture video related to these incidents. The Vienna Police Department is working closely with other Law Enforcement agencies in the region, coordinating our resources to investigate these crimes.

If you see suspicious activity or persons, we ask you to immediately notify the police department at 703-255-6366 or, in case of emergency call 911.

#### *INCIDENTS*

Animal Case 23-006731 200 Block Cherry Street, SW July 9 12:00 p.m.

A resident reported she has been trying to "Trap-Neuter-Return," the feral cat colony in her neighborhood. TNR, is a program where feral cats are humanely trapped, sterilized, vaccinated, and given necessary veterinary care, then returned to their outdoor homes. The resident reported her neighbors are feeding the cats, making it difficult for her to trap them. ACO Barker explained the situation to the neighbor, who agreed to stop feeding the cats.

Welfare Check 23-006737 Vienna Police Station 215 Center Street, South July 14 1:40 p.m.

A manager from Whole Foods came to the police station to request a welfare check on an employee they had not heard from in a few days and were unable to reach by phone. Our department sent a teletype to the Fairfax County Police Department requesting officers check the employee's residence in Reston, Virginia.

Arrest – Alcohol Violation 23-006749 100 Block Patrick Street, SE July 14 8:23 p.m.

An officer was on patrol when he observed five individuals drinking alcohol in the parking lot.

PFC Garcia issued a summons to each of the men charging Drinking In Public. A 59-year-old man from Mineral Springs Drive in Manassas, Virginia, a 27-year-old man from Cedar Lane, SE in Vienna, a 59-year-old man from Hume Court in Bristow, Virginia, a 41-year-old man with no fixed address, and a 55-year-old man from South Buchanan Street in Arlington, Virginia were all released on their signatures.

Arrest – Drunk In Public 23-006764 200 Block Cedar Lane, SE July 14 11:13 p.m.

An officer was on patrol when he observed a man screaming at people. Upon the officer's interaction with the man, he detected signs of impairment. The man refused to provide the officer with his identification.

PFC Mayar arrested the 44-year-old man with no fixed address. The man was transported to the Fairfax County Adult Detention Center and charged with Drunk In Public.

A woman spoke to an officer regarding court orders issued through Fairfax County concerning the custody of her children. The officer referred her to the courts and Fairfax County Police, where her children reside with her ex-husband.

An employee reported a man and woman came into the store and stole a bottle of alcohol, then fled the area in a vehicle. The same individuals were involved in previous shoplifting cases from this store.

Officers responded to the area for the report of a fight in progress involving two groups of people. They determined an assault had occurred at 7-11, 9616 Park Street, in Fairfax County's jurisdiction, and Fairfax County Police handled the investigation. One of the people involved left the scene before officers arrived, then later returned acting disorderly and raising the tensions again between the two groups. Upon the officer's interaction with the man, they detected signs of impairment.

Ofc. Harshfield arrested the 28-year-old man from Patrick Street, SE in Vienna. He was transported to the Fairfax County Adult Detention Center and Charged with Drunk In Public.

Officers responded to a welfare check on an elderly woman. The woman's sister reported the woman has been suffering from mental health issues. A mental health care provider responded to the residence, evaluated the woman, and advised the officer to obtain an Emergency Custody Order (ECO). PFC Sterling transported the woman to an area hospital for further evaluation and treatment on the ECO.

The business owner reported an incident with his employees when a man came in asking for a glass of water. When the employee handed the man a straw, he grabbed her wrist. The man let go as she pulled away and the other employee stepped in. The employees asked the man to leave and he complied.

During a traffic stop, when an officer interacted with four juvenile occupants of the vehicle, she detected an odor of alcohol. The driver reported his friends were drinking alcohol at another friend's house and contacted him to drive them home. The driver had not consumed any alcohol. The parents of the juveniles were notified and responded to the scene to take custody of their children.

RapidSOS is an intelligent safety platform that securely links life-saving data from 500M+ connected devices, apps, and sensors from 90+ global technology companies to over 450,000 first responders across 15,000 agencies nationwide. Whether there's an unsafe moment or an emergency, RapidSOS Ready devices, homes, or buildings deliver essential data to first responders when it matters most.

Town of Vienna residents may create a free emergency health profile that can be easily shared with first responders during a crisis or emergency to ensure they can access your critical health and medical information when you need help. Your created profile provides real-time details about your medical history, emergency contacts, allergies, etc. It only takes a few minutes to set up and is voluntary.

You can enter behavioral health information, pre-existing medical conditions, allergies, emergency contacts, and other relevant details into the database. This information is associated with your mobile phone number and will only be available to first responders when they receive an emergency call from your provided telephone number. You can choose the amount of information you provide based on your discretion.

Regularly reviewing and updating your profile is vital to ensure first responders have the most up-to-date information, especially after significant health or life changes.
