

VIENNA POLICE HIGHLIGHTS

August 18, 2023

The following summary contains various incidents of general interest as well as vehicular crashes handled by the Town of Vienna, Virginia Police Department from August 4, 2023 to August 10, 2023. Readers are reminded an "arrest" is based upon probable cause and does not always mean someone was physically taken into custody. Furthermore, it does not mean an individual is automatically guilty of a crime. Judicial outcomes and post-arrest proceedings can be researched through the appropriate court's website.

On July 1, 2021, citizens will be able to access Community Policing data via <u>https://data.virginia.gov/stories/s/rden-cz3h</u>. The Vienna Police Department had started complying with this state law in July of 2020. The portal will contain all non-consensual investigatory stops made by the Vienna Police Departments and other law enforcement agencies in the commonwealth.

UPDATE – Car Thefts and Tamperings

The National Capital Area, specifically the Northern Virginia area, has seen increased vehicle tampering incidents and vehicle thefts. A recent pattern has been identified where suspects enter the area in stolen vehicles and cruise streets between 3:00 AM and 7:00 AM. In addition to rifling through unlocked cars for valuables and money, they steal the vehicle when they encounter keys left in it. The Vienna Police Department would like to remind our community members to please stay vigilant, secure their cars and take the keys inside, and close and lock all doors of residences and garages to prevent criminals from targeting your property. Additionally, please call the police if you notice suspicious vehicles or people in your area, and share Ring doorbell or other security camera footage with us if you capture video related to these incidents. The Vienna Police Department is working closely with other Law Enforcement agencies in the region, coordinating our resources to investigate these crimes.

An employee reported a man who was yelling at customers. The employee trespassed the man from the premises, but he still refused to leave. Upon the officers' interaction with the man, they detected signs of intoxication. The officers attempted to arrest the man when he advised he was injured and requested EMS. Rescue personnel responded for a small cut on the man's finger and he insisted on being transported to a hospital for treatment. PFC Reed went to the magistrate's office and obtained a warrant charging Trespassing and a summons charging Drunk In Public.

An officer observed a driver commit a traffic violation and initiated a traffic stop. Upon the officer's interaction with the driver, he found she was in possession of marijuana.

An officer observed a man sleeping at the bus stop. While checking on the man's well-being, the officer detected signs of intoxication.

PFC Mayar arrested the 51-year-old man from Hardison Lane in Greenville, Kentucky. He was transported to the Fairfax County Adult Detention Center and charged with Drunk In Public.

The officer noticed the man matched the description of the suspect in the security video. PFC Mayar arrested the 38-year-old man with no fixed address. Approximately two hours later, the man called a mental health line making concerning comments. Officers responded back to the home and spoke to the man. The man was advised of the services available to him but he did not require any further assistance.

A citizen went to a residence to pick up her dog from the woman who takes care of her pet. She found the woman suffering a medical emergency and called for EMS to respond. Rescue personnel transported the woman to an area hospital for treatment. The citizen was concerned for the other dogs in the home the woman was caring for. A tenant who lives in the house agreed to take care of the animals while the woman was in the hospital.

200 Maple Avenue, East 23-007353 August 2 12:56 p.m.

Vehicle-2 was legally parked when it was struck by Vehicle-1. Driver-1 fled the scene without providing their information.

Ayr Hill Avenue and the W&OD Bike Trail, NE 23-007601 August 12 10:05 a.m.

Vehicle-2 was traveling eastbound on Ayr Hill Avenue approaching the bike trail. Vehicle-1 (a bicycle) was southbound on the bike trail. Vehicle-1 entered the intersection and was struck by Vehicle-2, knocking him to the ground. Both vehicles were traveling at a low speed and damage was minimal. Driver-1 was transported by rescue personnel to an area hospital with non-life-threatening injuries.

Vehicles 2, 3, 4, 5, and 6 were all stopped in traffic westbound on Maple Avenue. Vehicle-2 was in the left turn lane to access Branch Road. The other vehicles were in the left through lane. Vehicle-1 exited the shopping center onto Branch Road, went through the Exxon parking lot, and onto Maple Avenue colliding with Vehicle-2. Vehicle-1 continued into the next lane, striking Vehicle-3 and Vehicle-5. Vehicle-3 was pushed back in its lane and struck Vehicle-4. Vehicle-5 was pushed forward and struck Vehicle-6.

Driver-1 was issued a summons charging Failure to Maintain Proper Control.

300 Block Maple Avenue, East 23-007606

Two vehicles were traveling westbound on Maple Avenue in adjacent lanes. Vehicle-1 changed lanes from the right lane to make a left into the Exxon Gas Station and struck Vehicle-2 in the left lane causing minor damage to both vehicles.

Vehicle-1 was traveling westbound on Church Street, turning left onto southbound Lawyers Road. Vehicle-2 was traveling eastbound on Church Street, proceeding straight through the intersection of Lawyers Road when the two vehicles collided.

Police Officer First Class Alex Murray Named Vienna Optimist Club's Charles A. Robinson 'Respect for Law' Award Recipient

The emergency technology company, **RapidSOS**, has partnered with the American Heart Association, American Red Cross, and Direct Relief to sponsor a no-cost voluntary health database. RapidSOS is an intelligent safety platform that securely links life-saving data from 500M+ connected devices, apps, and sensors from 90+ global technology companies to over 450,000 first responders across 15,000 agencies nationwide. Whether there's an unsafe moment or an emergency, RapidSOS Ready devices, homes, or buildings deliver essential data to first responders when it matters most.

Town of Vienna residents may create a free emergency health profile that can be easily shared with first responders during a crisis or emergency to ensure they can access your critical health and medical information when you need help. Your created profile provides real-time details about your medical history, emergency contacts, allergies, etc. It only takes a few minutes to set up and is voluntary.

You can enter behavioral health information, pre-existing medical conditions, allergies, emergency contacts, and other relevant details into the database. This information is associated with your mobile phone number and will only be available to first responders when they receive an emergency call from your provided telephone number. You can choose the amount of information you provide based on your discretion.

Regularly reviewing and updating your profile is vital to ensure first responders have the most up-to-date information, especially after significant health or life changes.
