# Park Street Public Hearing

The Town Council will hold a public hearing on the proposed reconstruction of Park Street, S.E., on Monday, November 30, at 8 p.m. in the Council Chamber at Town Hall.

The proposed project includes the reconstruction of the road pavement from Maple Avenue to Fardale Street, addition of curb and gutter, installation of sidewalk on the west side of Park Street, and installation of storm drainage structures and pipe. Some pavement widening would be involved, with the following proposed face-ofcurb to face-of-curb widths:

From Maple Avenue to Locust Street - 40 feet

From Locust Street to Dominion Road - 36 feet

From Dominion Road to Cherry Street - 33 feet From Cherry Street to Moore Avenue

- 30 feet From Moore Avenue to 110 feet south of Elmar Drive - 33 feet

From 110 feet south of Elmar Drive to Adahi Road - 30 feet

From Adahi Road to McHenry Street - 36 feet

From McHenry Street to Fardale Street - 30 feet

Horizontal and vertical realignment would take place between Kingsley Road and Fardale Street.

A survey of the proposed construction area showed that approximately 40 trees would be removed as a result of the project. Twenty of these are either dead or dying.



As Transportation Chairman, not only does he arrange for dozens of rides each week to doctors' offices and other destinations for those with no other means of transportation, but he personally drives scores of people himself, averaging 9,000 miles every year. Moreland was a founding member of CHO and has also been active with AARP, NARFE, and the "Silver-Haired Legislature."



# Time for Dog Licenses, Rabies Shots

1988 Town of Vienna dog tags go on sale November 2. All dogs over six months old are required to be licensed.

Dog tags cost \$5 each and may be purchased in the Finance Department at Town Hall. A current rabies vaccination certificate for each dog must be presented at the time of purchase.

To purchase a dog tag by mail, complete the application form on this page and return it with your check payable to Town of Vienna and the dog's current rabies certificate. Send to: Finance Department, Town of Vienna, 127 Center St., S., Vienna, VA 22180.

The rabies certificate will be returned with the dog tag.

A low-cost rabies vaccination clinic will be held at the Fairfax County Animal Shelter, 4500 West Ox Rd. in Fairfax, on Sunday, November 22, from 12 noon to 2 p.m. All cats and dogs over six months old must be vaccinated.

Vaccine for animals over six months old costs \$6 and gives protection from rabies for three years. Vaccine for animals under a year old costs \$4 and protects for one year. Certificates will be given to pet owners at the clinic to verify each vaccination.

In bringing pets to the clinic, dogs should be on a leash and cats confined to a box or basket. For more information, call 830-1100.

# Historic Cemetery To Be Dedicated

# Town Should Keep Twice Yearly Cleanups

In response to last month's Citizen Comment that one Town Cleanup in the fall would be sufficient, a Cottage Street resident said, "I agree!" that the Spring Cleanup is an eyesore when flowers and trees are in bloom.

Two other citizens, however, were in favor of twice yearly Cleanups. A Church Street resident wrote:

I believe it is in the best interest of all citizens that the Town of Vienna has two Cleanups during the year. It is better for each quadrant to suffer for one week twice a year than to suffer the entire year. We've just come back from England, and it is amazing how little litter there is. Our opinion, though, is that the United States of America is the best place to live and to be, even if we do have to suffer with litter — and trash on the roads set out to be picked up twice a year.

This Town does so much for its citizens, and we often neglect or forget to thank those concerned.

So, Town of Vienna employees, all of you, thank you very much for making me happy to live in this town!

A Hillside Circle resident had these comments:

I have a good deal of sympathy with

my neighbor who was hindered from enjoying the spring flowers because of the Town's Spring Cleanup. However, I must strongly disagree with the suggestion that the Spring Cleanup be, therefore, abolished.

One of the nice things about being a "Viennese" has been, over the years, the sense of small-town personal involvement in a small cosmos within a large metropolitan area. Of the many little extra services with which our Mayor and his administrations have provided us, not the least of these is the twice-a-year Cleanup (as well as the collection of leaves in the fall).

The Spring Cleanup is particularly significant because, after the kind of winters we usually "enjoy," there is always a great deal of downed branches, dead debris along the fences, windblown roof tiles, etc., which need to be cleaned out of the yard and removed. In addition, it is also the time when repairs must be made to winter damage, and when our spirits need the lift of sprucing up inside the house as well as in the garden. Hence, the disposal of old appliances, etc. (Actually, contractors/carpenters/plumbers/etc., who perform such indoor sprucing up usual-

ly will remove old appliances as they are replaced, as part of their work contract, so that not every house getting rid of counters, toilets, basins, or whatever uses the Town's good services for this.)

I don't know that this is necessarily a question of "either/or," but if I were forced to give up one Cleanup a year, I would more readily give up the Fall Cleanup (but not the leaf collection, of course). However, I would want to know precisely what service or benefit I'd be receiving in return for forfeiting that one Cleanup.
