FY 88-89 Budget Adopted

The Town Council has adopted a budget for fiscal year 1988-89 totaling \$11,484,584. This is an increase of \$507,388, or 4.62% over last year.

GENERAL FUND

The General Fund budget of \$8,104,-279 is based on a real estate tax rate of 30¢ per \$100 of assessed valuation, which represents an effective tax increase of 7.95% due to reassessment of properties by Fairfax County even though the tax rate has been reduced by one cent.

Some highlights of the budget include:

- · Establishment of a program to begin the systematic cleaning of the Town's stream valley parks.
- Purchase of a street vacuum machine to clean Vienna's commercial areas of litter.
- · A significant increase in funding in the Parks and Recreation Department to provide for operation and maintenance expenses for the Community Center addition, rehabilitation work in the older portion of the Community Center, and upgraded maintenance of Town parks.
- Implementation of a classification and compensation plan for Town employees.

WATER & SEWER FUND

The Water and Sewer Fund budget is \$3,380,305, based on new water rates of \$1.12 per 1,000 gallons for town residents and \$1.50 for out-oftown customers, and a sewer rate for all customers of \$2.31 per 1,000 gallons of water used. This 10% increase is necessary to keep the Water and Sewer Fund in sound financial condition and to fund a renewal and replacement account to offset a portion of the

Town Council Action

MAY 23, 1988

- Conducted a public hearing on a proposal to remove provisions for "lot averaging" from the Town Code.
- Following a public hearing, adopted increases in water and sewer rates for fiscal year 1988-89.
- Approved a request to retain a basketball backboard in Town right-ofway on Onondio Circle, and directed that an ordinance be drafted to permit the backboard to remain on the street. The backboard is to be located between 411 and 412 Onondio Circle and safety precaution signs installed. Questions of insurance and Town liability will be investigated.
- Adopted the Town budget for fiscal year 1988-89 and set tax rates as follows: real estate, 30¢ per \$100 valuation; bank net capital, 30¢ per \$100 valuation; utility tax, 20% of first \$15 for residential and 15% of first \$300 for commercial.
- Approved the landscape plan for Anita's Restaurant, 521 Maple Ave., E., with the stipulation that the two red maple trees shown on the plan be a minimum of three-inch caliper and not less than 10 feet tall.
- Approved the final plat for the resubdivision of the property at 511 Marshall Rd., S.W., contingent on the existing residence becoming a conforming building on its existing lot.
- Requested the Virginia Department of Transportation to continue supervising the installation of the traffic signal at Beulah Road and Church Street.
- Amended the contract for machinelaid asphalt for the asphalt overlay of MacArthur Avenue, John Marshall Drive and McKinley Street at a cost of \$27,126, from the General Fund.
- Awarded a bid for a desktop publishing system to Applied Time Division, Inc., at a price of \$8,287, from the Capital Projects Fund.

Originally specializing in radar transponders, the company now designs and manufactures both target and reconnaissance tracking and command radar systems, interference resistant data links, location and navigation beacons, ranging systems, antennae and microwave devices, special test equipment and other special devices for target drones and unmanned vehicles. Vega systems are currently in operation on major U.S. ranges and in numerous foreign countries.

Vega employs approximately 350 people, including many Vienna residents, in engineering, design, development and manufacturing.

Lawn Mower Safety Is a Must

Lawn mower accidents cause 62,000 injuries annually in the U.S. Most of these injuries can be prevented by following safety practices while working with mowers. Here are some tips for a safe lawn maintenance season from the Fairfax County Fire and Rescue Department:

- Never smoke while refueling your mower. Gasoline is very explosive.
- Wait for your mower to cool down before refueling. Wipe up spills immediately. Never refuel a running mower.
- Inspect electric mower cords for damage. Frayed insulation added to a metal mower and damp grass can cause lethal shocks or severe electrical burns.
- Never leave your mower without turning it off. It only takes a second for an unattended mower to cause an accident.
- Never, never reach under a mower while it is still running. Disconnect the spark plug or unplug the electric cord before reaching underneath.
- Leave blade sharpening and electric repairs to the professionals.

Be Cautious About Radon Tests

Radon, an odorless, colorless and tasteless gas, has gained much attention in the past few months as people have become aware of the radon problem and are testing their homes. With this increased consumer interest, so too has the number of radon testing and remediation methods and firms increased. The Fairfax County Department of Consumer Affairs cautions citizens to protect themselves by taking the following steps:

Become informed about radon. Copies of two EPA brochures, "A Citizen Guide to Radon" and "Radon Reduction Materials," are available at County libraries. The Fairfax County Health Department also has citizen radon information packages available. To obtain one, call the Radon Hotline, 246-2300. Read closely the information in the packet on how radon is detected.

- If someone comes to the door selling a test kit or offering to test a home on the spot, two things should be done. First ask to see a Town of Vienna peddlers or solicitors license. If the person has none, citizens should not do business with the salesperson and should report this activity to the police at 255-6366. Second, citizens should ask to see a copy of the letter indicating that the firm has demonstrated proficiency in the EPA testing program (or check the name of the firm against the list of EPA proficiency test participants in the County radon information package mentioned above). · Bear in mind that due to the high expense of equipment capable of making on-the-spot tests ("grab samples"), it is unlikely that a genuinely qualified test firm will go door-to-door in this

If do-it-yourself test kits purchased by mail, from a store, or at your door are used, carefully follow the directions on the kit or the test may be inaccurate.

If, after receiving the test results, a firm recommends remedial action be taken, check the advice against the radon reduction/mediation techniques described in the EPA brochures or the citizens information packet. Again, citizens should protect themselves by taking the following steps:

Ask the firm to prepare a detailed estimate of the work to be done, separately stating parts and labor.

Ask the firm for qualifications such as training and experience in radon reduction methods, any references it may have (since radon reduction is a relatively new business, few firms will have extensive experience or references) and any professional/occupational licenses or certificates the people performing or supervising the job will have (there currently are no licensing/certificate requirements specific to radon reduction).

Check with the Fairfax County Department of Consumer Affairs at 359-9161 to see if the firm has had complaints filed against it and, if so, how they were resolved.

make sure that a contract is prepared that matches the terms agreed upon and includes provisions for follow-up testing/monitoring to ensure that the steps taken are reasonably effective; that the bulk of the payment of the contract price is to be made upon completion of the work, not in advance; that a schedule of work is set forth from start-up through completion dates; that the firm has responsibility for getting any permits for work to be done; and that the firm is insuring the risk of any injury to its employees.

Get any guarantees in writing. Since the effectiveness of any particular reduction method is not totally within the control of a contractor and is difficult to predict precisely, a guarantee that the work will be 100% successful may be unrealistic.

Purchasing Agent Certified

Town of Vienna Purchasing Agent Janet Berrier has received certification from the National Institute of Governmental Purchasing as a Professional Public Buyer (PPB). This honor recognizes professional competence in the field of public purchasing.

The Professional Public Buyer concept was developed to demonstrate that a prescribed level of achievement in public or governmental purchasing has been attained. The basic eligibility requirements for the PPB are four years purchasing experience, two years of which must be in a public purchasing position, and successful completion of a four-hour written examination on purchasing functions, organization and coordination.

To maintain their certification, Professional Public Buyers must demonstrate continued advancement through professional association memberships, education and training, and related activities.

Gifts of Sight

The Vienna Lioness Club thanks the residents of Vienna for their generous contributions of used eyeglasses for its program to restore sight. For those who can't afford to see, sight is the greatest gift of all. Collection boxes are located at the Vienna Community Center and Patrick Henry Library.

Lot Averaging Repealed


At its regular June 6 meeting, the Town Council voted unanimously to remove the "lot averaging" provisions from our residential zoning ordinance.

Our zoning ordinance reserves three zones primarily for single-family detached dwellings; namely the RS-10, RS-12.5, and RS-16 zones. The RS-10 zone, which requires that each house be situated on a lot of at least 10,000 square feet, has not been changed. The RS-12.5 zone formerly provided that, for approved subdivisions, the average lot size must be 12,500 square feet, but that so long as the average was satisfied, some lots might be as small as 10,500 square feet. Similarly, in the RS-16 zone, lots were required to average 16,000 square feet, but a minimum lot size of 14,000 square feet was permitted.

The Town Council became increasingly concerned as it observed the repeated use of "lot averaging" to design unattractively dense subdivisions and subdivisions with grossly irregular lot shapes, and thereby sidestep Vienna's well established limited growth, low-density land use policy. The repeal of "lot averaging" means that hereafter all new subdivision lots in the RS-12.5 zone must be at least 12,500 square feet, and that all new lots in the RS-16 zone must be at least 16,000 square feet.

It is the Council's feeling that the majority of people in Town really desire to preserve the low-density land use concept, and we feel that by reducing the number of homes permitted per acre of land in new subdivisions, this concept will be enhanced.

During our public hearing on this matter, opponents of the change argued that by increasing average lot size in new subdivisions, the Council would effectively raise the cost of housing to the public. We pointed out, however,

that the price of a new home is much less related to the cost of land than it is to the maximum market value of the home. Thus, we have some new homes in Town on which the price has increased by more than \$100,000 during construction and well after most of the costs were fixed.

My Town Council colleagues and I very much hope that our continued commitment to a conservative land use policy will meet with acceptance in the community.

cost of line replacement and other capital improvements.

Based on an average use of 25,000 gallons of water per quarter, in-town users of the system will see their bills increase from \$31 to \$89.75 every three months. In an effort to reduce the effect of the rate increase, the Town will no longer charge a sewer fee on water that is subject to the excess use charge. Therefore, customers whose water use increases drastically during the summer due to watering of lawns and gardens will see a reduction in the sewer portion of their bills. For example, if the average user of 25,000 gallons per quarter used 40,000 during the summer, he would have paid \$145.80 under the old system that charged sewer fees on all consumption. Under the new system that does not charge a sewer fee for water used at the excess use rate, that bill will now be \$120.41.

A summary of this year's budget is given on the front page of this News-letter. Complete copies of the adopted budget are available for public review in the Human Resources Office at Town Hall.




