

## Hearing August 1

## Town Asks Share of Bonds For Commercial Improvements

The Fairfax County Board of Supervisors has scheduled a public hearing for Monday, August 1, at 7:30 p.m. on five bond referenda questions posed for the general election in November. The public hearing will be held in the Board Room on the "A" level of the Massey Building, 4100 Chain Bridge Rd. in Fairfax City.

The proposals call for issuing bonds to provide for schools (\$178.9 million), parks and park facilities (\$91.5 million), human services (\$16.8 million), storm drainage improvements (\$12 million), and commercial and redevelopment areas (\$30.8 million).

ers will answer "ves" or "no" to each question individually.

Of particular interest to the Town of Vienna is the commercial and redevelopment areas question, which proposes a total of \$30.8 million, with \$21.1 million for physical improvements including placing utilities underground, sidewalk construction, street lighting, street furniture, tree plantings and other pedestrian amenities. Central business areas earmarked for these improvements are Annandale, Bailey's Crossroads, Springfield, Route 1 and McLean. The Vienna Town Council has asked the County Board of Supervisors for a portion of these funds for improvements to Vienna's central business district such as new sidewalks, new driveway cuts and aprons, and improved landscaping.

## Is Your Number Up? Address Must Be Visible

It's 2 a.m. and that unforeseen fire or medical emergency occurs. You dial 911 and feel confident that help will soon be there. You can hear the sirens coming, you can see the red lights reflecting off the trees. But wait, they didn't stop. They went too far. Maybe the emergency response crew couldn't see your address.

This scenario occurs every day. Precious time is wasted looking for the location of an accident or other emergency because the address is not properly posted. It is a law in the Town of Vienna that every building address must be posted in a manner as to be visible and distinguishable from the street. Violation of this law is a misdemeanor.

Script writing may look appealing, but try to read it on a dimly lit street from a moving vehicle. Large numerals on a color-contrasting background are much easier to read.

Be sure your house number is large and clear enough to be read from the street. It could prove to be a lifesaver should the unforeseen emergency occur.

  - ♦ Identification of the nominee
  - A description of the achievement as such, and a description of the nominee's role, extent of responsibility and extent to which the achievement exceeds normal performance or business activity or has contributed significantly to the betterment of the community
  - Citations of tangible evidence demonstrating the stature of the achievement
  - Identification of the nominator
- 2. To the extent feasible, supplement the basic nomination statement with pertinent exhibits, such as documents, testimonials, news stories, or other similar supporting evidence.
- 3. If the nominator wishes to have any of the supporting material when it has served its purpose, this should be clearly specified.
- 4. Note the cover sheet form on the reverse side of this page. It is designed to provide quick, positive identification of each nomination. Use the reverse side as the cover page for your nomination.

## Residential Development Highlights

Residential development activity within the Town of Vienna has significantly increased. The notion that there is almost no buildable land available in Vienna is misleading.

Since January 1, 1988, the Town Council has processed 16 applications for changes in zoning or for the subdivision of land. When these applications are taken individually, it appears to be business as usual. But when viewed on a town-wide basis, an entirely different pattern begins to emerge. In the larger sense, it means that our neighborhoods are changing, green space is slowly diminishing, and the original layout of some of our streets is being reshaped through the addition of many new cul-de-sacs.

The resubdivision of larger tracts into smaller residential lots with the addition of short cul-de-sac streets will have an impact on the local residential streets. Our local streets were designed and planned for a lower volume of traffic than is currently being experienced, and as new growth occurs, this disparity between traffic volumes and available capacity will continue to worsen.

These trends have not gone unnoticed by the Town Council, the various appointed boards and the Town staff. Several ordinances have been introduced and passed since the beginning of the year, with the most important being the repeal of the lot averaging provisions within the RS-16 and RS-12.5 single-family residential zones.

While it is clearly the right of any developer to seek a rezoning or to subdivide property, he may do so only after he has met certain requirements for the protection of the community. The subdivision of land is a privilege conferred upon the subdivider through the laws of the Commonwealth of Vir-

ginia and the Code of the Town of Vienna.

It is the subdivider who seeks to acquire the advantages of lot subdivision, and upon him rests the responsibility of compliance with all laws, ordinances and reasonable conditions. Generally imposed by the Town Council through the approval process, these conditions include the overall design and use of the land, off-site improvements, and conformance with the Town's Comprehensive Plan as it relates to the physical and economic development of Vienna, the safety and welfare of the community in general, and the future owners of the subdivided land in particular.

To address these issues and anticipated pressures of development around our borders, additional professionals were hired in the Planning and Zoning Department. In conjunction with these concerns, it has been our desire to ensure that existing neighborhoods would be maintained and enhanced through the elimination of potentially deleterious effects from new development activities.

The success of the Council's efforts in this endeavor will always be measured by the satisfaction level of the citizens within the community. But citizens must remain vigilant, too. When a resident of a neighborhood learns of a rezoning request or new subdivision, the rest of the neighborhood should be alerted. Ask to see the development plans, and attend each of the public hearings throughout the planning process. Attempt to meet with the developer to understand how your area may be impacted by the new development.

Those residents who attend public hearings during Council meetings know that it is not necessary to be a zoning expert to ask questions during our hearings. You only need to observe and voice your concerns. The staff of the Planning and Zoning Department

will address the technical issues of the application and will respond to any of your concerns. The Town Council, as a result of this process, has a responsibility to ensure a satisfactory result, which will address the technical matters surrounding the application, any constraints imposed by law, and the various concerns related by the citizens of Vienna at each of the public hearings.

The stated Town policy to maintain our residential neighborhoods, which has been endorsed by many citizens in the community, makes it mandatory that all of the Town's technical staff resources be focused on the residential development activities the town is experiencing.

This, coupled with citizen awareness, will ensure that our neighborhoods receive minimum impact due to development/redevelopment, thus achieving the quality of life we in Vienna demand.

## Rabies Shots Required Sooner

Attention pet owners: Effective July 1, the State of Virginia requires all dogs and cats to be inoculated against rabies by the time the animal is four months old (previously six months). Make sure your pet's vaccination is kept current because rabies appears to be on the increase. During the first six months of this year 18 cases were reported in Fairfax County, compared with 22 cases in all of 1987.

All dogs must also be licensed by four months of age. Dog tags cost \$5 each and may be purchased in person at Town Hall or by mail. For information, call 255-6323.
