Permit Required for Home Child Care

Town residents who provide child care in their homes are reminded that in addition to the necessary state and county licenses, a permit is also required from the Town of Vienna to operate a child care facility.

If you care for five children or fewer (not including your own), you must obtain a home occupation license from the Town. For more than five children, a conditional use permit must be approved by the Town's Board of Zoning Appeals.

JUNE 5, 1989

- Following a public hearing, set water and sewer rates for fiscal year 1989-90.
- Authorized payment to homeowners on Cherry Street, Elm Street and Kingsley Road who experienced sewer backup damage from the heavy rains in early May in the following amounts: up to \$200 to pay the deductible amount of sewer backup insurance; for those families not covered by insurance, up to \$1,000 to be paid upon presentation of appropriate bills for cleanup. This payment in no way commits the Town to any liability or future payments to the residents, but is being made for humanitarian reasons.
- Approved the final plat for Ainstree Subdivision, 401-415 Glyndon St., N.E., subject to installation of rip-rap to control erosion as directed by the Director of Public Works.
- Adopted the Town budget for fiscal year 1989-90 and set tax rates as follows: real estate, 28 cents per \$100 valuation; bank net capital, 80 cents per \$100 valuation; utility tax, residential - 20% of first \$15 and commercial - 15% of first \$300.
- Authorized relocation of a sanitary sewer easement at 317 Patrick St., S.W.
- Adopted amendments to the ordinance on erosion and siltation control.
- Awarded the bid for a litter vacuum machine to Virginia Public Works Equipment of Richmond in the amount of \$13,183.75.
- Adopted amendments to the flood plain ordinance.
- Referred a proposed ordinance relative to storm drainage controls in subdivisions to the Plan-

ning Commission for public hearing and recommendation.

JUNE 12, 1989

- Conducted a public hearing on the qualifications for membership on the Windover Heights Historic Architectural Review Board and the historic district itself.

JUNE 19, 1989

- Approved a donation of \$1,000 toward the purchase of jackets for the James Madison High School girls' varsity softball team, 1989 state champions.
- Authorized installation of a right-turn lane from Locust Street onto Park Street.
- Conducted a public hearing on a request to rezone property in the 100 block of East Street and 600 block of Pine Street, S.E., from RS-16, single-family residential, to RTH, townhouses.
- Approved a site plan modification for Tech Center II, 911 Follin Lane, S.E. The applicant is to provide a letter agreeing to provide land in the event a traffic light is needed.
- Awarded the bid for the Town's law enforcement and public officials liability policies to R. Jackson Ratcliffe, Inc. Awarded the bid for business automobile, comprehensive general liability, comprehensive crime, inland marine, boiler and machinery, umbrella, and real and personal property policies to Insurance One, Inc.
- Concurred with the request of Fairfax County to schedule a public hearing for the purpose of condemning two temporary construction easements for the Broadview Community Improvements Program.


- Authorized application for a new technical grant from the Virginia Department of Transportation for transit studies.
- Approved the sale of Town-owned property at 430 Lewis St., N.W., to Louise Smith at a price of \$20,000.
- Requested the Virginia Department of Transportation to consider improvements on Beulah Road and on Cottage Street between Locust Street and Moore Avenue as part of the 1989 Statewide Highway Plan.
- Approved an employment agreement between The Town of Vienna and the Town Manager; set the Town Manager's salary for fiscal year 1989-90 at \$79,378.
- Reappointed the following Town officials for fiscal year 1989-90: Town Attorney, John F. Gionfriddo; Treasurer, Philip R. Grant; Town Clerk, Carol A. Orndorff; and Town Manager, John H. Schoeberlein, pursuant to the approved employment agreement.
- Adopted a resolution endorsing in concept the Northern Virginia Subregional Transportation Plan for the year 2010 and supporting a continuing planning process to define a detailed final plan with financial sources to be presented to local governments within two years.

On the Road Again to Vienna

Many of Vienna's street names have a special character and significance in the town's history. For example, the intersection of Old Courthouse Road and Route 123 was the location of Fairfax County's first courthouse. The courthouse was relocated to Alexandria about 10 years later due to marauding Indians, but despite the change, country lawyers of the time continued to use a winding, tortuous track to pass through Vienna to Alexandria (and later, Fairfax City); this route became known as the "Lawyers" Road.

Between these first two arteries of the region that was to become Vienna ran the Old Georgetown Road, another twisting track, parts of which are traced by present-day Church Street.

The first maps of Vienna date from the mid-19th century. Perhaps the best known is the G.M. Hopkins map of 1878, reproductions of which are available from the Fairfax County Public Library's Virginia Room. The first aerial photographs of the Vienna/Tysons area date from 1937. Starting in 1960, aerial photos of the entire

county were taken every two years and, as might be expected, show dramatically the fast-moving development of the town and environs during the past 30 years.

In August 1990, as part of Vienna's Centennial celebration, there will be a display of some of the vintage maps and aerial photographs that document Vienna's history and growth. Anyone interested in assisting in this exhibit or possessing old maps of interest are encouraged to call the Public Information Office at Town Hall, 255-6330.

The Greater Vienna Chamber of Commerce wishes to enlist your help in selecting nominees for the Business Person and Citizen of the Year awards.

The awards program seeks to recognize those persons who make a distinctive contribution to improving the quality of life or the general good of members of our community.

QUALIFICATIONS:

- 1. The nominees must contribute above and beyond normal performance of business activity.
- 2. Efforts must be sustained over a long period of time and/or result from an outstanding one time contribution in the last 13 months (July 1988 August 1989).
- 3. Eligible recipients must have a business or residential address within the Greater Vienna area.
- 4. The "Business Person of the Year" must be nominated from the business community and the qualifying contribution must be the result of efforts not directly related to his or her normal business activity. Officers and Members of the Board of Directors of the Greater Vienna Chamber of Commerce will not be eligible.
- 5. The "Citizen of the Year" must be nominated from the non-business community. Eligibility will be dependent upon the nominee's significant contribution to the betterment of the community.

The deadline for receipt of nominations will be September 15th.

Persons receiving awards will be honored at a special luncheon in October.

SUBMISSION OF NOMINATIONS

To expedite the submission of nominations, the following guidelines are offered to nominators:

- 1. On request from the Selection Committee, be prepared to submit a concise basic statement (not more than three pages in length) which contains the following information:
 - ♦ Identification of the nominee
 - ♦ A description of the achievement as such, and a description of the nominee's role, extent of responsibility and extent to which the achievement exceeds normal performance or business activity or has contributed significantly to the betterment of the community
 - ♦ Citations of tangible evidence demonstrating the stature of the achievement
 - ♦ Identification of the nominator
- 2. To the extent feasible, supplement the basic nomination statement with pertinent exhibits, such as documents, testimonials, news stories, or other similar supporting evidence.
- 3. If the nominator wishes to have any of the supporting material returned when it has served its purpose, this should be clearly specified.
- 4. Note the cover sheet form on the reverse side of this page. It is designed to provide quick, positive identification of each nomination. Use the reverse side as the cover page for your nomination.
