

Zenith Sky Brightness in the Town of Vienna

Vienna

The zenith sky brightness is a way to measure skyglow. As the Town is located within a major region, the level of brightness at night is quite high. On the Bortle Scale, the Town scores around a 7. Nearby Tysons Corner scores an 8. Much of this brightness is from lighting in the region, but reducing light pollution in the Town itself would still improve night in and around it.

Regional Zenith Sky Brightness

The Washington Metropolitan Region is a major contributor to skyglow in this part of the country. The glow is noticeable out into Chesapeake Bay. DC itself scores a 9 on the Bortle Scale. Big cities need lighting, but if many cities in this

region reduced their light pollution levels those whited-out areas can shrink. Light pollution is not permanent!






