

New Law Bans Dumping of Used Motor Oil

Many people don't realize that the storm drain inlet at their curb leads not to a wastewater treatment plant but to a storm sewer system, and from there to a local stream or waterway. The widespread practice of dumping used motor oil and toxic chemicals at a curb or directly into a storm drain contributes to the degradation of our environment.

As little as one quart of used motor is sufficient to contaminate over one million gallons of drinking water. As of July 1,

1990, new state legislation will make it illegal to dump used motor oil onto land or into storm sewers in Virginia.

Public Hearings Set for June 4

Prior to its scheduled adoption of the Town budget for fiscal year 1990-91, the Town Council will hold three public hearings at its June 4 meeting on proposed increases in water and sewer service charges, vehicle license taxes. and cigarette taxes. The meeting will begin at 8 p.m. at Town Hall.

All interested citizens are encouraged to attend the meeting. Copies of the proposed ordinances are available at Town Hall.

Water rates are proposed to increase by 24 cents per 1,000 gallons, from \$1.57 to \$1.81 for Town of Vienna residents and from \$1.95 to \$2.19 for out-of-town customers. The sewer rate is proposed to increase by 41 cents per 1,000 gallons, from \$1.86 to \$2.27 for all customers. These increases would be the first in two years, necessitated by increased costs to operate and maintain the water and sewer system and anticipated increases in sewage treatment charges.

An increase in vehicle license decals is proposed from \$15 to \$20 for vehicles weighing less than 4,000 pounds, \$20 to \$25 for vehicles over 4,000 pounds, and \$8 to \$10.50 for motorcycles. This increase would be the first since 1976 and would bring Vienna in line with fees charged by neighboring jurisdictions.

Also proposed is a five cent increase in the cigarette tax, from 10 to 15 cents per pack.

- Awarded a bid for two parks maintenance equipment storage buildings to Sturdy-Built Manufacturing Co. of Woodbridge at a price of \$9,112.
- Approved an easement agreement with Vienna Properties, Inc., for a 20-foot easement between the end of Mill Street, N.E., and the property yard at Northside

Park. Authorized \$4,175 as compensation for the easement.

- Awarded the bid for the Mill Street extension project to Owens & Dove, Inc., at a price of \$191,000, to come from the Capital Projects Fund. Business owners in the area will be invited to a meeting to discuss the project.
- Approved the purchase of a sewer jet/vacuum machine from Virginia Public Works Equipment Co. of Richmond for a price of \$99,769 under a four-year lease purchase agreement.
- Requested that improvements to the heating and air conditioning system at Town Hall be moved to Phase 2 of the Capital Improvements Plan and those funds applied to infrastructure improvements in Phase 1.
- Awarded a contract for engineering services for water system improvements to Paciulli, Simmons and Associates in the amount of \$32,400.
- Approved a contract with AEC Engineers to inspect the remaining paint work to be done on the Wall Street water tank at a cost

of \$8,400.

- Appointed Edward D. Ossim to the Transportation Safety Commission for a two-year term.
- Awarded a contract for financial advisory services in connection with the bond issue for the Capital Improvements Projects to the Government Finance Research Center at a cost not to exceed \$13,500 for services proposed in the contract. Funding is to come from bond proceeds or meal and lodging tax revenues.



Did you know that there was a Civil War battle fought in Vienna? It happened near the place where the Community Center is now. There used to be railroad tracks where the Washington and Old Dominion bicycle path is. This was the first time that a railroad was used anywhere in the world as part of the combat.

The Battle of Vienna started on Sunday, June 17, 1861, at about 6:30 p.m. The Loudoun Hampshire Railroad train had left Arlington earlier with General Schenck and his Federal troops. The General was leaving soldiers along the way to guard the tracks and the workmen putting up telegraph lines.

Meanwhile, Colonel Gregg was coming from Hunter's Mill with over 600 Confederate soldiers. When they got to the train station, they destroyed the water tank. Then they heard the train whistle. They got ready to surprise the Union soldiers.


Just before Vienna, an old man tried to warn the the Union General, but he did not listen. A little while later, the Rebels opened fire. The 271 Federal men jumped off the train. The train engineer unhitched all of the cars, and backed his steam engine down the tracks to Arlington.

During the battle, 12 Union soldiers were killed or wounded. No Confederates died. The rest of the Federal troops retreated down the railroad tracks. The Rebels burned the railroad cars. The Battle of Vienna was over.

The 42nd Virginia Infantry will reenact this exciting battle on June 17, 1990 in Vienna. On June 16, they will camp out in the same way that Civil War soldiers would have. Everyone is invited to come down and visit the soldiers and watch the battle.

We just finished reading the May issue of the Vienna Newsletter, and we are at a loss to understand you people and your laws on yard sales. Only two per year? Are you afraid yard sales will hurt our town's businesses or do you see this as your only solution to our terrible traffic problems? Then your law says only two signs on our own property. Don't you think you are infringing on our rights as a tax paying property owner? What we can do and cannot do on our own property should be our business. What next, a law telling us what color you think our house should be, and who came up with what size our direction signs should be? Certainly not you people who run for re-election. Your signs stay up for months and are much larger

than two square feet - are you exempt from your own laws? It would seem to a lot of us tax payers that the officials of this town could spend their valued time on much more important matters, but you seem to want to stick your head in the sand and say "don't worry", let's keep everything the same as it was twenty years ago. the 21st century will soon be here and Vienna will still be living like it's 1950. Maybe that's why so many tax payers are looking for new leadership. Questions like how can we afford a Town Manager who makes over \$75,000,00 per year, or why do we have a zoning department that is redundant and near to impossible to work with, as a matter of fact. What does the town offer for the extra \$500.00 plus that we pay over the people that live in Fairfax County.

Maybe it is time to dissolve the town and return to Fairfax County.

Mayor Robinson replies:

This will acknowledge your letter to me, which also appeared in the <u>Vienna Times</u> and in the <u>Connection</u>, and in which you voice several specific complaints against the Town of Vienna, and suggest that the Town be dissolved.

You complain about Vienna's zoning ordinance which regulates yard sales. These controls were adopted after the Town Council received objections from members of the public concerning continuous or very frequent yard sales at the same premises. This sort of activity tends to transform residentially zoned property into a business use, and thereby annoys and infringes on the rights of neighborhood residents. You question the constitutionality of this ordinance, but for many years, the Supreme Court of the United States has upheld the validity of zoning laws as a constitutional exercise of governmental power.

Our election signs in the

Town of Vienna were in place for the 30 days permitted by ordinance. All of mine were removed on May 2. My opponent's disinclination to abide by our sign ordinance did result in an unfortunate proliferation of signs during that 30-day period.

You suggest that the Town of Vienna may soon specify the color of paint which may or may not be applied to residences in the Town. I am not aware of any discussion, intent, interest or plans of any kind on the part of any elected or appointed official in Vienna to do so.

You imply that the salary paid our Town Manager is exorbitant. Our Town Manager's salary is in the precise range of salaries paid to the managers of other nearby similar jurisdictions.

You also imply that Vienna residents receive no services for the additional real estate tax which they pay to the Town, and that it is less costly to live in Fairfax County, outside of the Town. A recent analysis prepared by Councilwoman Martha Pruett indicates that total charges for local government services in Vienna are in many cases less than would be the case for the same services to the same premises located in Fairfax County outside of Vienna's corporate limit. A copy of this analysis is enclosed for your information.

During the recent election campaign, I rang several thousand doorbells, and prior to receipt of your letter. I did not encounter one suggestion that the Town be dissolved. It is most certainly your privilege to express your view on dissolution, but, in my judgment, your view is decidedly in the minority. And, notwithstanding your assertion that "so many taxpayers are looking for new leadership," the Town's registered voters turned out in large numbers and expressed a four-to-one preference for the present leadership on the very day you wrote your letter, May 1 -Election Day.

Civil War Reenactment June 16-17

A weekend of Civil Warera activities that will conclude with a battle reenactment, will take place June 16 and 17 as part of Vienna's Centennial celebration. Activities are open to the public free of charge. Spectators may participate in the Civil Warera games to be held both days at the Freeman House on Church Street and in the dance of the period to be held at the gazebo on the grounds of the Vienna Community Center on Saturday evening.

The 42nd Virginia Infantry will organize the events with Federal troop participation coordinated by the 28th Massachusetts Infantry.

Both civilian and military life during the Civil War will be reenacted by approximately 150 participants from Virginia, Maryland, Delaware and Pennsylvania. Other participating units include the 30th Virginia, 57th Virginia, 23rd Virginia, 1st Virginia Infantry, Company B, 49th Virginia, 13th Virginia Infantry, 12th Virginia Infantry, Orange Artillery and 2nd Delaware Infantry.

The battle reenactment on June 17, 1990, will be held near the site of the original "Battle of Vienna," which occurred on June 17, 1861, and which saw the first tactical use of railroads in warfare. The reenactment will include infantry, artillery and cavalry. The Freeman House was used during the Civil War as a military headquarters and as a hospital.





THE MASKED ATTACK AT VIENNA

A Railroad Train Fired Upon from Hidden Batteries

Five Killed, Six Wounded, Nine Missing

Names of Killed and Wounded

Our Troops Take a Position and Hold It

The Rebels Dare Not Come Out

Latest from Vienna

All Quiet There

The following are the facts of the affair at Vienna. Gen. Schenck started yesterday afternoon with the 1st Ohio Regiment, to protect the Loudoun and Hampshire Railroad. Guards were stationed at the various bridges on the route, so that when the train reached Vienna, only about 180 men remained. Before the cars had stopped, fire was opened from a small battery and two field pieces upon a hill. Some of the Ohio men

were killed at once, and others after they had disembarked from the train. At the first alarm the engine-driver, in affright, detached all but one car, and hastened back, leaving the men to look after themselves.

After a few discharges, the Rebel force, estimated at above 2,500, consisting of infantry, artillery, and cavalry, retired without attempting to pursue their advantage.
