Town Keeps Double-A Bond Rating

The Town of Vienna was recently notified by the Rating Committee of Moody's Investors Service that its general obligation bonds have once again been rated "Aa." This is the highest bond rating attainable by a local government the size of Vienna, and one that has been achieved by less than 10% of all jurisdictions nationwide.

This rating enables the Town to sell bonds at more favorable interest rates compared to those of municipalities not so rated, resulting in substantial savings for Vienna taxpayers over the life of the bonds.

To protect its excellent credit rating, the Town Council has adhered to a policy of keeping a low ratio of net debt to market value of taxable property, and a ratio of debt service to general fund disbursements below 10%.

The Town of Vienna borrows money by issuing tax-free general obligation bonds to finance major capital projects such as construction of the new police station, water and sewer system improvements, and upgrading of park facilities. Bond financing spreads the cost of these capital projects over a period of many years, rather than charging the full cost to today's taxpayers.

Vienna Residents Now Eligible For Home Improvement Assistance

Free home repairs for the elderly or disabled and subsidized home improvement loans are now available to Town of Vienna residents through an agreement between the Town and Fairfax County. The Home Repair for the Elderly Program (HREP) and the Home Improvement Loan Program (HILP) of the County Department of Housing and Community Development are taking applications from low and moderate income homeowners who need repairs, improvements or handicap accessible modifications on

HREP provides free home repairs to homeowners who are age 62 and older or are handicapped or disabled and have an income below \$28,150 for one person or \$32,150 for two persons. (Income limits change with family size, and other qualifications apply.) Typical services include minor electrical, plumbing or heating repairs; painting; repairing steps, windows, floors, etc.; and installing ramps and grab bars.

HILP provides low interest rates and deferred payment loans along with technical assistance to help homeowners make needed repairs. Work must include some critical items such a roof, furnace, windows or siding and may also include energy efficiency upgrades and general improvements. The current maximum interest rate is 5% for 15-year loans for families of four persons with income up to \$61,000. (Income limits change with family size, and other qualifications apply.) Other types of financing and terms are available.

Dumpsters Aren't for Dumping!!

Town businesses report an increase of illegal dumping in their commercial dumpsters. Many business owners arrive at work to find their dumpsters overflowing with scrap lumber, old mattresses and other debris, which they must pay to have hauled away.

Services include information on Social Security, Medicare, Supplemental Security Income, Medicaid, Food Stamps and housing subsidies; consumer credit and debt problems; medical expense and medical insurance problems; and preparation of living wills and powers of attorney.

Callers must be age 60 or older, have a monthly income of \$1,200 or less for individuals or \$1,800 or less for couples, and have cash assets (not including home equity) of \$15,000 or less.

Comment from the Council Table

Real Estate Taxation in Vienna

In Vienna, we pay property taxes to both Fairfax County and the Town of Vienna; this year \$1.16 per hundred dollars of valuation to the County and 30 cents per hundred to the Town. One might, therefore, quickly conclude that, yes indeed, it costs more to live in Town than in the County outside of Town. This, however, is not true for all of us. Actually, for many property owners, the in-Town cost is less.

The table on this page compares costs for similar two-car families; one living in Town with a house assessed at \$175,000 and the other in an identical house outside of Town; each family in a combined Federal and State income tax bracket of 24%. Total annual costs for the in-Town family come to \$552.00 vs. \$561.92 for the outof-Towners; a savings of \$9.92 for the in-Towners. As the table indicates, the in-Towners pay \$525 more in real estate tax. but lower utility taxes and lower vehicle registration fees. In addition, the in-Towners enjoy free trash pickup, free leaf pickup, and free special trash pickups (3,000 of them last year). And, the Town real estate tax is deductible for Federal and State income tax purpses, but the higher County utility taxes, higher vehicle sticker fees and trash removal charges are not.

However, the dollar savings do shift to favor the out-of-Towners as homeowner assessed value increases, because the higher real estate tax paid by the in-Towners overrides the higher utility, trash removal, and vehicle sticker fees prevailing out of Town. Thus an owner assessed at \$200,000 would pay \$609.00 in Vienna and \$563.82 outside of Town; a difference of \$45.18. And with a \$250,000 assessment, the in-Towner's costs are \$155.38 per year higher. Obviously, for those in-Towners in "high bracket" homes, the incremental cost is greater.

In all of these comparisons it is important to remember that these figures assign no value whatever to the in-Towner's rapid response police department, prompt and efficient snow removal, extra recreation programs, and local control over land use zoning, streets, and sidewalks; plus an enhanced sense of community enjoyed by the in-Towners. For example, Vienna provides 8.7 sworn police officers per square

mile of area or 2.6 officers per thousand population. Fairfax County, being overall less densely populated, provides police manpower of about 2.5 officers per square mile or 1.13 officers per thousand popula-

As full residents of Fairfax County, Vienna residents also participate in and enjoy all County services; excellent schools, basic fire and rescue (in concert with the Vienna Volunteer Fire Department), broad social services, libraries, criminal justice, civil courts, etc. Town and County officials work closely together to avoid duplication and waste.

Nobody likes to pay taxes of any kind, and we all wish that taxes could be lower. However, my experience as an elected official over the years indicates that if people believe they are receiving value for

their tax dollars, they understand the need to fund the services they use. In Vienna, our prime objective is to supply those services at minimum cost consistent with long term financial integrity. We are very proud of our double A bond rating, our very low indebtedness, and our efficient staff.

Traffic Report Cyclists Must Yield To Pedestrians On Sidewalks

The Town Code allows children under 11 years old to ride a bicycle on any sidewalk in town, and cyclists of any age may ride on the sidewalk wherever it is hazardous to ride in the roadway.

The Town Code also requires bicyclists at all times to yield the right-of-way to pedestrians on sidewalks and, before overtaking and passing pedestrians, to give an audible horn or bell signal.

Bicyclists can prevent accidents and injuries by being careful and courteous toward pedestrians. Drivers of motor vehicles are reminded to yield the right-of-way to both cyclists and pedestrians at intersec-

During the month of May, the Vienna Police Department issued 379 traffic citations, 85 for speeding and 294 for other violations such as running stop signs and blocking intersections.

No Tax Increase in FY 95-96 Budget

The Town budget for the fiscal year beginning July 1 totals \$15,625,345, an increase of \$374,978 or about 2.5% over last year. The real estate tax rate remains the same at 30¢ per \$100 of assessed valuation. A "Budget in Brief" summary is given below; complete copies of the budget, which was adopted by the Town Council June 5, are available for review or purchase in the Administrative Services Office at Town Hall.

An increase of 5¢ per 1,000 gallons in the water rate and a decrease of 2¢ per 1,000 gallons in the sewer rate were approved, in addition to a 75¢ increase in the quarterly account service charge. The combined water and sewer rate for town residents this fiscal year is \$4.58 per 1,000 gallons, or about \$6 more per year for the average customer.
