FEBRUARY 1989 — Retired Norfolk Southern Railroad caboose #557725 made its final run February 16 — not on a railroad track but along Northern Virginia highways — to the end of the line in its new home, Vienna. Norfolk Southern approved the Town's request for a caboose last August and subsequently made an additional donation of rails, ties and track material on which to place it.

FEBRUARY 1979 — The Town has purchased the dilapidated house and the property at 430 Lewis St., N.W., thus ending many years of effort to have the house torn down. The condition of the house violated numerous Town and County ordinances and was declared unfit for human habitation by the County Health Department. Nevertheless, the County Circuit Court judged the house to be structurally sound and ruled that the Town could do anything short of demolition to abate the nuisance, and the Supreme Court of Virginia refused to hear the case on appeal. The Town's purchase of the property clears the way for demolition of the house to proceed.

FEBRUARY 1969 - Dr. Ross Netherton, Chairman of the Friends of the Library, reported to Council that legal action is underway for the County to obtain the necessary additional land for a permanent library in Vienna. The building will be constructed at the corner of Maple Avenue and Center Street at the site of the old library. It is hoped that construction can begin this summer.



Sidewalk Hearing February 1

The Town Council will hold a public hearing on the construction of additional sidewalks in Vienna at its February 1 meeting, which will begin at 8 p.m. in the Council Chamber at Town Hall. All interested citizens are encouraged to attend and speak on the sidewalk projects proposed by a joint committee of the Transportation Safety Commission and the Planning Commission, or any other sidewalk improvements.

The Sidewalk Committee has established three priority groups of sidewalk projects, which were published is last month's newsletter and are available for review in the Town Clerk's Office at Town Hall.

Approximately \$388,000 is available in the Town budget for sidewalk construction, which is not enough to fund all of the recommended projects. Citizen input at the public hearing will assist the Town Council in its final selection of sidewalk projects, which could begin this spring.

FY 2000 Budget Process Underway

Preparation of Vienna's budget for fiscal year 1999-2000 has begun. Citizens who have suggestions about what items should be given priority for funding are encouraged to express their views in writing to Town Manager John H. Schoeberlein by February 5. Citizens will also have an opportunity to comment on the proposed budget at the May 17 Town Council meeting.

February 5 is also the deadline for non-profit Vienna organizations to apply for donations of Town funds in FY 2000. For more information, call the Town Manager's office at 255-6370.

What Requires a Building Permit?

The Town of Vienna requires home owners, renters, business owners and tenants to obtain a building permit whenever they wish to make improvements to their property. A permit is required *before* any of the following improvements may commence:

- 1. Constructing, enlarging, altering, repairing, or demolishing any part of a building or structure. This includes but is not limited to installation of a new roof or siding, erection of a storage shed or other accessory structure, finishing a basement, and construction of new facilities such as retaining walls, fences, hot tubs, pools, driveways, satellite antennas, and
- 2. Changing the use of a building either within the same use group or to a different use group when the new use requires more structural strength, fire protection, exits, or sanitary
 - 3. Removing or disturbing any asbestos-containing materials.
- 4. Additions, alterations, replacement, or relocation of any plumbing, mechanical, or electrical systems.

There are exceptions to when a building permit is required, such as ordinary repairs. The term "ordinary repairs" means replacement of materials with like materials, including but not limited to:

- 1. Painting.
- 2. Roofing when not exceeding 100 square feet of roof area.
- 3. Windows when they are replaced in exactly the same size and location.
- 4. Doors, except those in fire-rated wall assemblies or exitways.
- 5. Floor coverings and porch flooring.
- 6. Repairs to plaster, interior tile work, and other wall coverings.
- 7. Cabinets installed in residential dwellings.
- 8. A notable exception is the construction of an accessory structure less that 8½ feet tall and with a total area of less than 150 square feet on a single-family lot. The installation of such a structure does not require a building permit, but its location is restricted in accordance with setback requirements for each of the three residential zones.

Your application, therefore, may not be acted on immediately but may be held in a citizen "talent bank" until such time as a vacancy, or other Town project, matching your abilities and interests is available. Your interest in serving the Town is sincerely acknowledged and appreciated.

Planning Commission - approves preliminary plats of subdivisions, prepares the Comprehensive Plan for the future development of the town, hears and makes recommendations to Council on rezoning requests and other planning and zoning matters.

Board of Zoning Appeals - is authorized to hear and decide appeals of any decision made by the Director of Planning and Zoning, grant variances from the zoning code, approve conditional use permits, and interpret the zoning map.

Board of Architectural Review - examines and approves plans for commercial buildings, signs and landscaping to ensure that new construction is not bizarre or garish and is harmonious and compatible with existing buildings.

Transportation Safety Commission - studies intersections, traffic signs, speed limits and other matters relating to street safety and makes recommendations to Council.

Windover Heights Board of Review - approves new construction and major exterior alterations of buildings within the Windover Heights Historic District in northwest Vienna to ensure that they are in keeping with the old and historic architectural aspect of the surroundings.

Town/Business Liaison Committee - makes studies and offers recommendations to Council on matters affecting the town's businesses and their relationship with other segments of the community.

Community Beautification Commission - created to act as the focal point for beautification and litter control programs.

Preparing for the Year 2000

This year much attention will be focused on preparations to become "Y2K compliant." Many businesses and government agencies, including the Town of Vienna, are working very hard to make sure computer systems continue to operate properly when the year 2000 arrives. The Town anticipates its system being 100% compliant at that time.

At this point, no one knows exactly what problems may occur, how widespread they may be, or how long they will last. The good news, however, is that (1) many private sector and government organizations are running Y2K simulations to assure compliance, (2) all the problems can be fixed once they are identified, and (3) many companies will activate contingency plans while they are working on permanent solutions to the "millennium bug." The Town does not anticipate major problems with government or private sector basic services on which we all depend for daily living.

One Vienna resident, who works as a technology company executive dealing with Y2K compliance issues, takes a differing view, however, and has written to the Mayor and Town Council suggesting the following precautions just in case any unforeseen difficulties arise next January 1. Consistent with the Town's practice to publish citizen comment of general interest, her views are set forth as follows:

- Have some extra cash on hand in case computer-controlled electronic transactions involving ATM cards, credit cards, and the like cannot be processed. Plan to keep cash in a safe place, and withdraw money from your bank in small amounts well in advance of December 31, 1999, to avoid long lines at the bank at the last minute.
 - Plan to fill your automobile gas tank a day or so before December 31, 1999.
- In case the power fails, plan to use alternative cooking devices in accordance with manufacturer's instructions. Be careful of open flames or charcoal grills indoors.
- Have extra blankets, coats, hats, and gloves to keep warm. Use extreme care with gasfueled appliances, like an oven, as an alternative heating source. The same goes for woodburning or liquid-fueled heating devices that are not designed to be used in a residential structure. Camp stoves and heaters should only be used out of doors in a well-ventilated area. If you do purchase an alternative heating device, make sure it is approved for use indoors and is listed with the Underwriters Laboratories (UL).
- Have plenty of flashlights and extra batteries on hand. Use extreme care if candles are used for emergency lighting, especially with children around.
- Examine your smoke alarms now. If you have smoke alarms that are hard-wired into your home's electrical system (most newer ones are), check to see of they have battery back-ups. Every fall, replace all batteries in all smoke alarms as a general fire safety precaution.
- Be prepared to relocate to a shelter for warmth and protection in the very unlikely event of a prolonged power outage or if for any other reason local officials require that you leave your home. Listen to a battery-operated radio or television for information about where shelters will be available. (The Town does not anticipate any need whatever for shelters or any other major emergency of this magnitude.)
- If you plan to use a portable generator, connect what you want to power directly to the generator; do not connect the generator to your home's electrical system. Also, be sure to keep the generator in a well-ventilated area, either outside or in a garage with the door open. Don't operate a generator in your basement or anywhere inside your home.
- Check with manufacturers of any essential computer-controlled electronic equipment in your home to see if that equipment may be affected. This includes fire and security alarm systems, programmable thermostats, appliances, consumer electronics, garage door openers, electronic locks, and any other electronic equipment in which an "embedded chip" may control its operation.

The Fairfax County Beltway Improvement Task Force has scheduled a series of public information meetings for residents in communities most likely to be impacted by the Virginia Department of Transportation's (VDOT) proposed Beltway improvements. The meeting nearest to Vienna will be held on Tuesday, February 9, from 7:30 to 10 p.m. at Churchill Road Elementary School, 7100 Churchill Rd. in McLean.

The task force was established by the Chairman of the County Board of Supervisors to look at ways to improve this vital transportation route while protecting those communities that might be impacted in the process. Membership includes community and business representatives. Vienna's representative to the task force is Town Councilman Mike Polychrones.

At the February 9 meeting VDOT staff will make a brief presentation and the task force will present an alternative plan. Citizens will have an opportunity to comment. Broadleaf Drive Traffic Calming Survey Results

The Public Works Department has received general consensus from residents directly affected by the proposed installation of speed humps on Broadleaf Drive, N.E. The consensus favors two speed humps (Option #2), one to be placed near 306 Broadleaf and one between 318 and 320 Broadleaf. Twenty-three responses were received of the 26 letters sent out to residents. Of those responses, only three were in favor of Option #1, one speed hump located near 314 Broadleaf. Therefore, two speed humps will be installed sometime this spring.

Rabies Still on the Increase

In the latest annual compilation, cats were ranked fourth in the list of total rabies cases in Virginia and dogs seventh. These totals, recorded for 1997, included a record number of rabid cats statewide. Rabies in domestic animals is of special concern because of the increased potential for people to be exposed to the disease.

Rabies in cats and dogs is preventable, but it presents a real public health threat if these animals are not vaccinated. The law requires all cats and dogs over four months old to be vaccinated and to receive regular boosters during their lifetime.

Fairfax County operates a rabies infoline at 324-BITE. The 24-hour recording gives weekly updates on rabies cases in the county plus information on how to spot a rabid animal, what to do if bitten, and tips on how to keep your family and pets safe from rabid animals.
