APRIL 1989 — At its April 3 meeting, the Town Council adopted a resolution in support of the rezoning of the Virginia Center property near the Vienna Metrorail Station, which was recently enacted by the Fairfax County Board of Supervisors. Instead of a high-rise office building and four high-rise apartment buildings, there will be two office buildings facing the station and 153 residential townhouses. Moreover, there will be no application for high-rise commercial rezoning on the adjacent 10 acres, which will also be developed in townhouses.

APRIL 1979 — At its April 2 meeting, the Town Council will consider a petition to pave and open Church Street from Lawyers Road to Pleasant Street. The petition by residents of the Windover Heights area asks that Church Street be opened in order to accommodate traffic that will be generated by the new 301 Tower Building on Maple Avenue and channel it away from the residential area, and to delineate more clearly the boundary between the commercial and residential zones.

APRIL 1969 — The plot of vacant land on Maple Avenue between Hawthorne's Drugstore and Center Street on one side and the Vienna Inn on the other is being graded and will be planted with greenery this spring as a temporary park. Although the land is privately owned, the Town has permission to make some improvements, on what has been an eyesore on the main street.

Town Budget Preview

A look at the proposed Town of Vienna budget for fiscal year 2000 is included on pages 5–8 of this newsletter. Copies of the proposed budget will be available for public review in the Administrative Services Office at Town Hall and at Patrick Henry Library. Bond Issue Hearing

At its April 5 meeting, the Town Council will hold a public hearing on a proposed 1999 bond issue. The meeting will begin at 8 p.m. in the Council Chamber at Town Hall. If approved, an estimated \$5,000,000 in general obligation bonds would be issued to fund Phase II of the Maple Avenue Enhancement Project, traffic signal system upgrade, street improvements, water main cleaning and lining, water tank rehabilitation, improvements to the Community Center and Nutley Street property yard, and other major public improvements.

BPOL Tax Due May 3

The deadline for filing business, professional and occupational license (BPOL) returns this year is May 3. All town businesses, including home occupations, should receive license tax forms in the mail this month. Forms are also available in the Finance Department at Town Hall. Curbside Collection of Cardboard, Mixed Paper Begins April 1

Great news for Town of Vienna recyclers! Beginning April 1, Vienna residents may begin to recycle cardboard and "mixed paper" (magazines, catalogs, junk mail, telephone books) at the curb along with their other recyclables.

The Town currently collects newspaper, glass bottles and jars, plastic bottles and jugs, and metal food and beverage cans. These will continue to be collected as usual.

The cardboard and mixed paper may be included with newspaper. *CARDBOARD MUST BE FLATTENED* and may be either bundled or placed in paper bags. No "peanuts," styrofoam packing, or plastic wrap should be left in any cardboard box. Peanuts may be taken to local mailing or packaging businesses.

Glass, plastic, and metal recyclables must be placed in plastic bags for curbside collection.

In addition to the convenience of expanded curbside recycling, it is estimated that 100 tons of mixed paper will be diverted from the waste stream, creating a potential savings of \$3,600 each year in disposal fees. Also, the Town will no longer need to rent and service the bin for telephone books in the Giant Food parking lot, saving approximately \$3,900 annually.

Car Tag Deadline April 15

1999 Town of Vienna motor vehicle decals are available by mail and in the Finance Department at Town Hall weekdays from 8 a.m. to 4:30 p.m. The registration fee is \$20 for passenger cars and trucks weighing under 4,000 pounds, \$25 for cars and trucks 4,000 pounds and over, and \$10.50 for motorcycles. Decals must be displayed by midnight April 15.

Additional hours for last-minute car tag sales have been scheduled in the Finance Department at Town Hall on Saturday, April 10, from 8 a.m. to 12 noon and Wednesday and Thursday, April 14 and 15, from 8 a.m. to 6 p.m. For more information, call 255-6323.

Town of Vienna residents do not need to purchase Fairfax County vehicle decals, but they must pay County personal property tax on motor vehicles. The County Department of Tax Administration mailed 1999 Personal Property Filing Notices in February. If you still own the vehicle listed on your notice, and all of the information is correct, you do not need to do anything else at this time. You will be billed this summer, with payment due October 5. If any of the information on the form is incorrect, write the correct information on the form and send it back immediately. If you own a vehicle not listed on the form, contact the Department of Tax Administration as soon as possible at 222-8234.

Town Election Day May 4

Vienna's annual Town election will be held on Tuesday, May 4. Polls will be open from 6 a.m. to 7 p.m. at the Vienna Community Center. Town elections are non-partisan, and Town Council members are elected at large.

This year, incumbent Council members Vincent J. Olson, Michael J. Polychrones, and M. Jane Seeman are seeking reelection to two-year terms beginning July 1. W. Samuel Althoff is a Council candidate for the first time.

Voters who will be out of town on election day or who are physically unable to go to the polls may request an absentee ballot from the Fairfax County General Registrar's Office. Call 222-0776 for information.

Voter Registration Deadline April 5

Monday, April 5, is the last day to register to vote in the May 4 Town election. You may register in person at various locations around the county, or by mail. For more information, call the Fairfax County General Registrar's Office at 222-0776.

If you are already a registered voter, no additional registration is required for the Town election; however, you should check your voter registration card to be sure it lists your current address.

To be eligible to vote in the Town election, you must be a Vienna resident, at least 18 years old by election day, and a U.S. citizen.

Adopt-A-Spot is a Town beautification program being implemented by the Community Enhancement Commission and the Parks and Recreation Department. Organizations and individuals are invited to make a two-year commitment to regular cleanup of an area such as neighborhood roadsides, parks, and school grounds. Trim Those Branches

Residents are reminded to keep tree branches, shrubs, vines, and hedges trimmed so that they do not obstruct the view of motorists or endanger pedestrians or bicyclists using sidewalks. A good standard to follow is to keep shrubs and hedges cut back 6" from the edge of the sidewalk and tree limbs elevated to an overhead height of 8'–10'.

The Parks and Recreation Department is responsible for monitoring and enforcing this ordinance. Violations may be reported by calling 255-6360.

Sewer Backups Are Costly! Backup Insurance Is Not!

All insurance companies writing homeowner policies in Virginia offer special coverage for damage resulting from backups of drains and sewers, and this additional protection is available at very reasonable rates. For information on obtaining sewer backup coverage, contact your insurance company.

The Town's insurance carrier rarely approves claims resulting from sewer backups unless negligence in maintaining the system can be shown. Therefore, residents are encouraged to protect their property by obtaining sewer backup insurance.

To help prevent sewer backups, the Public Works Department cleans the main sewer lines whenever residents notify the department that their service laterals have been rodded by a commercial sewer cleaning service. Pressure cleaning to remove material washed into the main sewer line from the service lateral may help prevent future blockage of the main line. If you have your sewer service lateral cleaned, please call the Public Works Department at 255-6381.

No dollar value has been assigned to certain advantages to living in town, such as the rapid response of the Police Department; prompt and efficient snow removal; extra recreation opportunities; local control over land use, streets and sidewalks; responsive local elected officials and staff; and the enhanced sense of community enjoyed by in-town residents.

Town Has Top Bond Rating

The Town of Vienna's general obligation bonds are rated "Aa2" by the Rating Committee of Moody's Investors Service. This is the highest bond rating attainable by a local government the size of Vienna, and one that has been achieved by less than 10% of all jurisdictions nationwide.

This rating enables the Town to sell bonds at more favorable interest rates compared to those of municipalities not so rated, resulting in substantial savings for Vienna taxpayers over the life of the bonds.

Moody's noted that its high rating is based on Vienna's location and economic base, overall debt capacity, healthy financial condition, and relatively rapid retirement of debt. Standard & Poor's financial analysts have also given Vienna a high bond rating.

To protect its excellent credit rating, the Town Council has adhered to a policy of keeping a low ratio of net debt to market value of taxable property, and a ratio of debt service to general fund disbursements below 10%.

The Town of Vienna borrows money by issuing tax-free general obligation bonds to finance major capital projects such as construction of new buildings, water and sewer system improvements, and upgrading of park facilities. Bond financing spreads the cost of these capital projects over a period of many years, rather than charging the full cost to today's taxpayers.

Town of Vienna, Virginia A Look at the Proposed Budget For Fiscal Year 1999–2000

MESSAGE FROM THE TOWN MANAGER

We were directed by the Town Council to craft a budget that, while continuing all services and expanding our recycling program, requires no increase in the real estate property tax rate. The proposed budget for FY 1999–2000 meets this goal even though many of our revenue sources have not increased to any substantial degree.

The proposed FY 1999–2000 budget is based on a real estate property tax rate of 31¢ per \$100 of assessed valuation — the same rate as in FY 1998–99 — but it does represent a 2.45% effective tax rate increase. The effect of this rate will vary by property but, on average, Vienna taxpayers should see a small increase in their Vienna real estate tax bill equivalent to approximately \$2 per month.

We have been able to produce a budget with no increase in the tax rate in large part due to personnel reductions made during FY 1997–98. We have reduced the Town workforce from 165.5 employees in FY 1997–98 to 161.6 employees in the proposed budget — a reduction of 3.9 full-time equivalent positions.

INCORPC

The proposed Water and Sewer Budget, if adopted as presented, requires no rate increase. We have been able to control our expenses to the extent that no change to any of the rates (either in or out of town) is necessary. We will also be able to fund our share of the improvements to the Fairfax County Wastewater Treatment Plant as rates were increased in FY 1998–99 for this purpose.

Glossary of Budget Terms

Budget – A specific plan which identifies the program of operations for the fiscal year, states the expenditures required to meet the program, and identifies the revenues necessary to finance it. The annual Town budget is established by the Town Council by resolution.

Debt Service Fund – The fund in which transactions related to the payment of interest and principal on the Town's long-term debt are housed.

Expenditure – A decrease in net financial resources. These include payment in cash for current operating expenses, debt service and capital outlays.

Fiscal Year – The year running from July 1 through June 30, designated by the calendar year in which it ends.

General Fund – Accounts for the general operations of the Town. This fund accounts for all financial transactions and resources not required to be accounted in an enterprise fund.

Licenses & Permits – Documents issued to regulate businesses and other activity. A degree of inspection may accompany the issuing of a license or permit, as in the case of building permit, and in most instances a fee is charged, generally to cover all or part of the cost of administration.

Reserve – An account used either to set aside budgeted revenues that are not required for expenditure in the current budget year or to earmark revenues for a specific future purpose.

Revenue – An increase in assets or financial resources which does not represent an increased liability, a repayment of an expenditure already made, a cancellation of certain liabilities, or an increase in contributed capital.

Water & Sewer Fund – An enterprise fund where the costs of providing goods and services to the general public on a continuing basis are financed or recovered through user charges.



Your Tax Dollars at Work – Town Services

POLICE

The Police Department's Patrol Division has the primary responsibility for law enforcement in Vienna. Officers patrol both res-

idential and commercial areas, and respond to thousands of calls for service each year. The detectives of the Criminal Investigations Section investigate major crimes, and their case closure rate is consistently



higher than the national average in almost every area.

The Community Services Officer conducts home and business security inspections, teaches Drug Abuse Resistance Education (DARE) at elementary schools and Rape Aggression Defense (RAD) training, speaks to community groups about crime prevention, and coordinates the Neighborhood Watch Program. The Youth Resource Officer investigates runaway cases, acts as liaison between schools and the department, tracks gang activity, and targets at-risk youth for early intervention in an effort to prevent crime.

The Traffic Section's primary responsibility is the enforcement of Vienna's traffic laws. It also provides escorts and traffic control when necessary, performs child safety seat inspections, and conducts training for both Town employees and the public in defensive driving, accident reduction, and other traffic safety issues.

The Town's Animal Warden is also part of the Police Department.

PARKS & RECREATION

The Vienna Community Center has recently reopened following a \$1 million renovation project, which included the installation of a full-service elevator and other ADA compliance items; replacement of the aged, inefficient heating and air conditioning system; addition of 1,200 square feet of storage space; improvements to make the basement more functional as a teen center; and a general interior facelift. The Community Center provides space for a large variety of youth and adult classes; drop-in activities in the gym and Teen Center; meetings and seminars; and numerous other activities and special events such as the annual July 4th celebration, antique shows, theatrical productions, and band concerts. On December 31, 1999, the Community Center will be the site of a hometown New Year's Eve celebration to ring in the year 2000.

The Parks Maintenance Division maintains the grounds at all Town owned buildings, parks, athletic fields and courts, playgrounds, and specified right-of-way medians and utility strips. The division began a townwide inventory of street trees in the public rights-of-way in the fall of 1998. The primary benefit of the project

will be the long-term effect on preservation of trees along the Town's 60 miles of public roadway. With the completion of the street tree inventory, the Town arborist can better plan and schedule preventive maintenance work. The tree management computer software will provide reports and tracking of work required and work completed, as well as data for the annual tree maintenance budget and strengthening of tree protection ordinances. Department staff will be able to provide residents and Town officials more accurate information regarding specific trees within a much shorter time period than before.

FINANCE

The Finance Department provides overall management and supervision of the Town's financial operations, provides cash management, and coordinates capital financing and debt management. The department has completed a substantial number of Y2K related computer system conversions and upgrades to ensure that essential Town services to citizens will not be interrupted, and anticipates its system being 100% Y2K compliant when the year 2000 arrives.

PUBLIC WORKS

The Department of Public Works' many services include street maintenance; snow removal; leaf collection; asphalt repair; collection of trash, recyclables, and special pickups; mulch processing and delivery; storm drainage maintenance; street sweeping; maintenance

of traffic signals, signs and markings; maintenance of all Town buildings, vehicles and equipment; repair and replacement of concrete curb, gutters, sidewalks and driveway aprons; and operation and maintenance of the



water and sewer system. As of April 1, 1999, the Department's curbside recycling program has been expanded to include cardboard and mixed paper.

PLANNING & ZONING

The Department of Planning and Zoning provides current and long-range planning for Vienna as well as administration of the zoning code. The staff reviews applications for building and occupancy permits, and investigates zoning violations. In 1998, over 200 new zoning violations were investigated, including prohibited activities on private property, inoperative vehicles, illegal signs, weed and debris violations, and work performed without a building permit. Over 95% of these cases had been closed as of January 1999.
