# This Month in History

from the Vienna Newsletter archives

APRIL 1990 — Vienna Centennial activities will focus on area churches during the month of April. The commemoration will be highlighted by an ecumenical worship service at St. Mark's Catholic Church. More than 400 people will take part in the service, which will feature adult, youth and children's choirs as well as brass instrumentalists. Following the service, a reception will be held in the fellowship hall, during which Mayor Charles A. Robinson, Jr., will cut a cake in honor of both Vienna's Centennial and the 25th anniversary of St. Mark's Church.

APRIL 1980 — Vienna residents of all ages are invited to participate in a cleanup of the town's central business district on two consecutive Saturday afternoons, April 12 and 19. These cleanup days are part of the "I Keep Vienna Clean and Green" program. Participants should assemble in the Minipark at the corner of Maple Avenue and Center Street to receive trash bags and instructions.

APRIL 1970 — For their Earth Day project Madison High School students are taking over the cleanup of Vienna's business area. Armed with plastic trash bags and assisted by Town trucks, classes will compete with each other to see who can fill the greatest number of bags. Other students will plant shrubs in selected areas. After an afternoon of work, a dance will be held on the grounds of the Community Center.



# Yard Waste Disposal

Residents are reminded that effective April 1, yard waste (leaves, grass, small clippings, acorns, and other vegetation) must be placed in clear plastic bags or kraft paper bags for pickup by Town sanitation crews.

The new requirement is due to changes in Fairfax County solid waste regulations and is intended to allow the sanitation crews to identify more easily the contents of bags containing recyclable vard waste.

The clear plastic bags may be purchased at Town Hall, and bags are also available at some local grocery stores. For more information, call the Public Works Department at 703-255-6382.

# **BPOL Tax Due May 1**

The deadline for filing business, professional and occupational license (BPOL) returns is May 1. The annual license tax is based on gross receipts, and the rate varies according to the type of business. All town businesses, including home occupations, should receive license tax forms in the mail this month. Forms are also available in the Finance Department at Town Hall. # **Car Tag Deadline April 17**

2000 Town of Vienna motor vehicle decals are available by mail and in the Finance Department at Town Hall weekdays from 8 a.m. to 4:30 p.m. The registration fee is \$20 for passenger cars and trucks weighing under 4,000 pounds, \$25 for cars and trucks 4,000 pounds and over, and \$10.50 for motorcycles. Decals must be displayed by midnight April 17.

Additional hours for last-minute car tag sales have been scheduled in the Finance Department at Town Hall on Friday, April 14, from 8 a.m. to 6 p.m., Saturday, April 15, from 8 a.m. to noon, and Monday, April 17, from 8 a.m. to 6 p.m. For more information, call 703-255-6323.

# **County Assesses Town Real Estate**

Last month many Vienna residents received notice of a change in their 2000 real estate assessments. The Fairfax County Department of Tax Administration (DTA) sent notices to all county property owners whose assessment has been changed.

The majority of residential properties increased in value, reflecting the price appreciation and record sales volume in the 1999 real estate market, although individual assessment changes may vary considerably.

Property owners can file an appeal with DTA if they believe their assessment is not uniform in comparison with similar properties or if they believe their assessment exceeds fair market value. Appeals should be filed by April 5 to ensure a timely response prior to the Board of Equalization (BOE) filing deadline of June 1.

Appeals can also be filed directly with BOE, a panel of nine taxpayers appointed by the County Board of Supervisors who conduct formal hearings and takes sworn testimony. All appeals to BOE must be filed by June 1. BOE appeal forms are also available at DTA's homepage or by calling BOE at 703-324-4891.

# Census 2000: Time to Be Counted

Billions of dollars of federal, state and local funds will be spent on thousands of projects across the country in the next decade, including education, health care, job training, and transportation. How and where that money is spent depends on citizen response to the U.S. Census 2000 questionnaire mailed out last month. All Vienna residents are urged to mail back their completed questionnaires to help provide a complete and accurate picture of our community. Be sure to include ALL people residing in your household.


ALBERT J. BOUDREAU is a retired federal executive and part-time consultant to the U.S. Congress. A resident of Vienna for 43 years, Councilman Boudreau also represents the Town on several State and Regional commissions on transportation, land use, and environment issues.

"I have strived to initiate projects to improve the unique character and small-town atmosphere that is Vienna. These include the revitalization of Maple Avenue and Church Street, which have improved the Town's overall appearance and led to the renovation of many commercial properties. A "turn of the century" vision plan for Church Street (the Town's original Main Street) has been completed and a new incentive ordinance enacted to encourage small shops and pedestrian shopping.

"In the past you have told me you wanted a safer town. A major program to expand sidewalks (over \$450,000 this year) will provide a safer pedestrian environment and a greater sense of community. More steps have been taken to neutralize the adverse effects of commuter traffic, including traffic calming, modern technology law enforcement, and a proposal for a special Rte. 66 exit to divert some traffic from Vienna.

"There are still some challenges ahead: continued modernization of our streets, sewer, water, and service facilities; further revitalization of Maple Avenue's healthy, attractive business community with its strong tax base; an expanded vision for the future; and most important, the continued delivery of Town services in a fiscally sound manner.

"I want Vienna to keep its special identity and small-town character and I will continue to work to maintain and strengthen it."



STEVEN D. BRIGLIA, a life-long Vienna resident, has served on Council since 1996 and is currently interim Mayor. He was formerly the attorney member on the Board of Architectural Review and he also served on the Town/Business Liaison Committee. He is an attorney in private practice.

"We are living in dynamic and prosperous times. However, we cannot sit back and assume that the Town will take care of itself. I have worked to ensure that the level of police protection, parks and recreational programs, and public works services continues to meet the needs of Vienna residents, and to renovate the Town's aging infrastructure. I have supported the implementation of traffic calming measures, the recent improvements to the Community Center, the new Teen Center, and the next phase of the Maple Avenue revitalization. The Photo Red Light Enforcement program is serving as a deterrent to aggressive and impatient drivers. I am also working to improve traffic signalization on Maple Avenue.

"I have worked diligently to ensure that the Town can fund its renovation projects and provide the services that citizens expect and value without raising property taxes. Of course, the Town Council could not do its job without the tireless assistance of our community groups, volunteers who serve on our Boards and Commissions, and dedicated Town employees. I have always valued the 'home town' feeling that people associate with our Town. We need to work together to ensure that our community remains a vibrant, safe and great place in which to live.

"It has been a pleasure and an honor to serve the citizens of Vienna and I look forward to the opportunity to continue to serve."



ROBERT P. McCORMICK was elected to Council in 1997. Councilman McCormick is a past president of the Malcolm-Windover Heights Civic Association and is active in other community organizations. He works as an independent insurance broker in Vienna.

"Anyone who has purchased a home understands the phrase, 'location, location, location.' After 24 years of living in Vienna, I would stress 'community, community, community.' Vienna is unique. We are in the middle of a booming metropolitan area, yet somehow Vienna maintains its small-town atmosphere. (Thank you Charlie.) In working with my Council colleagues, the Town staff and many volunteers, although the task at hand varies, the underlying goal is always the same: Make sure Vienna continues to be a great place in which to live.

"In my last campaign article I mentioned I was working on the Oldest Tree project and the Virginia Center development near Metro. I am happy to report, with the combined efforts of many people, the Oldest Tree is located at 802 Marjorie Ln., S.E., and the developers of Virginia Center withdrew their request for additional office space. I have worked with a wonderful group of citizens and Town employees to open Club Phoenix, Vienna's first real Teen Center. Currently I am working with several volunteers to place a mural on the wall opposite the train station, and another group is exploring the possibility of activating the Town's cable channel. (If you have technical expertise, we could use your advice.)

"Obviously, I enjoy being on the Town Council, and I promise to do what I can to keep Vienna a wonderful, unique place in which to live. Thank you."



# Dog Owners Required To Clean Up After Pets


The Town of Vienna has a "pooper scooper" ordinance that requires dog owners to clean up after their pets when out for a walk. Please be a responsible pet owner and don't allow your dog to foul the lawns of neighbors.

Also, signs are posted in several Town parks to remind pet owners that dogs are not allowed on athletic fields, tennis and basketball courts, playgrounds and picnic areas because of the nuisance and potential health hazard to park users. The Town Animal Warden is authorized to fine pet owners found in violation of these laws.

Dog owners are reminded that it is against the law to let dogs run at large on public or private property. Dogs must be restrained by a dependable leash and controlled by a responsible person when off the property of the owner. Dogs found running at large may be picked up by the Animal Warden, and owners charged with dog-at-large violations must appear in court.

TOWN RECEIVES BUDGET AWARD — For the sixth consecutive year, the Town of Vienna has received the Distinguished Budget Presentation Award from the Government Finance Officers Association of the United States and Canada. This award, for the fiscal year 1999–2000 budget, is the highest form of recognition given for governmental budgeting. In order to receive the budget award, a jurisdiction must satisfy nationally recognized guidelines for effective budget presentation. These guidelines are designed to assess how well a government's budget serves as a policy document, a financial plan, an operations guide, and a communications device. Budget documents must be rated "proficient" in all of these categories to receive the award.

# **Town Has Top Bond Rating**

The Town of Vienna's general obligation bonds are rated "Aa1" by Moody's Investors Service. This high bond rating for a local government the size of Vienna is enjoyed by very few towns in the United States.

This rating enables the Town to sell bonds at more favorable interest rates compared to those of municipalities with lower bond ratings, resulting in substantial savings for Vienna taxpayers over the life of the

Moody's noted that its high rating is based on Vienna's healthy economy, sound financial condition, and rapid debt retire-

The Town of Vienna borrows money by issuing tax-free general obligation bonds to finance major capital projects. The \$4.8 million of public improvements funded in the 1999 bond issue include Phase II of the Maple Avenue Enhancement Project, traffic signal system upgrade, street improvements, water main cleaning and lining, water tank rehabilitation, improvements to the Nutley Street property yard, and other major public improvements.

Bond financing spreads the cost of capital projects over a period of many years, rather than charging the full cost to today's taxpayers. Also, the Town's policy of using meals and lodging tax revenues for a large portion of annual debt amortization payments limits the need for property tax increases to fund these projects.



# Town of Vienna, Virginia A Look at the Proposed Budget For Fiscal Year 2000-2001

## MESSAGE FROM THE TOWN MANAGER



INCORPC

Continuing our efforts to keep costs to a manageable level and to meet Town Council directives, the 2000-2001 proposed budget has been submitted with no increase in the real estate tax rate of 31¢ per \$100 of assessed valuation. Included in the budget is funding for the recently completed classification and compensation study and a 2% salary adjustment for all employees effective July 1, 2000.

While the real estate tax rate has remained at 31¢ there will be an effective tax rate increase due to increased assessments on both residential and commercial property. On average, the increase in real estate taxes to fund the proposed budget will be in the 4%-5% range for the average tax bill, but each property is unique and the actual increase will depend on the increase in the assessment, if any.

The proposed water and sewer budget includes no increase in consumption charges, but we have proposed an increase in the quarterly service charge from \$4.75 to \$8.00 to cover our fixed charges such as meter reading, billing, etc. The average water bill, therefore, would increase by \$3.25 per quarter or about 41¢ per day. We have also proposed increasing our excess use charge to \$2.15 per 1,000 gallons, which equals the charge to the Town for excess use water purchases from the City of Falls Church.

No decrease in programs or services is planned and we have proposed an increase in the number of employees in the Police and Public Works Departments in order to better serve the public and increase efficiency.

I invite you to read the entire budget message and proposed budget, which provides more detail than this synopsis. The budget will be available for public review beginning April 5 at Town Hall and Patrick Henry Library.

# **Glossary of Budget Terms**

Budget - A specific plan which identifies the program of operations for the fiscal year, states the expenditures required to meet the program, and identifies the revenues necessary to finance it. The annual Town budget is established by the Town Council by resolution.

Debt Service Fund - The fund in which transactions related to the payment of interest and principal on the Town's long-term debt are housed.

Expenditure - A decrease in net financial resources. These include payment in cash for current operating expenses, debt service and capital outlays.

Fiscal Year - The year running from July 1 through June 30, designated by the calendar year in which it ends.

General Fund - Accounts for the general operations of the Town. This fund accounts for all financial transactions and resources not required to be accounted in an enterprise fund.

Licenses & Permits - Documents issued to regulate businesses and other activity. A degree of inspection may accompany the issuing of a license or permit, as in the case of a building permit, and in most instances a fee is charged, generally to cover all or part of the cost of administration.

Reserve - An account used either to set aside budgeted revenues that are not required for expenditure in the current budget year or to earmark revenues for a specific future purpose.

Revenue- An increase in assets or financial resources which does not represent an increased liability, a repayment of an expenditure already made, a cancellation of certain liabilities, or an increase in contributed capital.

Water & Sewer Fund - An enterprise fund where the costs of providing goods and services to the general public on a continuing basis are financed or recovered through user charges.



# Your Tax Dollars at Work — Town Services

#### POLICE

In 1999 the Vienna Police Department implemented a state-ofthe-art photo red light surveillance system. Hundreds of citations have been issued

for red light violations since the system was installed. This new technology has increased safety on our streets and allows members of the Traffic Squad to concentrate their efforts on other offenses.



At the annual conference of the Virginia Association of Chiefs of Police, the department received awards for its efforts to increase compliance with traffic laws and to improve public safety, and its efforts to inform the public about ways to prevent auto theft. The Vienna Police Department was also awarded grants for the purchase of laser radar equipment and six traffic classifiers.

The department conducted a program called "Collect-a-Cop," a distribution of police officer trading cards to Vienna area elementary and middle school students. The program was very successful in encouraging acceptance of police officers among Vienna's children.

Also in 1999 the department earned the Certificate of Accreditation from the Virginia Law Enforcement Professional Standards Commission. Achievement of this award demonstrates the department's compliance with recognized standards of professionalism in law enforcement. The departent's ultimate goal is the achievement of national recognition through the Commission on Accreditation for Law Enforcement Agencies.

#### **PUBLIC WORKS**

Curbside recycling of mixed paper (cardboard, magazines, catalogs, junk mail and telephone books) began in 1999. In addition to the convenience to town residents, it is estimated that 100 tons of mixed paper will be diverted from the waste stream, creating a potential savings of \$3,600 each year in disposal fees. Also, the Town no longer needs to rent and service a drop-off bin for phone books, saving another \$3,900 annually.

The General & Street Maintenance Division, Vehicle & Equipment Maintenance Division, and Water & Sewer Division earned the National Safety Council's 1998 "President's Citation" for maintaining a perfect operating record without any days lost from work due to an occupational injury or illness — a total of over 167,000 employee hours. This award recognizes the cooperation and effort made by Vienna's Public Works crews to complete each day safely, in spite of having to perform some of the toughest jobs, such as snow plowing and repairing water main breaks, at all hours and in extreme weather conditions.

The Public Works Department is currently developing plans for the proposed Northside maintenance facility and overseeing the sidewalk construction program, water and sewer line replacement, and construction of the Wall Street booster pumping station.

#### PLANNING & ZONING

During 1999 the Planning and Zoning staff was involved in the implementation of the Church Street Vision Plan, an incentive based development program to preserve the unique character of the historic Church Street commercial corridor. Under the plan, which is entirely voluntary, property owners are encouraged to renovate and develop properties in accordance with guidelines that reflect a main street urban architecture reminiscent of the small-town American streetscape of the late 19th century. In exchange, owners will receive additional building square footage, a reduction in parking requirements, and an expedited review process.

The department was awarded a grant for a Geographic Information System (GIS), which will enable the Town to produce detailed, computer-generated maps showing as large or as small an area as desired, from the entire town to an individual piece of property. The computer software program is compatible with software used by Fairfax County to allow easy exchange of information.

#### PARKS & RECREATION

The Parks and Recreation Department celebrated the completion of major renovations to the Vienna Community Center and



Southside Park in 1999. A trail was completed at Wildwood Park, and the department recently received a grant from the Virginia Department of Conservation and Recreation to help fund a trail through Northside

Park to provide access to the Washington & Old Dominion Regional Park Trail. The 1,400 foot asphalt trail will begin at Glyndon St., N.E., and include a bridge across Piney Branch.

Club Phoenix Teen Center opened in September and was an instant success with a turnout of more than 400 teens and parents for the grand opening event. Middle school and high school teen councils, along with the Vienna Teen Center Foundation, provide volunteers and assist in planning dances and other special events.

The Community Center hosted the Vienna 2000 Celebration on New Year's Eve, and a new "Millennium Clock" was unveiled outside the building as a lasting reminder of Y2K.
