### This Month in History

from the Vienna Newsletter archives

OCTOBER 1990 – The glass collection dumpster in the Park Street parking lot of the Community Center now has three companions - dumpsters for plastic, cans and cardboard. As with glass, the Town will realize no revenue from the deposited items; however, the savings in landfill costs will be substantial.

OCTOBER 1980 - The Town Council has adopted an ordinance to franchise and regulate cable television in Vienna. Franchises are expected to be awarded next year. The ordinance Council adopted October 20 parallels that of Fairfax County, and a joint Town/ County solicitation of applications and award of franchises is planned. Once franchises have been awarded, construction of the cable system must begin within one year, and 20% of the system must be completed each succeeding year until the entire system is finished in five years.

OCTOBER 1970 – Vienna has purchased the Bowman property, which is located on Center Street and separated from Town Hall by the medical center. The location, which is convenient to Town Hall, the Community Center and the Fire Department, is an ideal location for the future expansion of Town facilities. The Board of Zoning Appeals will soon hold a public hearing on the Town's request for a use permit to construct a municipal swimming pool on the property.

OCTOBER 1960 - This is the first issue of a quarterly newsletter addressed to every citizen of Vienna from the Town government. Other issues will follow. It is dedicated to the mission of briefly informing all citizens of the principal events transpiring in the conduct of their Town government in the preceding quarter. Some events must be omitted to obtain brevity and others because their status is not sufficiently firm at the time of publishing to warrant a precise and correct statement. The preparation and distribution of these newsletters is accomplished entirely by Town employees and entails many hours of work, some after regular working hours, but is done cheerfully and enthusiastically in order to fully inform all citizens of the current operations of their government.

### Windover Heights **Board of Review**

The Windover Heights Board of Review, established in 1979, approves new construction and major exterior alterations of buildings within the Windover Heights Historic District in northwest Vienna, one of the original residential sections of town and home to citizens prominent in the community's development.

Before issuing a Certificate of Appropriateness, the Board considers the relation of the proposed project to the old and historic aspect of the surroundings; the extent to which areas of historic interest will be preserved or protected; and architectural and other features that relate to the cultural and artistic heritage of the town.

The Board meets the first Tuesday of each month, if an application is submitted, at 7:30 p.m. in the Council Chamber at Town Hall, and interested citizens are welcome to attend. Members are Thomas Kamstra, Chairman; Jill Decker; Shirley Damon; Peter VanderNat; and Steve Bukont. ### **Personal Property Tax**

October 5 is the deadline to pay Fairfax County personal property tax on motor vehicles. (If you moved into the county or purchased a vehicle after July 1, your taxes will not be due until February 15, 2001.) In this third year of the state-authorized tax reduction, taxpayers' personal property tax will be reduced by 47.5%, which is reflected in the bill they received from the County. Taxes may be paid in a variety of ways, including in person at the County Government Center and certain local banks. by mail, and over the Internet. ### **Leaf Pickup Begins October 16**

Fall leaf collection will begin on October 16 in south Vienna and October 26 on the north side of town. Department of Public Works crews using leaf vacuum machines will collect leaves that residents have raked to the curbside.

The leaf collection crews will make one pass through town each month during October, November and December. ALL LEAVES MUST BE AT THE CURBSIDE PRIOR TO THE FIRST SCHEDULED COLLECTION DAY FOR EACH PASS THROUGH YOUR AREA. ONCE YOUR STREET HAS BEEN COVERED. CREWS WILL NOT DOUBLE BACK.

If you miss your vacuum collection dates, the Public Works Department will still collect your leaves; however, the leaves must be bagged and placed at the curbside for pickup with your regular trash. Up to 20 bags of leaves will be picked up on any single refuse collection day throughout the year.

Please rake leaves just to the curbside, not into the street. Cars parked on leaf piles may catch on fire, and children playing in the leaves may be struck by a passing vehicle. Also, leaves may prevent rain water from reaching storm water inlets. Residents may wish to move vehicles off the street to avoid dust from the leaf vacuums when the weather is dry; the Town cannot be responsible for washing cars.

### Operation ABC Mobilization: America Buckles Up Children

Operation ABC Mobilization, sponsored by the Air Bag and Seat Belt Safety Campaign in partnership with the National Highway Traffic Safety Administration and the U.S. Department of Transportation's Buckle Up America Campaign, is a stepped-up drive to enforce seat belt and child passenger safety laws and provide safety seat inspections, installation and education.

Traffic crashes are the leading cause of death for American children of all races. It's the law in all 50 states that children must be restrained. But because adults are breaking the law, children are crippled and killed in car crashes every day. In fact, six out of ten children who die in crashes are unbuckled. Of those, nearly half would be alive today if they had just been buckled up.

The National Highway Traffic Safety Administration reports that when its year 2000 goals are reached, an estimated 4,200 deaths and 103,000 injuries will be prevented each year, translating to a savings in societal costs of approximately \$6.7 billion annually. Here are some important actions all drivers should take:

- Use the right size child safety seat. Don't take your child out of a safety seat simply because he or she turns four. Virginia law requires safety seat use for children under four, yet most four year olds are not large enough to use adult safety belts.
- Use your safety seat properly. Read directions. The child should be snugly secured in the safety seat, and the safety seat should be very tightly secured in the vehicle. An infant must face backwards and be reclined until he or she reaches 20 pounds. Never use a rear facing safety seat in a seating position with an airbag.
- Never risk putting a child on a lap or two people in one belt. A child belted in with an adult will likely be crushed in a crash. If you have more people that safety belts, make two trips or take two cars.
- Do not move the car until everyone has buckled up. If you have allowed your child to ride unprotected in the past, then start today securing him or her every time. Always wear your own safety belt.

The Vienna Police Department has joined thousands of law enforcement agencies nationwide in declaring zero tolerance for drivers with unbuckled children. Police officers will gladly assist parents to install child safety seats properly.

## Utility Deregulation is Coming! Are We Ready?

At the September 11 Town Council meeting, one of the items of consideration was to change the Town of Vienna's consumer utility tax to a consumption-based tax. The net effect of making this change will not be apparent to you on your next electric and/or natural gas bill: the tax stays the same \$3 (for residents) and \$45 (for business) you have always paid. I am sure that you are probably asking yourself. "If there will be no difference then why are we changing?" Well, the answer is Utility Deregulation. What is it? How is it going to affect all of us as consumers? And how are we as a community and a local government preparing for it? I will attempt to cover these issues in the following few paragraphs. Now, I do not claim to be an expert on the subject of utility deregulation, but what I want to do is share with you some information and encourage you to follow this subject so that when the time comes all of us as consumers can make informed decisions about what we're buying and who we are buying it from.

First, what is utility deregulation? Currently, we purchase electric power and natural gas in what is referred to as a "bundled" service, meaning that the electricity we buy is generated and delivered to our homes by the same company. (The same applies to natural gas service.) Utility deregulation means that theses services will become "unbundled," and the company that generates the power and the company that delivers it may be different. In addition, the charges on your utility bills will be broken out so that you can see what portion is for generation, distribution, and other costs.

Why are we going from the current system to a more deregulated environment? The utility companies say that consumers of all types and sizes want to have a choice. Virginia Power in its literature cites a survey conducted by Virginia Commonwealth University of 1,000 Virginians showing that supporters of "choice" outnumbered opponents 7-to-1. In addition,

many of those think that competition should begin sooner rather than later.

After studies in the late 1990's, the Virginia General Assembly enacted the Virginia Electric Utility Restructuring Act, which allows consumers to choose their energy supplier. Similar legislation was passed in the 2000 legislative session to create a retail supply choice program for natural gas customers. Both acts basically allow for consumers to have the opportunity to choose where they purchase the energy they use. The legislation also has provided for a timetable for customer choice, allowing for a phased in approach in making this fundamental change and giving the legislature working through the State Corporation Commission (SCC) time for further evaluation and study in an effort to correct unknown or unforeseen problems as they arise. Full retail competition for all customers will take effect by January 1, 2004.

How will this affect us as consumers and as a Town Government? Will we as individual consumers realize a savings and better prices as a result of this competitive and open market? All basic laws of economics say that as competition enters and customers have a choice, then those customers should realize a savings, but nobody can say for sure. As a Town government, if we can save on those energy costs and have the ability to contract with energy providers, then we can base our budget on those contract prices, thereby saving you the taxpayer on the costs of energy that the Town requires.

How successful this process will be depends in large part on customer education. A lot is required to make choices for all of us so that a competitive market can

develop and we as consumers will believe that adequate, safe, reliable and efficient energy services at fair and reasonable prices will continue as competition evolves. To give you better sources of information on this subject, let me recommend that you contact any one or all of the following organizations:

I would encourage everyone, whether you are a town resident or not, to get as much information as possible so you can make an INFORMED decision about what energy plan will be best for you.

### Voter Registration Deadline Oct. 10

Tuesday, October 10, is the last day to register to vote in next month's general election. Registration applications are available at various locations around the county, including the Town Clerk's Office at Town Hall, and may also be downloaded from the County web site, <a href="https://www.co.fairfax.va.us/eb">www.co.fairfax.va.us/eb</a>. In addition, in-person voter registration will be held at Tysons Corner Center, JCPenney at Fair Oaks Mall, and JCPenney at Springfield Mall on Saturdays and Sundays from noon to 5 p.m. through October 8.

To be eligible to vote, you must be a U.S. citizen, a Virginia resident, and at least 18 years old on or before election day.

If you are already a registered voter, no additional registration is required for this election; however, you should check your voter registration card to be sure it lists your current address and update it if necessary.

On the ballot in the November 7 general election are candidates for President and Vice President, U.S. Senate and House of Representatives, and two proposed amendments to the Constitution of Virginia.

### Political Signs Require a Permit

An article appeared in the September newsletter regarding the time, manner and placement of political signs. Because the election season is now in full swing, it is appropriate to again consider the Town's zoning regulations pertaining to these types of signs.

The Town Code requires all candidates for political office to first obtain a permit to erect signs from the Department of Planning and Zoning. The cost is \$15 for the temporary sign permit and \$25 for a sign bond that is refundable once the election is over and all signs have been removed. The permit entitles the candidate to post not more than five temporary signs not exceeding a total area of 20 square feet. Any such sign must be posted on private property and may be erected in that time period between 30 days prior to election day and five days after the election.

Property owners may erect signs for the candidates of their choice on their own property. Based on a ruling by the Town Attorney, citizens are not subject to the permit or time length requirements in the placement of signs on property that they own.

It is unlawful to place signs on street lights, utility poles, markers or other signs, or to place a sign within ten feet of the curb or edge of pavement.
