MARCH 1995 – The Virginia Department of Transportation will hold an open forum on the Cottage Street reconstruction project on March 27. The project includes the reconstruction of the street at its existing width between Moore Avenue and the rear of the Vienna Shopping Center; replacement of curb, gutter and sidewalk; addition of storm sewers; and replacement of water and sanitary sewer lines.

Business License Deadline March 1

Town businesses are reminded that March 1 is the deadline for payment of the annual business, professional and occupational license (BPOL) tax. All businesses in the Town of Vienna, including home occupations, must renew their business licenses by March 1.

The amount of the tax is based on gross receipts, and the rate varies according to the type of business. The gross receipts threshold is \$50,000, below which the tax does not apply. Those businesses with total annual gross receipts of \$50,000 or less pay only the minimum license fee of \$30 per year.

Vehicle Decals Available March 15

2005 Town of Vienna motor vehicle decals go on sale Tuesday, March 15, and must be displayed by midnight April 15. Decals may be purchased by mail or in person in the Finance Department at Town Hall. (Military personnel must apply in per-

Decals cost \$20 for passenger cars and trucks under 4,000 pounds, \$25 for cars and trucks 4,000 pounds and over, and \$10.50 for motorcycles.

To reduce expenses and speed up the application process, each renewal application will be mailed individually this year rather than manually combining forms for owners of more than one vehicle into a single envelope as has been done in the past.

Information for pre-printed application forms for 2005 decals was taken from 2004 records; therefore, if your vehicle was not registered in Vienna last year, you will not automatically receive an application form in the mail. Call 703-255-6323 or visit the Finance Department to obtain a form, or download it from the Town's Web site, www.ci.vienna.va.us.

Town of Vienna residents do not need to purchase Fairfax County vehicle decals, but they must pay County personal property tax on motor vehicles.

Tax Relief Offered to Senior, **Disabled Low-income Homeowners**

Both the Town of Vienna and Fairfax County offer real estate tax relief for lowincome homeowners who are 65 years old and over, or permanently and totally disabled. To qualify, the following requirements must be met:

- Total household income of \$52,000 or less. This amount excludes \$6,500 of income of relatives, other than the spouse, who reside in the household. Also excluded is \$7,500 of any income received by a disabled homeowner. 100% tax relief is given for total combined income of \$40,000 or less, 50% tax relief between \$40,001 and \$46,000, and 25% tax relief between \$46,001 and \$52,000.
- Total combined assets of no more than \$190,000. This amount excludes the value of the residence, up to one acre of land, and household furnishings.
- Disabled persons applying for the first time must show evidence of disability. In addition to real estate tax relief, Fairfax County provides rental grants and relief from personal property tax for one automobile per household. The Town of Vienna provides all relief recipients one free auto decal.

Applications for 2005 for all programs are due April 1. This date may be extended to December 31 of next year for first-time filers or if hardship conditions exist which, through no fault of the applicant, prohibit applying by April 1.

DECEMBER 20, 2004

- Approved AAC as the vendor to implement a wide area network among Town facilities, funded with cable TV franchise fees, at a cost not to exceed \$202,532.40. (Approved 6-1, Polychrones voting nay.)
- Approved the purchase of personal protective equipment for Town police officers from Global Protection at a cost of \$20,428.51, funding to come from a State Homeland Security Grant.

- Awarded a contract for private landfill usage to Lorton Landfill at a total estimated cost not to exceed \$100,000 for the base year of the contract.
- Accepted an easement to connect water and sewer lines at Ridge Lane in Fairfax County to the Town's water supply.

JANUARY 3, 2005

 Conducted a public hearing on proposed amendments to the zoning code concerning trailers and manufactured homes related to schools, government and public safety uses.

- Approved the final plat for the resubdivision of the property at 612 and 616 Center St., S. (Approved 5-2, Cole and Verinder voting nay.) Waived the installation of curb, gutter and sidewalk, with funds to be placed in escrow for public improvements.

A Lost Purse or Wallet Can Lead to Identity Theft

If you have lost your purse or wallet in the Town of Vienna, the Police Department wishes to assist you in every way possible. Criminal victimization through personal identity theft sometimes begins with a lost or stolen purse or wallet.

Personal identity theft is the unauthorized use of another person's personal identifying information to: obtain credit, goods, services, money or property; or commit a felony or misdemeanor. Personal identifying information means a person's name, address, telephone number, driver's license number, social security number, place of employment, employee identification number, mother's maiden name, demand deposit account number, savings or checking account number or credit card number.

The Vienna Police Department is concerned with ensuring that you take appropriate steps to decrease your chance of becoming a victim of identity theft. We suggest the following if your purse or wallet is lost:

- Purchase a large notebook and begin by making notations about the date, time, location and other important information regarding the loss of your belongings.
- It is likely that you will need to make several telephone calls to protect yourself from becoming a victim of identity theft. For each call, record the date, time, telephone number, person's name, purpose of call, what was accomplished, what follow-up is needed and other relevant notes. Also, write down any questions you asked and the answers received.
- Keep copies of all letters you write and all forms you submit. Mail everything by certified mail. Keep these records in a safe place. Be consistent and methodical and take action immediately!
- Contact the three major credit bureaus: TransUnion, Experian, and Equifax. Request that a fraud alert be place on your file immediately. You will be assigned a reference or confirmation number to use in future communications. Your name and address will be removed from prescreened mailing lists for a length of time specified by each credit bureau. Each credit bureau is different, so follow their instructions explicitly. They may ask you to write a letter and enclose copies of three pieces of identification before they mail your report. Be sure to ask how long the alert will be in effect and how to extend it, if necessary.

Order a copy of your credit report from each of the credit bureaus every three to six months for the first year. After the first year, order copies semi-annually or at least annually. Remember, if whoever stole your identity has not been apprehended and/or your belongings have not been recovered, your identity still remains in their possession and you are subject to future victimization. Or, your imposter may have sold your information to someone else who may attempt to use it at some later date.

- If your ATM or debit card has been lost, report this theft to your bank. Close this account and open a new account number and new password. Do not use your old password. Act quickly to ensure that you are not held liable for any fraudulent funds obtained by your imposter.
- If checks were lost, cancel the accounts immediately. Notify your bank of the number and payee on the last check you wrote. Place "stop payments" on the remaining checks. Ask your bank to notify the check verification company it uses. Here is a list of some of these companies:

It may be necessary that YOU contact the major check verification companies. If so, request each company to notify retailers in their database not to accept the lost checks.

- If your driver's license has been lost, apply for a duplicate at a Department of Motor Vehicles office. Identification documents are required to issue a replacement license, such as a certified birth certificate, etc. Contact DMV for a complete list of acceptable documents and specific requirements. Please be aware that photocopies and facsimiles are not adequate proof. Only original documents will be accepted. When a customer is requesting a replacement driver's license because their license has been stolen, this is indicated on the customer's record as the reason for the replacement. The customer would need to contact law enforcement to report the license as stolen. DMV also has a Web site you can visit for information on protecting your identity: http://www.dmv.state.va.us/webdoc/citizen/drivers/identitytheft.asp.
- Change the locks on your home and car if your keys were lost. Remember, if someone finds your keys in conjunction with your personal information, they have both your address and access to your residence.

Fence Line May Not Equal Lot Line

A 30-year town resident writes from southwest Vienna: "With all of the redevelopment of Vienna going on, it might be a good idea to let current homeowners/residents know that a fence line may not necessarily be their lot line.

"When the lot next door to ours was sold to a developer, the surveyor told us he had found the corner stakes for the lot lines. He did not dig them out nor did he stake the property line. In fact, he told me that the fence line was the property line. This was not the case. While the drawings submitted to the Town were correct, the visual illusion of the fence line as the property line for prospective buyers would not have been correct and could have led to many problems down the road.

"We hired an independent local surveyor at our own expense to come out and survey our property correctly. He staked our lot line and we are thankful we had this done. However, we felt compelled to remove our side fencing, to eliminate the visual illusion, at a time when we had not planned to do so just to protect our property rights and clarify the lines.

"My feeling is that surveyors should always dig down and expose the existing corner stakes and then properly stake the lot line so that homeowners living next door to redeveloping properties don't have to incur that expense to protect their rights and property. While we live in a very affluent town and county, we must always recognize that many people do not have extra resources to incur unneeded expenses. The Town powers that be still need to recognize this and require that a developer's surveyor properly identify the corner stakes and draw the lot line in an obvious manner.

"In addition, existing homeowners need to be informed well in advance of zoning approvals, that they have a right to question what possible changes might be made to land elevations/drainage problems, etc., when a developer comes in. What I have seen in my neighborhood is that the developer has not put up a sign of any kind, so neighboring property owners might not know who is building in their neighborhood and what changes are really forthcoming that might affect their properties.

"I do have to point out the Planning and Zoning Department staff have been a wonderful help to my husband and me. I just think that if we publish more of this information in the newsletter, we can relieve them of some of the frustrating calls they must receive (mine included)."

From the Department of Planning and Zoning: ANY type of permit application requires an accurate property survey in accordance with §18-220 of the Town Code. We also advise prospective buyers, when they ask, to be sure and obtain a copy of their survey as they will pay for it as part of their closing costs.

As to notification procedures, for ALL development applications before the Planning Commission, a letter is sent to all adjoining and abutting property owners one week prior to the meeting advising them of the existence of the application and the place, date and time of its consideration.

In addition, all agendas for the Planning Commission, Board of Zoning Appeals, and Windover Heights Board of Review along with other Town boards and commissions and the Town Council are posted on line at www.ci.vienna.va.us, generally at least one week before the meeting date.

Monday, April 4, is the last day to register to vote in the May 3 Town election. You are eligible to register if you are a Vienna resident, at least 18 years old by election day, and a U.S. citizen.

You may register in person in the Fairfax County General Registrar's Office.

Mail-in application forms are available at Town Hall, all public libraries and other locations around the county, and can also be downloaded from the County Web site, www.fairfaxcounty.gov/goveb/vregis.htm.

If you are already a registered voter, no additional registration is required for the Town election; however, you should check your voter registration card to be sure it lists your current name and address.

This year, Vienna voters will elect three Town Council members for two-year terms beginning July 1.

Water Mains Flushed in Spring

Each spring the Town of Vienna flushes the water mains in its distribution system in order to maintain a high standard of water quality and to ensure proper and efficient operation of the fire hydrants. The preventive maintenance program begins in early April, and flushing usually occurs between 11 p.m. and 5 a.m.

Water mains are flushed by opening the fire hydrants and allowing the water to flow freely for a short period of time. The flushing cleans out sediment that normally accumulates during the summer and winter, and enables the Town to test and perform routine maintenance on the 800+ fire hydrants within its service area.

Flushing may result in some discoloration and the presence of sediment in the water reaching your home or business. These conditions are not harmful and should be of short duration. The Town appreciates your tolerance of this inconvenience. If you need more information, please call the Water and Sewer Customer Service Office at 703-255-6385.

Recycle Motor Oil, Antifreeze, Batteries

The next quarterly recycling day for used motor oil, antifreeze and car batteries is Saturday, March 5, from 8 a.m. to 2 p.m. at Northside Property Yard, 600 Mill St., N.E. This service of the Public Works Department provides citizens a convenient and environmentally responsible way to dispose of vehicle waste products. For more information, call 703-255-6381.

Too often, used oil is improperly poured down storm drains or into sewers. Just one quart of oil can pollute 250,000 gallons of water, releasing toxic metals such as lead, cadmium and arsenic into the environment. Recycled oil is a valuable resource that can be re-manufactured into new fuels.

Antifreeze, like oil, can contaminate water and should never be disposed of in drains or sewers. In addition, antifreeze stored around the house presents a great danger to children and pets; it tastes sweet but is deadly poison.

Improper disposal of automobile batteries is a leading cause of lead contamination in landfills and energy recovery facilities. In Virginia it is illegal to dispose of automobile batteries with refuse.



The Right Way to Mulch

Mulch is good for trees for a variety of reasons: It looks good in the landscape and can help provide unity among different planting beds. It can suppress weed growth. It helps to conserve soil moisture and keep the roots cool in the summer, and it can modify temperature extremes during winter freezes. It can prevent soil erosion around roots on slopes.

But mulch can cause problems if it is applied improperly. The biggest problem is "mulch volcanoes," those mounds of mulch that are two or three feet deep and piled up onto the trunks of trees. If you pile mulch onto the bark, it will be exposed to dark and moisture. As the bark continues to be in the moisture, it will begin to rot. Rotted bark cannot protect the tree from diseases, and in fact, diseases grow better in the dark moisture of the mulch. So now the tree is more likely to get diseases.

Some trees have shallow roots, especially maples. If mulch volcanoes are piled around the trunk, the roots will start to grow into it. These roots tend to stay in the mulch volcano and will then grow around the trunk in the mulch. As the root grows in diameter, it pushes against the trunk, which is also trying to grow bigger. These roots will eventually strangle the trunk. This type of root is called a "girdling root." The trunk will keep growing wider above and below the girdling root, and may actually encase the root.

While the root is constricting the stem growth, the tree will begin to suffer. Young, outer branches will begin to die back. Leaves may appear yellow and become smaller than in previous years because water, nutrients and foods cannot flow through the tree properly. Total growth will slow down. Trees must continue to grow to remain healthy, thus the tree's health will decline further. The tree may eventually become hazardous due to being very top heavy for the size of the trunk at the girdle.

Mulch volcanoes can cause all this damage as the tree is growing larger. Remove the mulch on and around the tree trunk. Keep mulch over the root zone instead. Here is the right way to mulch: Clear all the weeds and grass from the area you intend to cover to prevent them from growing up through the mulch. Cover the cleared area with two to four inches of mulch, away from the trunk or stems of the plant. Make a neat outer edge by leaving a small gap between the mulch and the surrounding lawn.

If you use wood chips, it is recommended that you lightly sprinkle the ground with granular fertilizer to prevent nitrogen deficiency. The bacteria that decay the wood chips need nitrogen. If you don't apply it, the soil reserves to the tree may become low.
